A BILL

To amend title 49, United States Code, to permit the use of State highway standards for airfield pavement construction and improvement under certain circumstances, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Airport Regulatory Re-*
5 *lief Act of 2025”.*

6 **SEC. 2. USE OF STATE HIGHWAY STANDARDS.**

7 *Section 47114(d)(4) of title 49, United States Code,*
8 *is amended to read as follows:*

9 *“(4) USE OF STATE HIGHWAY SPECIFICA-*
10 *TIONS.—*

11 *“(A) IN GENERAL.—The Secretary shall use*
12 *the highway specifications of a State for airfield*
13 *pavement construction and improvement using*
14 *funds made available under this subsection or*
15 *subsection (c)(1)(D) at nonprimary airports*
16 *serving aircraft that do not exceed 60,000 pounds*
17 *gross weight if—*

18 *“(i) such State provides notice to the*
19 *Secretary that nonprimary airports in the*
20 *State intend to use such highway specifica-*
21 *tions; and*

22 *“(ii) the Secretary determines that*
23 *such specifications will not negatively affect*
24 *safety.*

1 “(B) *DEADLINE.*—*The Secretary shall make*
2 *a determination described in subparagraph*
3 *(A)(i) not later than 6 months after a State*
4 *provides notice to the Secretary under subpara-*
5 *graph (A)(i).*

6 “(C) *EXTENSION.*—*If the Secretary deter-*
7 *mines that the time provided under subpara-*
8 *graph (B) is insufficient to make a determina-*
9 *tion, the Secretary may extend the determination*
10 *period by 6 months, so long as the Secretary—*

11 “(i) *notifies the State that provided*
12 *notice pursuant to subparagraph (A)(i) of*
13 *the extension; and*

14 “(ii) *provides justification for the ex-*
15 *tension to such State.*

16 “(D) *ADDITIONAL EXTENSIONS.*—*The Sec-*
17 *retary may authorize additional extensions*
18 *under subparagraph (C).”.*
