## A BILL

To amend the Federal Water Pollution Control Act to provide additional financial assistance to rural, small, and tribal publicly owned treatment works, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Affordable Clean  
5 Water Infrastructure Act”.

1 **SEC. 2. WATER POLLUTION CONTROL REVOLVING LOAN**  
2 **FUNDS.**

3 Section 603(i) of the Federal Water Pollution Control  
4 Act (33 U.S.C. 1383(i)) is amended—

5 (1) in paragraph (1)(A)—

6 (A) in the matter preceding clause (i), by  
7 striking “in assistance”;

8 (B) in clause (i), by inserting “, either as  
9 a whole or within the geographic area served by  
10 the project for which the eligible recipient seeks  
11 additional subsidization” before the semicolon;  
12 and

13 (C) in clause (ii)(III), by striking “to such  
14 ratepayers” and inserting “to help such rate-  
15 payers afford wastewater (including  
16 stormwater) services”; and

17 (2) by striking paragraph (3) and inserting the  
18 following:

19 “(3) SUBSIDIZATION AMOUNTS.—

20 “(A) IN GENERAL.—A State may use for  
21 providing additional subsidization in a fiscal  
22 year under this subsection an amount that does  
23 not exceed the greater of—

24 “(i) 50 percent of the total amount  
25 received by the State in capitalization

1 grants under this title for the fiscal year;  
2 or

3 “(ii) the annual average over the pre-  
4 vious 10 fiscal years of the amounts depos-  
5 ited by the State in the State water pollu-  
6 tion control revolving fund from State  
7 moneys that exceed the amounts required  
8 to be so deposited under section 602(b)(2).

9 “(B) ADDITIONAL COMMUNITY ASSIST-  
10 ANCE.—For each fiscal year, of the amount of  
11 the capitalization grant received by the State  
12 under this title, an additional 10 percent may  
13 be made available by the State to provide addi-  
14 tional subsidization under this subsection to  
15 rural, small, and tribal publicly owned treat-  
16 ment works in the State.

17 “(C) MINIMUM.—To the extent there are  
18 sufficient applications for additional subsidiza-  
19 tion under this subsection that meet the criteria  
20 under paragraph (1)(A), a State shall use for  
21 providing additional subsidization in a fiscal  
22 year under this subsection an amount that is  
23 not less than 20 percent of the total amount re-  
24 ceived by the State in capitalization grants  
25 under this title for the fiscal year.

1           “(4) EXCLUSION.—A loan from the water pollu-  
2           tion control revolving fund of a State with an inter-  
3           est rate equal to or greater than 0 percent shall not  
4           be considered additional subsidization for the pur-  
5           poses of this subsection.”.
