A BILL

To direct the Director of the Congressional Research Service to prepare a report extent of recidivism by individuals pardoned by the President under Presidential Proclamation 10887, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “January 6th Truth
5 and Transparency Act”.

6 **SEC. 2. REPORT ON RECIDIVISM BY 1/6 INSURRECTIONISTS.**

7 (a) REPORT.—Not later than 60 days after the date
8 of enactment of this Act, and every 180 days thereafter,

1 the Director of the Congressional Research Service shall
2 submit to the appropriate congressional committees and
3 make publicly available on the website of the Library of
4 Congress, a report on the extent of recidivism by individ-
5 uals pardoned by the President under Presidential Procla-
6 mation 10887 entitled “Granting Pardons and Commuta-
7 tion of Sentences for Certain Offenses Relating to the
8 Events at or Near the United States Capitol on January
9 6, 2021” (January 20, 2025).

10 (b) CONTENTS.—The report under subsection (a)
11 shall contain—

12 (1) a list of each individual who was pardoned
13 by, had their sentence commuted by, or with respect
14 to whom a pending indictment was dismissed pursu-
15 ant to the Presidential Proclamation referred to in
16 subsection (a);

17 (2) a list of each individual described in para-
18 graph (1) who has been arrested for, charged with,
19 or convicted of a criminal offense under Federal,
20 State, or local law, during the period beginning on
21 January 20, 2025, and ending on the date of the re-
22 port, including a description of each such criminal
23 offense;

24 (3) a list of each individual described in para-
25 graph (1) who has been involved in an encounter

1 with Federal, State, or local law enforcement, that
2 involved the use of force by a law enforcement offi-
3 cer against the individual; and

4 (4) any other information the Director of the
5 Congressional Research Service determines appro-
6 priate.

7 (c) APPROPRIATE CONGRESSIONAL COMMITTEES.—
8 In this section, the term “appropriate congressional com-
9 mittees” means

10 (1) the Committee on House Administration of
11 the House of Representatives;

12 (2) the Committee on Rules and Administration
13 of the Senate; and

14 (3) the Committees on Appropriations of the
15 House of Representatives and of the Senate.
