Mr. CISNEROS (for himself, Mr. BERGMAN, Mr. LIEU, and Mr. GRAVES) introduced the following bill; which was referred to the Committee on Armed Services, and in addition to the Committees on Transportation and Infrastructure, Oversight and Government Reform, Agriculture, Small Business, Financial Services, the Judiciary, Education and Workforce, Veterans' Affairs, Ways and Means, Homeland Security, and House Administration, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To amend laws relating to duty performed by members of the reserve components of the Armed Forces, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Duty Status Reform
5 Act”.

3 **SEC. 3. CONSOLIDATION OF AUTHORITIES TO ORDER RE-**
 4 **SERVE COMPONENT MEMBERS TO PERFORM**
 5 **DUTY.**

6 Chapter 1209 of title 10, United States Code, is
 7 amended to read as follows:

8 **“CHAPTER 1209—RESERVE DUTY AND**
 9 **ASSIGNMENTS**

1 “SUBCHAPTER I—ADMINISTRATION OF
2 RESERVE DUTY

3 **“§ 12311. Authority of President to suspend certain**
4 **laws relating to promotion, retirement,**
5 **and separation**

6 “(a) IN GENERAL.—Notwithstanding any other pro-
7 vision of law, during any period a member of a reserve
8 component is serving on active duty pursuant to section
9 12341 of this title, the President may suspend any provi-
10 sion of law relating to promotion, retirement, or separa-
11 tion applicable to any member of the Armed Forces who
12 the President determines is essential to the national secu-
13 rity of the United States.

14 “(b) TERMINATION OF SUSPENSION.—A suspension
15 made under subsection (a) shall terminate on the earlier
16 of—

17 “(1) the date of the release from active duty of
18 a member of a reserve component ordered to active
19 duty under the authority of section 12341 of this
20 title; or

21 “(2) the date on which the President deter-
22 mines the circumstances that required the action of
23 ordering the member to active duty no longer exist.

24 “(c) 90-DAY EXTENSION OF SEPARATION OR RE-
25 TIREMENT DATE.—Upon the termination of a suspension

1 made under subsection (a) of a provision of law otherwise
2 requiring the separation or retirement of an officer on ac-
3 tive duty because of age, length of service or length of
4 service in grade, or failure of selection for promotion, the
5 Secretary concerned shall extend by up to 90 days the oth-
6 erwise required separation or retirement date of the officer
7 if the separation or retirement date, but for the suspen-
8 sion, would have occurred before the date of the termi-
9 nation of the suspension or within 90 days after the date
10 of such termination.

11 **“§ 12312. Use during expansion of armed forces**

12 “(a) OFFICERS NOT ASSIGNED TO A UNIT.—When
13 an expansion of the active armed forces requires that an
14 officer of a reserve component who is not a member of
15 a unit organized to serve as such be ordered as an indi-
16 vidual to active duty under section 12341 of this title with-
17 out the officer’s consent, the services of qualified and
18 available reserve officers in all grades shall be used, so
19 far as practicable, according to the needs of the branches,
20 grades, or specialties concerned.

21 “(b) STANDBY RESERVE.—(1) A unit or member in
22 the Standby Reserve may be ordered to active duty only
23 as provided in section 12341 of this title, but subject to
24 the limitations in paragraph (2).

1 “(2)(A) In time of war or national emergency de-
2 clared by Congress, or expansion of the force to meet na-
3 tional security requirements as determined by Congress,
4 a unit in the Standby Reserve organized to serve as a unit,
5 and a member of the Standby Reserve who is not assigned
6 to a unit, may be ordered to active duty under section
7 12341 of this title for a purpose described in section
8 12351(a)(1) of this title, subject to the limitations in sub-
9 paragraphs (B) and (C).

10 “(B) A unit in the Standby Reserve organized to
11 serve as a unit, and a member of the Standby Reserve
12 who is a member of such a unit, may be ordered to active
13 duty under section 12341 of this title for a purpose de-
14 scribed in section 12351(a)(1) of this title only if the Sec-
15 retary concerned, with the approval of the Secretary of
16 Defense in the case of a Secretary of a military depart-
17 ment, determines that there are not enough of the re-
18 quired kinds of units in the Ready Reserve that are readily
19 available.

20 “(C) A member in the Standby Reserve who is not
21 assigned to a unit may, without the consent of the mem-
22 ber, be ordered to active duty as an individual under sec-
23 tion 12341 of this title for a purpose described in section
24 12351(a)(1) of this title only if the Secretary concerned,
25 with the approval of the Secretary of Defense in the case

1 of a Secretary of a military department, determines that
2 there are not enough qualified members in the Ready Re-
3 serve in the required category who are readily available.

4 “(c) RETIRED RESERVE.—(1) A member in the Re-
5 tired Reserve, if qualified, may, without the consent of the
6 member, be ordered to active duty under section 12341
7 of this title but only for a purpose described in section
8 12351(a)(1) of this title.

9 “(2) A member of the Retired Reserve (other than
10 a member transferred to the Retired Reserve under section
11 12641(b)(2) of this title) who is ordered to active duty
12 or other appropriate duty in a retired status may be cred-
13 ited under chapter 1223 of this title with service per-
14 formed pursuant to such order.

15 “(3) A member of the Retired Reserve shall not be
16 eligible for promotion (or for consideration for promotion)
17 as a member of a reserve component.

18 **“§ 12313. Release from active duty**

19 “(a) IN GENERAL.—Except as otherwise provided in
20 this title, an authority designated by the Secretary con-
21 cerned may at any time release from active duty a member
22 of a reserve component under the jurisdiction of the Sec-
23 retary concerned.

24 “(b) WAR OR NATIONAL EMERGENCY.—(1) In time
25 of war or of national emergency declared by Congress or

1 the President after January 1, 1953, a member of a re-
2 serve component may be released from active duty (other
3 than for training) only if—

4 “(A) a board of officers, convened at the mem-
5 ber’s request by an authority designated by the Sec-
6 retary concerned, recommends the release and the
7 recommendation is approved;

8 “(B) the member waives the right to request
9 that a board of officers be convened to consider the
10 decision of the Secretary concerned to the release
11 the member from active duty; or

12 “(C) the member’s release is otherwise author-
13 ized by law.

14 “(2) This subsection does not apply to an armed force
15 during a period of demobilization or reduction in strength
16 of that armed force.

17 **“§ 12314. Active duty agreements**

18 “(a) WRITTEN AGREEMENT.—To provide a definite
19 term of active duty (other than for training) under section
20 12342 of this title for a member of a reserve component
21 with the member’s consent, an authority designated by the
22 Secretary concerned may make a standard written agree-
23 ment with the member requiring the member to serve for
24 a period of active duty (other than for training) of not
25 more than 5 years. When such an agreement expires, a

1 new one may be made. This subsection shall not apply in
2 time of war declared by Congress.

3 “(b) MINIMUM TERM.—An agreement shall not be
4 made under subsection (a) unless the specified period of
5 duty is at least 12 months longer than any period of active
6 duty that the member is otherwise required to perform.

7 “(c) UNIFORMITY; STANDARDS AND POLICIES.—
8 Agreements made under subsection (a) shall be uniform,
9 so far as practicable, and are subject to such standards
10 and policies as may be prescribed by the Secretary of De-
11 fense for the Armed Forces under the Secretary of De-
12 fense’s jurisdiction or by the Secretary of Homeland Secu-
13 rity for the Coast Guard when it is not operating as a
14 service in the Navy.

15 “(d) WAR OR NATIONAL EMERGENCY.—If an agree-
16 ment made under subsection (a) expires during a war or
17 during a national emergency declared by Congress or the
18 President after January 1, 1953, the member concerned
19 may, without the consent of the member, be kept on active
20 duty as otherwise prescribed by law.

21 “(e) EARLY RELEASE.—(1) An agreement made
22 under subsection (a) shall provide that the member will
23 not, without the consent of the member, be released from
24 active duty during the period of the agreement—

1 “(A) because of a reduction in the actual per-
2 sonnel strength of the armed force concerned, unless
3 the release is in accordance with the recommenda-
4 tion of a board of officers appointed by an authority
5 designated by the Secretary concerned to determine
6 the members to be released from active duty under
7 regulations prescribed by the Secretary; or

8 “(B) for any other reason, without an oppor-
9 tunity to be heard by a board of officers before the
10 release, unless the member is—

11 “(i) dismissed or discharged under the sen-
12 tence of a court-martial;

13 “(ii) released because of an unexplained
14 absence without leave for at least 3 months;

15 “(iii) released because the member is con-
16 victed and sentenced to confinement in a Fed-
17 eral or State penitentiary or correctional insti-
18 tution and the sentence has become final; or

19 “(iv) released because the member has
20 been considered at least twice and has not been
21 recommended for promotion to the next higher
22 grade or because the member is considered as
23 having failed of selection for promotion to the
24 next higher grade and has not been rec-
25 ommended for promotion to that grade, under

1 conditions that would require the release or sep-
2 aration of a reserve component officer who is
3 not serving under such agreement.

4 “(2) A member who is, without the consent of the
5 member, released from active duty before the end of the
6 member’s agreement made under subsection (a) is entitled
7 to an amount computed by multiplying the number of
8 years and fractions of a year of the member’s unexpired
9 period of service under the agreement by the sum of one
10 month’s basic pay, special pay, and allowances to which
11 the member is entitled on the day of the member’s release.
12 The amount to which a member is entitled under this
13 paragraph is in addition to any pay and allowances to
14 which the member is otherwise entitled. For the purposes
15 of this paragraph, a fraction of a month of 15 days or
16 more is counted as a whole month, and a fraction of a
17 month of less than 15 days is disregarded. This paragraph
18 shall not apply to a member if the member is—

19 “(A) released for a reason described in clauses
20 (i), (ii) or (iii) of paragraph (1)(B);

21 “(B) released because of a physical disability
22 resulting from the member’s intentional misconduct
23 or willful neglect;

24 “(C) eligible for retired pay, separation pay, or
25 severance pay under another provision of law;

1 “(D) placed on a temporary disability retired
2 list; or

3 “(E) released to accept an appointment, or to
4 be enlisted, in a regular component of an armed
5 force.

6 **“§ 12315. Officers: grade in which ordered to active**
7 **duty**

8 “An officer of a reserve component who is ordered
9 to active duty or full-time National Guard duty shall be
10 ordered to active duty or full-time National Guard duty
11 in the officer’s reserve grade, except that such an officer
12 who is credited with service under section 12207 of this
13 title, is ordered to active duty, and placed on the active-
14 duty list, may be ordered to active duty in a reserve grade
15 and with a date of rank and position on the active-duty
16 list determined under regulations prescribed by the Sec-
17 retary of Defense based upon the amount of service cred-
18 ited.

19 **“§ 12316. Kinds of duty**

20 “Notwithstanding any other provision of law, a mem-
21 ber of a reserve component who is on active duty other
22 than for training may, under regulations prescribed by the
23 Secretary concerned, be detailed or assigned to any duty
24 authorized by law for a member of the regular component
25 of the armed force concerned.

1 **“§ 12317. Retention after becoming qualified for re-**
 2 **tired pay**

3 “Any person who has qualified for retired pay under
 4 chapter 1223 of this title may, with the person’s consent
 5 and by order of an authority designated by the Secretary
 6 concerned, be retained on active duty, or in service in a
 7 reserve component other than that listed in section
 8 12732(b) of this title. A member so retained shall be cred-
 9 ited with that duty or service for all purposes.

10 **“§ 12318. Duty with or without pay**

11 “(a) IN GENERAL.—Subject to other provisions of
 12 this title, any member of a reserve component may be or-
 13 dered to active duty or other duty—

14 “(1) with the pay and allowances provided by
 15 law; or

16 “(2) with the member’s consent, without pay.

17 “(b) DUTY WITHOUT PAY.—Duty without pay de-
 18 scribed in subsection (a)(2) shall be considered for all pur-
 19 poses (other than pay) as if the duty without pay were
 20 duty with pay.

21 “(c) PAY AND ALLOWANCES FOR RESERVE COMPO-
 22 NENT MEMBERS RETAINED ON ACTIVE DUTY.—A mem-
 23 ber of a reserve component who is retained on active duty
 24 after the member’s term of service expires is entitled to
 25 pay and allowances while on that duty, except that the
 26 pay and allowances may be forfeited—

1 “(1) under the approved sentence of a court-
2 martial;

3 “(2) by non-judicial punishment by a com-
4 manding officer; or

5 “(3) when the member is otherwise in a non-
6 pay status.

7 **“§ 12319. Payment of certain members while on duty**

8 “(a) IN GENERAL.—Except as provided by subsection
9 (b), a member of a reserve component who because of the
10 member’s earlier military service is entitled to a pension,
11 retired or retainer pay, or disability compensation, and
12 who performs duty for which the member is entitled to
13 compensation, may elect to receive for that duty either—

14 “(1) the payments to which the member is enti-
15 tled because of the member’s earlier military service;
16 or

17 “(2) if the member specifically waives those
18 payments, the pay and allowances authorized by law
19 for the duty that the member is performing.

20 “(b) PAYMENTS.—Unless the payments described in
21 subsection (a)(1) are greater than the compensation de-
22 scribed in subsection (a)(2), a member of a reserve compo-
23 nent who because of the member’s earlier military service
24 is entitled to a pension, retired or retainer pay, or dis-
25 ability compensation, and who upon being ordered to ac-

1 tive duty for a period of more than 30 days in time of
2 war or national emergency is found physically qualified to
3 perform that duty, ceases to be entitled to the payments
4 because of the member's earlier military service until the
5 period of active duty ends. While on that active duty, the
6 member is entitled to the compensation described in sub-
7 section (a)(2). Other rights and benefits of the member
8 or the member's dependents are unaffected by this sub-
9 section.

10 **“§ 12320. Theological students: limitations**

11 “A member of a reserve component shall not be re-
12 quired to serve on active duty, or to participate in reserve
13 component duty, while preparing for the ministry in a rec-
14 ognized theological or divinity school.

15 **“§ 12321. Reserve officer training corps units: limita-**
16 **tion on number of reserve component**
17 **members assigned**

18 “The number of members of the reserve components
19 serving on active duty or full-time National Guard duty
20 for the purpose of organizing, administering, recruiting,
21 instructing, or training the reserve components, who are
22 assigned to duty with a unit of the Reserve Officer Train-
23 ing Corps program, shall not exceed 275.

1 **“§ 12322. Regulations**

2 “(a) IN GENERAL.—The Secretary of Defense, and
3 the Secretary of Homeland Security in the case of the
4 Coast Guard when it is not operating as a service in the
5 Navy, shall prescribe such regulations for the reserve com-
6 ponents of the Armed Forces under their respective juris-
7 dictions as the Secretary of Defense and the Secretary of
8 Homeland Security, respectively, consider necessary to
9 carry out this chapter.

10 “(b) ARMY NATIONAL GUARD AND AIR NATIONAL
11 GUARD.—A member of the Army National Guard of the
12 United States or the Air National Guard of the United
13 States who consents to an order to active duty under sec-
14 tion 12341 or 12342 of this title shall not be ordered to
15 such duty without the consent of the Governor or other
16 appropriate authority of the State concerned. The consent
17 of a Governor or other appropriate authority described in
18 the preceding sentence may not be withheld (in whole or
19 in part) with regard to active duty outside the United
20 States, the Commonwealth of Puerto Rico, the District of
21 Columbia, a territory of the United States, or a possession
22 of the United States because of any objection to the loca-
23 tion, purpose, type, or schedule of such active duty.

24 “(c) CONSIDERATIONS FOR INVOLUNTARY ORDER TO
25 ACTIVE DUTY.—In determining which units or members
26 of the reserve components may, without the consent of the

1 members, be ordered to active duty under section 12341
2 of this title for any purpose described in section 12351
3 of this title, the Secretary of Defense shall prescribe such
4 policies and procedures as the Secretary determines nec-
5 essary to carry out this subsection. Such policies and pro-
6 cedures shall take into consideration—

7 “(1) the length and nature of previous service,
8 to ensure such sharing of exposure to hazards as na-
9 tional security and military requirements will reason-
10 ably allow;

11 “(2) the frequency of assignments during serv-
12 ice career;

13 “(3) family responsibilities; and

14 “(4) employment necessary to maintain the na-
15 tional health, safety, or interest.

16 “(d) CONTINUOUS PERIOD OF DUTY.—(1) When the
17 authority or purpose for a member of a reserve component
18 to serve on active duty or full-time National Guard duty
19 changes with no break in service—

20 “(A) the order to active duty shall be amended
21 to cite the new authority or purpose and the applica-
22 ble funding; and

23 “(B) the member shall remain on the same
24 order to duty.

“(1) each order to active duty described in this chapter shall cite the authority and the purpose of the order to duty, and each amendment to such order shall cite the new authority or purpose of the duty if the authority or purpose changes; and

“12341. Category I: active duty.

“12342. Category II: active duty.

“12344. Category IV: remote assignments.

21 “(a) IN GENERAL.—(1) Under regulations prescribed
22 by the Secretary of Defense, or the Secretary of Homeland
23 Security in the case of the Coast Guard when it is not

1 operating as a service in the Navy, an authority des-
2 ignated by the Secretary concerned may order a member
3 of a reserve component under the jurisdiction of the Sec-
4 retary concerned to active duty, or retain the member on
5 active duty, for a purpose described in section 12351 of
6 this title.

7 “(2) Duty performed pursuant to an order to active
8 duty under this section shall be known as category I active
9 duty.

10 “(3) A member in the Standby Reserve on the inac-
11 tive status list who is ordered to active duty under this
12 section shall be subject to the limitations described in sec-
13 tion 10153 of this title.

14 “(b) MEMBER CONSENT.—(1) A member of a reserve
15 component may, with or without the consent of the mem-
16 ber, be ordered to active duty under this section.

17 “(2) A member of a reserve component who is, with-
18 out the consent of the member, ordered to active duty
19 under this section shall not be retained on active duty be-
20 yond the duration described in section 12351 of this title,
21 if any, for the purpose of that duty.

22 “(3) A member of a reserve component who is, with
23 the consent of the member, ordered to active duty under
24 this section shall not be subject to a duration or strength

1 limitation described in section 12351 of this title, if any,
2 for the purpose of that duty.

3 **“§ 12342. Category II: active duty**

4 “(a) IN GENERAL.—(1) Under regulations prescribed
5 by the Secretary of Defense, or the Secretary of Homeland
6 Security in the case of the Coast Guard when it is not
7 operating as a service in the Navy, an authority des-
8 ignated by the Secretary concerned may order a member
9 of a reserve component under the jurisdiction of the Sec-
10 retary concerned to active duty, or retain the member on
11 active duty, for a purpose described in section 12352 of
12 this title.

13 “(2) Duty performed pursuant to an order to active
14 duty under this section shall be known as category II ac-
15 tive duty.

16 “(3) A member in the Standby Reserve on the inac-
17 tive status list who is ordered to active duty under this
18 section shall be subject to the limitations described in sec-
19 tion 10153 of this title.

20 “(b) MEMBER CONSENT.—The consent of a member
21 of a reserve component shall be required for an order to
22 active duty under this section, except—

23 “(1) when the member is made the subject of
24 proceedings described in section 12352(a) of this
25 title;

1 “(2) when the member is placed in a missing
2 status described in section 12352(b) of this title; or

3 “(3) for required training described in section
4 12352(c) of this title.

5 “(c) CATEGORY I OPERATION OR MISSION EXCLU-
6 SION.—Except as provided in section 12351(e) of this
7 title, a member of a reserve component shall not be or-
8 dered to or retained on active duty under this section if
9 that duty is in support of an operation or mission for
10 which a member of a reserve component is ordered to ac-
11 tive duty under section 12341 of this title for such oper-
12 ation or mission.

13 **“§ 12343. Category III: reserve component duty**

14 “(a) IN GENERAL.—(1) Under regulations prescribed
15 by the Secretary of Defense, or the Secretary of Homeland
16 Security in the case of the Coast Guard when it is not
17 operating as a service in the Navy, an authority des-
18 ignated by the Secretary concerned—

19 “(A) may require or authorize a member of the
20 Army Reserve, Navy Reserve, Marine Corps Reserve,
21 Air Force Reserve, or Coast Guard Reserve, under
22 the jurisdiction of the Secretary concerned, to per-
23 form reserve component duty for a purpose de-
24 scribed in section 12353 of this title; and

1 “(B) may require a member of a reserve compo-
2 nent to perform reserve component duty for the pur-
3 pose described in section 12353(b) of this title.

4 “(2) Duty performed pursuant to a requirement or
5 authorization to perform reserve component duty under
6 this section shall be known as category III reserve compo-
7 nent duty.

8 “(b) MEMBER CONSENT.—(1) A member described
9 in subsection (a) shall, without the consent of the member,
10 be required to perform reserve component duty under this
11 section for—

12 “(A) required training described in section
13 12353(a) of this title; or

14 “(B) muster described in section 12353(b) of
15 this title.

16 “(2) A member described in subsection (a) may, with
17 the consent of the member, be authorized to perform re-
18 serve component duty under this section for—

19 “(A) additional training described in section
20 12353(c) of this title; or

21 “(B) support activities or requirements de-
22 scribed in section 12353(d) of this title.

23 “(c) PERIOD OF SERVICE.—(1) Each period of re-
24 serve component duty performed under this section shall
25 be for a duration of not fewer than 2 hours.

1 “(2) Not more than 2 periods of reserve component
2 duty may be performed under this section in a calendar
3 day.

4 “(d) HOSTILE FIRE OR IMMINENT DANGER
5 AREAS.—A member described in subsection (a) shall not
6 perform reserve component duty under this section if the
7 location of that duty is in a designated hostile fire or an
8 imminent danger area.

9 “(e) CATEGORY I OPERATION OR MISSION EXCLU-
10 SION.—A member described in subsection (a) shall not
11 perform reserve component duty under this section if that
12 duty is in support of an operation or mission for which
13 a member of a reserve component is ordered to active duty
14 under section 12341 of this title for such operation or mis-
15 sion.

16 **“§ 12344. Category IV: remote assignments**

17 “(a) IN GENERAL.—(1) Under regulations prescribed
18 by the Secretary of Defense, or the Secretary of Homeland
19 Security in the case of the Coast Guard when it is not
20 operating as a service in the Navy, an authority des-
21 ignated by the Secretary concerned, at the discretion of
22 that authority, may assign a member of the Ready Reserve
23 or Standby Reserve in an active status—

1 “(A) work described in section 12354(a)(1) of
2 this title that has been pre-approved by the Sec-
3 retary concerned; or

4 “(B) a course of instruction described in section
5 12354(a)(2) of this title that has been pre-approved
6 by the Secretary concerned.

7 “(2) Duty performed pursuant to an assignment
8 under this section shall be known as a category IV remote
9 assignment.

10 “(b) INDIVIDUALLY ASSIGNED.—Work or a course of
11 instruction assigned under this section shall be specifically
12 and individually assigned to a member described in sub-
13 section (a).

14 “(c) DIRECT MILITARY CONTROL NOT REQUIRED.—
15 (1) Work or a course of instruction assigned under this
16 section shall not require direct military control of the
17 member or the presence of a supervisor or instructor.

18 “(2) Work or a course of instruction assigned under
19 this section may be performed at a time and location de-

23 “(d) ELECTRONIC BASED METHODOLOGY.—A course
24 of instruction assigned under subsection (a)(2) may be
25 completed by an electronic-based distributed learning

1 methodology or other means approved by the Secretary
 2 concerned.

3 “SUBCHAPTER III—DUTY AND ASSIGNMENTS:
 4 PURPOSES

“12351. Category I: active duty purposes.

5 **“§ 12351. Category I: active duty purposes**

6 “(a) CONGRESSIONAL DECLARATIONS AND DETER-
 7 MINATIONS.—(1)(A) A unit, or a member not assigned to
 8 a unit organized to serve as a unit, of a reserve component
 9 under the jurisdiction of the Secretary concerned may be
 10 ordered to active duty under section 12341 of this title
 11 for the purpose of—

12 “(i) supporting operations and missions
 13 during a war or national emergency declared by
 14 Congress; or

15 “(ii) meeting national security require-
 16 ments when Congress determines that more
 17 units and organizations are needed for national
 18 security than are in the regular component.

19 “(B)(i) A member who is, without the consent of the
 20 member, ordered to active duty for the purpose described
 21 in paragraph (1)(A)(i) shall not be required to serve for
 22 longer than the duration of the war or national emergency,
 23 as appropriate, and for 6 months thereafter.

1 “(ii) A member who is, without the consent of the
2 member, ordered to active duty for the purpose described
3 in paragraph (1)(A)(ii) may be retained on active duty as
4 long as so needed.

5 “(2) So far as practicable, during any expansion of
6 the active armed forces that requires that a reserve compo-
7 nent unit or member be ordered to active duty for the pur-
8 pose described in paragraph (1)(A)(i), a member of a unit
9 organized and trained to serve as a unit who is, without
10 the consent of the member, ordered to that duty shall be
11 so ordered with the member’s unit. However, a member
12 of that unit may be reassigned after being so ordered to
13 active duty.

14 “(3) A member on an inactive status list or in a re-
15 tired status shall not, without the consent of the member,
16 be ordered to active duty under section 12341 of this title
17 for the purpose described in paragraph (1)(A)(i) unless
18 the Secretary concerned, with the approval of the Sec-
19 retary of Defense in the case of the Secretary of a military
20 department, determines that there are not enough quali-
21 fied members of a reserve component in an active status
22 or in the inactive National Guard in the required category
23 who are readily available.

24 “(b) PRESIDENTIAL CALL-UP.—

1 “(1) INSURRECTION.—(A)(i) The militia of any
2 State (other than the State requesting assistance
3 under subclause (I) of this clause) may be called
4 into Federal service under section 12341 of this title
5 for use with such of the Armed Forces as the Presi-
6 dent determines necessary—

7 “(I) for the purpose of responding,
8 when there is an insurrection in any State
9 against the State’s government, upon the
10 request of the State’s legislature, or of the
11 State’s Governor if the legislature cannot
12 be convened, and in the number requested
13 by that State;

14 “(II) for the purpose of responding,
15 when the President considers that unlawful
16 obstructions, combinations, or assemblages,
17 or rebellion against the authority of the
18 United States make it impracticable to en-
19 force the laws of the United States in any
20 State by the ordinary course of judicial
21 proceedings or to suppress the rebellion; or

22 “(III) for the purpose of responding,
23 when the President determines it is nec-
24 essary to suppress, in a State, any insur-
25 rection, domestic violence, unlawful com-

1 bination, or conspiracy, if the insurrection,
2 domestic violence, unlawful combination, or
3 conspiracy—

4 “(aa) so hinders the execution of
5 the laws of that State, and of the
6 United States within the State, that
7 any part or class of its people is de-
8 prived of a right, privilege, immunity,
9 or protection named in the Constitu-
10 tion and secured by law, and the con-
11 stituted authorities of that State are
12 unable, fail, or refuse to protect that
13 right, privilege, or immunity, or to
14 give that protection; or

15 “(bb) opposes or obstructs the
16 execution of the laws of the United
17 States or impedes the course of justice
18 under those laws.

19 “(ii) In any situation covered by clause
20 (i)(III)(aa), the State shall be considered to have de-
21 nied the equal protection of the laws secured by the
22 Constitution.

23 “(iii) When the President considers it necessary
24 to use the militia or the Armed Forces under this
25 subparagraph, the President shall, by proclamation,

1 immediately order the insurgents to disperse and re-
2 tire peaceably to their abodes within a limited time.

3 “(B)(i) A member or unit of the National
4 Guard of any State, in such numbers as the Presi-
5 dent considers necessary, may be called into Federal
6 service under section 12341 of this title for the pur-
7 pose of supporting missions and operations when—

8 “(I) the United States, the Commonwealth
9 of Puerto Rico, the District of Columbia, a ter-
10 ritory of the United States, or a possession of
11 the United States are invaded or is in danger
12 of invasion by a foreign nation;

13 “(II) there is a rebellion or danger of a re-
14 bellion against the authority of the Government
15 of the United States; or

16 “(III) the President is unable with the reg-
17 ular forces to execute the laws of the United
18 States.

19 “(ii) When the President calls a member or unit
20 of the National Guard of any State into Federal
21 service pursuant to clause (i), orders shall be issued
22 through the Governor of the State, or in the case of
23 the District of Columbia through the commanding
24 general of the National Guard of the District of Co-
25 lumbia.

1 “(C) In this paragraph the term ‘State’ means
2 any State of the United States, the District of Co-
3 lumbia, the Commonwealth of Puerto Rico, the
4 United States Virgin Islands, and Guam.

5 “(D)(i) The repeal of the provisions described
6 in clause (ii) and the replacement of those provisions
7 with this paragraph shall not be construed as an ex-
8 pansion or limitation of the authorities granted
9 under those provisions. The intent of such repeal
10 and replacement is to reorganize the provisions de-
11 scribed in clause (ii) in order to reduce the number
12 of authorities for ordering members of the reserve
13 components and militia to duty and to align those
14 authorities with identified benefits.

15 “(ii) The provisions described in this clause are
16 the following provisions of law as in effect on the
17 day before the effective date of this section:

18 “(I) Chapter 13 of this title (commonly
19 known as the ‘Insurrection Act’).

20 “(II) Section 12406 of this title.

21 “(2) READY RESERVE MOBILIZATION.—(A) A
22 unit, or a member not assigned to a unit organized
23 to serve as a unit, of the Ready Reserve under the
24 jurisdiction of the Secretary concerned may be or-
25 dered to active duty under section 12341 of this title

1 for the purpose of supporting missions and oper-
2 ations in connection with a national emergency de-
3 clared by the President.

4 “(B) A member who is, without the consent of
5 the member, ordered to active duty for the purpose
6 described in subparagraph (A) shall serve for not
7 more than 24 consecutive months.

8 “(C) Not more than 1,000,000 members of the
9 Ready Reserve may, without the consent of the
10 members, be on active duty at any one time for the
11 purpose described in subparagraph (A).

12 “(3) FORCE AUGMENTATION: COVERED EMER-
13 GENCIES; SIGNIFICANT CYBER EVENTS.—(A)(i) A
14 unit, or a member not assigned to a unit organized
15 to serve as a unit, of the Selected Reserve (as de-
16 scribed in section 10143(a) of this title), or a mem-
17 ber in the Individual Ready Reserve mobilization
18 category (as described in section 10144(b) of this
19 title) and designated as essential under regulations
20 prescribed by the Secretary concerned, may be or-
21 dered to active duty under section 12341 of this title
22 when the President determines it is necessary to
23 augment the active force other than in time of war
24 or national emergency for the purpose of providing
25 assistance for a covered emergency.

1 “(ii) In this paragraph, the term ‘covered emer-
2 gency’ means an emergency involving—

3 “(I) a use or threatened use of a weapon
4 of mass destruction (as defined in section 1403
5 of the Defense Against Weapons of Mass De-
6 struction Act of 1996 (50 U.S.C. 2302)); or

7 “(II) a terrorist attack or threatened ter-
8 rorist attack in the United States that results,
9 or could result, in significant loss of life or
10 property.

11 “(B)(i) A unit, or a member not assigned to a
12 unit organized to serve as a unit, of the Selected Re-
13 serve (as described in section 10143(a) of this title),
14 may be ordered to active duty under section 12341
15 of this title when the Secretary of Defense or the
16 Secretary of the department in which the Coast
17 Guard is operating determines that it is necessary to
18 augment the active armed forces for the response of
19 the Department of Defense or other department
20 under which the Coast Guard is operating, respec-
21 tively, to a significant cyber incident.

22 “(ii) In this paragraph, the term ‘significant
23 cyber incident’ means—

24 “(I) a cyber incident involving a Depart-
25 ment of Defense information system, or a

1 breach of a Department of Defense system that
2 involves personally identifiable information, that
3 the Secretary of Defense determines is likely to
4 result in demonstrable harm to the national se-
5 curity interests, foreign relations, or the econ-
6 omy of the United States, or to the public con-
7 fidence, civil liberties, or public health and safe-
8 ty of the people of the United States;

9 “(II) a cyber incident involving a Depart-
10 ment of Homeland Security information system,
11 or a breach of a Department of Homeland Se-
12 curity system that involves personally identifi-
13 able information, that the Secretary of Home-
14 land Security determines is likely to result in
15 demonstrable harm to the national security in-
16 terests, foreign relations, or the economy of the
17 United States, or to the public confidence, civil
18 liberties, or public health and safety of the peo-
19 ple of the United States;

20 “(III) a cyber incident, or collection of re-
21 lated cyber incidents, that the President deter-
22 mines is likely to result in demonstrable harm
23 to the national security interests, foreign rela-
24 tions, or economy of the United States or to the
25 public confidence, civil liberties, or public health

1 and safety of the people of the United States;
2 or

3 “(IV) a significant incident declared pursu-
4 ant to section 2233 of the Homeland Security
5 Act of 2002 (6 U.S.C. 677b).

6 “(C) A unit or member described in this para-
7 graph shall not—

8 “(i) provide assistance under this para-
9 graph for a purpose described in paragraph (1);

10 “(ii) provide assistance under this para-
11 graph to the Federal Government or a State for
12 a serious natural or manmade disaster, acci-
13 dent, or catastrophe (other than a covered
14 emergency or significant cyber incident); or

15 “(iii) provide assistance under this para-
16 graph for a covered emergency unless the Presi-
17 dent determines that the requirements for re-
18 sponding to the covered emergency have exceed-
19 ed, or will exceed, the response capabilities of
20 local, State, and Federal civilian agencies.

21 “(D) Not more than 200,000 members of
22 the Selected Reserve and Individual Ready Re-
23 serve, of whom not more than 30,000 may be
24 members of the Individual Ready Reserve, may,
25 without the consent of the members, be on ac-

1 tive duty for the purpose of this paragraph at
2 any one time.

3 “(E) A member of a reserve component
4 who is, without the consent of the member, or-
5 dered to active duty for the purpose of this
6 paragraph may be required to serve for not
7 more than 365 consecutive days.

8 “(F) Whenever the President authorizes
9 the Secretary of Defense or the Secretary of
10 Homeland Security to order a unit or member
11 of the Selected Reserve or Individual Ready Re-
12 serve to active duty under section 12341 of this
13 title for a purpose described in this paragraph,
14 the President shall, within 24 hours after exer-
15 cising such authority, submit to Congress a re-
16 port, in writing, setting forth the circumstances
17 necessitating the action and describing the an-
18 ticipated use of the units or members.

19 “(G)(i) Whenever a unit of the Selected
20 Reserve or a member of the Selected Reserve
21 not assigned to a unit organized to serve as a
22 unit, or a member of the Individual Ready Re-
23 serve, is ordered to active duty under section
24 12341 of this title for a purpose described in
25 subparagraph (A), the service of all units or

1 members so ordered to active duty may be ter-
2 minated by—

3 “(I) order of the President; or

4 “(II) law.

5 “(ii) Whenever a unit of the Selected Re-
6 serve or a member of the Selected Reserve not
7 assigned to a unit organized to serve as a unit
8 is ordered to active duty under section 12341 of
9 this title for a purpose described in subpara-
10 graph (B), the service of all units or members
11 so ordered to active duty may be terminated
12 by—

13 “(I) order of the Secretary of Defense
14 or, with respect to the Coast Guard, the
15 Secretary of the Department in which the
16 Coast Guard is operating; or

17 “(II) law.

18 “(H) Nothing contained in this paragraph
19 may be construed as amending or limiting the
20 application of the provisions of the War Powers
21 Resolution (50 U.S.C. 1541 et seq.).

22 “(I) In this paragraph, the term ‘State’
23 means a State of the United States, the Dis-
24 trict of Columbia, the Commonwealth of Puerto

1 Rico, the United States Virgin Islands, and
2 Guam.

3 “(c) ACTIVATION FOR A MAJOR DISASTER OR EMER-
4 GENCY.—(1) When a Governor requests Federal assist-
5 ance, a unit, or a member not assigned to a unit organized
6 to serve as a unit, of the Army Reserve, Navy Reserve,
7 Marine Corps Reserve, or Air Force Reserve may be or-
8 dered to active duty under section 12341 of this title when
9 authorized by the Secretary of Defense for the purpose
10 of providing Federal assistance in responding to—

11 “(A) a major disaster or emergency (as those
12 terms are defined in section 102 of the Robert T.
13 Stafford Disaster Relief and Emergency Assistance
14 Act (42 U.S.C. 5122)); or

15 “(B) an emergency involving a manmade dis-
16 aster, a serious natural or manmade accident or ca-
17 tastrophe, or an act of terrorism (as that term is de-
18 fined in section 2(18) of the Homeland Security Act
19 of 2002 (6 U.S.C. 101(18))).

20 “(2) A member described in paragraph (1) who is,
21 without the consent of the member, ordered to active duty
22 for a purpose described in this subsection shall serve on
23 active duty for a continuous period of not more than 120
24 days.

1 “(3) Whenever a unit, or a member not assigned to
2 a unit organized to serve as a unit, is ordered to active
3 duty for a purpose described in this subsection, the service
4 of all units or members so ordered to active duty may be
5 terminated by—

6 “(A) order of the Secretary of Defense; or

7 “(B) law.

8 “(d) SECRETARY CONCERNED DETERMINATION OF
9 OPERATIONAL AND SUPPORT REQUIREMENTS.—

10 “(1) MISSING OR CAPTIVE.—(A)(i) A member
11 of a reserve component may, without the consent of
12 the member, be ordered to or retained on active duty
13 under section 12341 of this title for the purpose of
14 maintaining continuity of military service and pro-
15 viding pay, allowances, and benefits for the member
16 and continuity of benefits for eligible dependents of
17 the member if the Secretary concerned determines
18 that the member is in a missing status that occurs
19 as the result of a hostile action and is related to the
20 member’s military status.

21 “(ii) A member of a reserve component who was
22 in a missing status shall not be retained on active
23 duty for more than 30 days after the member’s
24 missing status is terminated, notwithstanding any

1 previous maximum period of service prescribed for
2 the purpose the member was ordered to active duty.

3 “(B) In this paragraph the term ‘missing sta-
4 tus’ means a status described in section 551(2) of
5 title 37.

6 “(2) PRE-PLANNED MISSION SUPPORT.—(A)(i)
7 A member or unit of the Selected Reserve may be
8 ordered to active duty under section 12341 of this
9 title for the purpose of providing support when the
10 Secretary of a military department determines that
11 it is necessary to augment the active forces for a
12 preplanned mission.

13 “(ii) A member who is, without the consent of
14 the member, ordered to active duty for the purpose
15 described in clause (i) shall serve on active duty for
16 not more than 365 consecutive days.

17 “(B)(i) A member or unit of the Selected Re-
18 serve may, without the consent of the member, be
19 ordered to active duty for the purpose described in
20 subparagraph (A)(i) only if—

21 “(I) the manpower and associated costs of
22 such active duty are specifically included and
23 identified in the defense budget materials (as
24 defined in section 231(f)(2) of this title) for the

1 fiscal year or years in which such units are an-
2 ticipated to be ordered to active duty;

3 “(II) the budget information on such costs
4 includes a description of the mission for which
5 such units are anticipated to be ordered to ac-
6 tive duty and the anticipated length of time of
7 the order of such units to active duty on a vol-
8 untary or an involuntary basis; and

9 “(III) the Secretary of the military depart-
10 ment concerned submits to Congress a report,
11 in writing, setting forth the circumstances ne-
12 cessitating the action taken under section
13 12341 for the purpose described in subpara-
14 graph (A)(i) and describing the anticipated use
15 of such units of the Selected Reserve ordered to
16 active duty.

17 “(ii) In the event the President’s budget is de-
18 livered later than April 1st in the year prior to the
19 year of the mobilization of one or more units under
20 this paragraph, the Secretary concerned may submit
21 to Congress the information required under clause
22 (i) in a separate notice.

23 “(C)(i) Each reserve component shall have not
24 more than 10 percent of its authorized end strength
25 for the Selected Reserve on active duty under this

1 paragraph, without the consent of the members, at
2 any one time.

3 “(ii) Upon determination that such an action is
4 in the national interest—

5 “(I) the Secretary of a military department
6 may increase the maximum strength authorized
7 in clause (i) for a reserve component by a num-
8 ber equal to not more than 2 percent of the au-
9 thorized end strength for the Selected Reserve
10 for that reserve component; and

11 “(II) the Secretary of Defense may in-
12 crease the maximum strength authorized in
13 clause (i) for a reserve component by a number
14 equal to not more than 3 percent of the author-
15 ized end strength for the Selected Reserve of
16 that reserve component.

17 “(iii) Any increase under clause (ii)(I) of the
18 maximum strength for a reserve component for a fis-
19 cal year shall be counted as part of the increase for
20 that reserve component for that fiscal year author-
21 ized under clause (ii)(II).

22 “(D) The service of all members and units
23 of the Selected Reserve ordered to active duty
24 for the purpose of this paragraph may be termi-
25 nated by—

1 “(i) order of the Secretary of the mili-
2 tary department concerned; or

3 “(ii) law.

4 “(E) Nothing contained in this paragraph
5 may be construed as amending or limiting the
6 application of the provisions of the War Powers
7 Resolution (50 U.S.C. 1541 et seq.).

8 “(e) SPECIAL RULE REGARDING CALL-UP RELATED
9 ACTIVITIES.—(1) A member of a reserve component may
10 be ordered to or retained on active duty under section
11 12341 of this title for the purpose of—

12 “(A) completing training that is required to
13 prepare the member for a category I active duty
14 purpose described in this section;

15 “(B) completing activities approved by the Sec-
16 retary concerned that are required to prepare the
17 member for a category I active duty purpose de-
18 scribed in this section;

19 “(C) receiving medical or dental care that is re-
20 quired to meet the deployment readiness standards
21 for a category I active duty purpose described in this
22 section;

23 “(D) undergoing medical evaluation or receiving
24 treatment or rehabilitation for an injury, illness, or
25 disease incurred or aggravated in the line of duty

1 while serving on active duty under section 12341 of
2 this title or full-time National Guard duty under sec-
3 tion 541 of title 32;

4 “(E) undergoing medical evaluation for dis-
5 ability separation or retirement under chapter 61 of
6 this title for an injury, illness, or disease incurred or
7 aggravated in the line of duty while serving on active
8 duty under section 12341 of this title or full-time
9 National Guard duty under section 541 of title 32;
10 or

11 “(F) participating in post-deployment and re-
12 integration activities approved by the Secretary con-
13 cerned following service on active duty under section
14 12341 of this title.

15 “(2)(A) A member of a reserve component on active
16 duty under section 12342 of this title who is performing
17 Active Guard and Reserve functions described in section
18 12352(f)(1) of this title may be ordered to active duty
19 under section 12341 of this title for the purpose of sup-
20 porting an operation or mission described in this section
21 while retaining the member’s status as an Active Guard
22 and Reserve.

23 “(B) During a period that a member described in
24 subparagraph (A) is serving on active duty under section
25 12341, the member may perform duties in connection with

1 any operation or mission for a purpose described in this
2 section, notwithstanding the limitations specified in sec-
3 tion 12352(f) of this title on the duties a member de-
4 scribed in subparagraph (A) is authorized to perform.

5 “(C) Funds available for the pay and allowances of
6 a member described in subparagraph (A) for performing
7 the duties described in section 12352(f)(1) of this title
8 shall be available for the pay and allowances of the mem-
9 ber while performing an operation or mission pursuant to
10 subparagraph (A).

11 **“§ 12352. Category II: active duty purposes**

12 “(a) DISCIPLINARY PROCEEDINGS.—A member of a
13 reserve component may, without the consent of the mem-
14 ber, be ordered to active duty under section 12342 of this
15 title for the purpose of being under the jurisdiction of mili-
16 tary authority when the member is made the subject of
17 proceedings under section 815 (article 15) or section 830
18 (article 30) of this title for an offense that occurred while
19 the member was on reserve component duty or traveling
20 to or from such duty, or during intervals between consecu-
21 tive periods or days of such duty, as provided in subsection
22 (d) of section 802 (article 2) of this title.

23 “(b) MISSING.—(1) A member of a reserve compo-
24 nent may, without the consent of the member, be ordered
25 to or retained on active duty under section 12342 of this

1 title for the purpose of maintaining continuity of military
2 service and providing pay, allowances, and benefits for the
3 member and continuity of benefits for eligible dependents
4 of the member if the Secretary places the member in a
5 missing status.

6 “(2) A member of a reserve component in a missing
7 status shall not be retained on active duty for the purpose
8 described in paragraph (1) for more than 30 days after
9 the member’s missing status is terminated.

10 “(3) In this subsection the term ‘missing status’
11 means a status described in section 551(2)(A) of title 37.

12 “(c) REQUIRED TRAINING.—(1) Except as provided
13 in regulations prescribed by the Secretary of Defense, or
14 the Secretary of Homeland Security in the case of the
15 Coast Guard when it is not operating as a service in the
16 Navy, a member of the Ready Reserve of the Army Re-
17 serve, Navy Reserve, Marine Corps Reserve, Air Force Re-
18 serve, or Coast Guard Reserve (except a person who is
19 enlisted, inducted, or appointed in an armed force under
20 section 513 or 10145(b) of this title) shall be ordered to
21 active duty under section 12342 of this title for the pur-
22 pose of training for not less than 14 days (exclusive of
23 travel time) during each year.

24 “(2) A member described in paragraph (1) who has
25 served on active duty for one year or longer shall not be

1 required to perform a period of active duty for training
2 required under paragraph (1) if the first day of that pe-
3 riod falls during the last 120 days of the member's re-
4 quired membership in the Ready Reserve.

5 “(d) ADDITIONAL TRAINING AND SUPPORT.—At any
6 time, a member of a reserve component may, with the con-
7 sent of the member, be ordered to or retained on active
8 duty under section 12342 of this title for the purpose of—

9 “(1) additional training, as determined by the
10 Secretary concerned; or

11 “(2) providing operational support, other than
12 for missions or operations described in section
13 12351 of this title, as determined by the Secretary
14 concerned.

15 “(e) OTHER ACTIVITIES OR REQUIREMENTS.—At
16 any time, a member of a reserve component may, with the
17 consent of the member, be ordered to or retained on active
18 duty under section 12342 of this title for the purpose of—

19 “(1) preparing for or performing funeral honor
20 functions at the funeral of a veteran, as described in
21 section 1491 of this title;

22 “(2) receiving medical or dental care authorized
23 by the Secretary concerned;

24 “(3) undergoing medical evaluation for dis-
25 ability or other similar purposes;

1 “(4) participating in a Department of Defense
2 health care study, which may include an associated
3 medical evaluation for the member; or

4 “(5) performing an activity or requirement ap-
5 proved by the Secretary concerned.

6 “(f) ACTIVE GUARD AND RESERVE.—(1) A member
7 of a reserve component may, with the consent of the mem-
8 ber, be ordered to active duty under section 12342 of this
9 title for the purpose of performing the Active Guard and
10 Reserve functions of organizing, administering, recruiting,
11 instructing, or training the reserve components.

12 “(2) Subject to regulations prescribed by the Sec-
13 retary concerned, a member performing Active Guard and
14 Reserve functions pursuant to paragraph (1) may perform
15 the following additional activities to the extent that the
16 performance of the additional activities does not interfere
17 with the performance of the member’s primary Active
18 Guard and Reserve functions described in such paragraph:

19 “(A) Supporting operations or missions as-
20 signed in whole or in part to the reserve compo-
21 nents.

22 “(B) Supporting operations or missions per-
23 formed or to be performed by—

1 “(i) a unit composed of elements from
2 more than one component of the same armed
3 force; or

4 “(ii) a joint forces unit that includes—

5 “(I) one or more reserve component
6 units; or

7 “(II) a member of a reserve compo-
8 nent whose reserve component assignment
9 is in a position in an element of the joint
10 forces unit.

11 “(C) Advising the Secretary of Defense, the
12 Secretaries of the military departments, the Joint
13 Chiefs of Staff, or the commanders of the combatant
14 commands regarding reserve component matters.

15 “(D) Instructing or training in the United
16 States, the Commonwealth of Puerto Rico, the Dis-
17 trict of Columbia, a territory of the United States,
18 or a possession of the United States—

19 “(i) members of the Armed Forces on ac-
20 tive duty;

21 “(ii) members of foreign military forces
22 (under the same authorities and restrictions ap-
23 plicable to members of the Armed Forces on ac-
24 tive duty providing such instruction or train-
25 ing);

1 “(iii) Department of Defense contractor
2 personnel; or

3 “(iv) Department of Defense civilian em-
4 ployees.

5 “(3)(A) Notwithstanding paragraph (2) and
6 subject to subparagraph (C), a member performing
7 Active Guard and Reserve functions pursuant to
8 paragraph (1) may perform functions in support of
9 emergency preparedness programs to prepare for, or
10 to respond to, any emergency involving any of the
11 following:

12 “(i) The use or threatened use of a weapon of
13 mass destruction (as defined in section 1403 of the
14 Defense Against Weapons of Mass Destruction Act
15 of 1996 (50 U.S.C. 2302)) in the United States.

16 “(ii) A terrorist attack or threatened terrorist
17 attack in the United States that results, or could re-
18 sult, in catastrophic loss of life or property.

19 “(iii) The intentional or unintentional release of
20 nuclear, biological, or radiological, or toxic or poi-
21 sonous chemical, materials in the United States that
22 results, or could result, in catastrophic loss of life or
23 property.

1 “(iv) A natural or manmade disaster in the
2 United States that results, or could result, in cata-
3 strophic loss of life or property.

4 “(B) The costs of the pay, allowances, clothing,
5 subsistence, gratuities, travel, and related expenses
6 for a member described in paragraph (1) who is per-
7 forming functions described in subparagraph (A)
8 shall be paid from the appropriation that is available
9 to pay such costs for other members of the reserve
10 component of that member who are performing func-
11 tions described in paragraph (1).

12 “(C) A member described in paragraph (1) may
13 perform functions described in subparagraph (A)
14 only while assigned to a reserve component weapons
15 of mass destruction civil support team.

16 “(D) A member described in paragraph (1) who
17 is performing functions described in subparagraph
18 (A) shall be counted against the annual end strength
19 authorizations required by sections 115(a)(1)(B) and
20 115(a)(2) of this title.

21 “(E) The justification material for the defense
22 budget request for a fiscal year shall identify the
23 number and component of the members described in
24 paragraph (1) who are programmed to be per-

1 forming functions described in subparagraph (A)
2 during that fiscal year.

3 “(F) A reserve component weapons of mass de-
4 struction civil support team, and any member de-
5 scribed in paragraph (1) who is assigned to such a
6 team, shall not be used to respond to an emergency
7 described in subparagraph (A) until the Secretary of
8 Defense certifies to the Committee on Armed Serv-
9 ices of the Senate and the Committee on Armed
10 Services of the House of Representatives that the
11 team, or the member, possesses the requisite skills,
12 training, and equipment to be proficient in all mis-
13 sion requirements.

14 “(G) If the Secretary of Defense submits to
15 Congress any request for the enactment of legisla-
16 tion to modify the requirements of subparagraph (A)
17 or (C), the Secretary shall provide with the re-
18 quest—

19 “(i) a justification for each such requested
20 modification; and

21 “(ii) the Secretary’s plan for sustaining the
22 qualifications of the personnel and teams de-
23 scribed in subparagraph (C).

1 “(H) In this subsection, the term ‘United
2 States’ includes the Commonwealth of Puerto Rico,
3 Guam, and the United States Virgin Islands.

4 “(4) A member described in paragraph (1) shall
5 serve in the member’s reserve grade and while so
6 serving continue to be eligible for promotion as a
7 member of a reserve component, if otherwise quali-
8 fied.

9 “(5) A member described in paragraph (1) may
10 be provided training that is consistent with training
11 provided to other members on active duty, as the
12 Secretary concerned determines appropriate.

13 “(g) SEXUAL ASSAULT LINE OF DUTY DETERMINA-
14 TION.—(1) In the case of a reserve component member
15 who is the alleged victim of sexual assault committed while
16 on active duty and who is expected to be released from
17 active duty before the determination is made regarding
18 whether the member was assaulted while in the line of
19 duty (in this section referred to as a ‘line of duty deter-
20 mination’), upon the request of the member, the member
21 may, with the consent of the member, be ordered to or
22 retained on active duty under section 12342 of this title
23 for the purpose of aiding in the line of duty determination
24 until completion of the determination. A member eligible
25 for continuation on active duty under this paragraph shall

1 be informed as soon as practicable after the alleged assault
2 of the option to request continuation on active duty under
3 this paragraph.

4 “(2) In the case of a reserve component member who
5 is not on active duty and who is the alleged victim of a
6 sexual assault that occurred while the member was on ac-
7 tive duty and when the line of duty determination is not
8 completed, upon the request of the member, the member
9 may be ordered to active duty under section 12342 of this
10 title for the purpose of aiding in the line of duty deter-
11 mination until completion of the determination.

12 “(3) The Secretaries of the military departments
13 shall prescribe regulations to carry out this subsection,
14 subject to guidelines prescribed by the Secretary of De-
15 fense. The guidelines of the Secretary of Defense shall
16 provide that—

17 “(A) a request submitted by a member de-
18 scribed in paragraph (1) or (2) to continue on active
19 duty, or to be ordered to active duty, shall be de-
20 cided within 30 days from the date of the request;
21 and

22 “(B) if the request is denied, the member may
23 appeal to the first general officer or flag officer in
24 the chain of command of the member, and in the
25 case of such an appeal, a decision on the appeal

1 shall be made within 15 days from the date of the
2 appeal.

3 **“§ 12353. Category III: reserve component duty pur-**
4 **poses**

5 “(a) REQUIRED TRAINING.—Except as provided in
6 regulations prescribed by the Secretary of Defense, or the
7 Secretary of Homeland Security in the case of the Coast
8 Guard when it is not operating as a service in the Navy,
9 a member of the Ready Reserve of the Army Reserve,
10 Navy Reserve, Marine Corps Reserve, Air Force Reserve,
11 or Coast Guard Reserve (except a person who is enlisted,
12 inducted, or appointed in an armed force under any provi-
13 sion of law other than section 513 or 10145(b) of this
14 title) shall, without the consent of the member, be required
15 during each fiscal year to perform reserve component duty
16 under section 12343 of this title for the purpose of—

17 “(1) participating in at least 48 periods of
18 training; or

19 “(2) performing such other equivalent training
20 as the Secretary concerned may prescribe.

21 “(b) MUSTER.—(1) Subject to the requirements and
22 limitations described in paragraph (2), a member of the
23 Ready Reserve may, without the consent of the member,
24 be required one time each year to perform reserve compo-
25 nent duty under section 12343 of this title for the purpose

1 of updating personnel records and qualifications, docu-
2 menting civilian occupational skills, and assessing the
3 member's physical condition and availability for service.

4 “(2) The requirements and limitations described in
5 paragraph (1) are as follows:

6 “(A) The period that the member may be re-
7 quired to devote to muster under this subsection, in-
8 cluding round-trip travel to and from the location of
9 that muster, shall not total more than one day each
10 calendar year.

11 “(B) Except as provided in subparagraph (D),
12 muster (and travel directly to and from muster)
13 under this subsection shall be treated the same as
14 any other reserve component duty (and travel di-
15 rectly to and from that duty) for the purposes of
16 this title and the provisions of title 37 (other than
17 section 206(a) of title 37), including provisions relat-
18 ing to the determination of eligibility for and the re-
19 ceipt of benefits and entitlements provided under
20 those titles for members performing reserve compo-
21 nent duty and for the dependents and survivors of
22 the members.

23 “(C) In lieu of compensation under section
24 206(a) of title 37, the Secretary concerned shall pay
25 an allowance in accordance with section 433 of title

1 37 to a member of the Ready Reserve who is not a
2 member of the National Guard or the Selected Re-
3 serve.

4 “(D) Muster under this subsection shall not be
5 credited in determining entitlement to, or in com-
6 puting, retired pay under chapter 1223 of this title.

7 “(c) ADDITIONAL TRAINING.—A member of the
8 Army Reserve, Navy Reserve, Marine Corps Reserve, Air
9 Force Reserve, or Coast Guard Reserve may, with the con-
10 sent of the member, participate in additional training peri-
11 ods, including additional flight training periods, under sec-
12 tion 12343 of this title.

13 “(d) SUPPORT ACTIVITIES OR REQUIREMENTS.—(1)
14 A member of the Army Reserve, Navy Reserve, Marine
15 Corps Reserve, Air Force Reserve, or Coast Guard Re-
16 serve may, with the consent of the member, be required
17 to perform reserve component duty under section 12343
18 of this title for the purpose of—

19 “(A) participating in operational support re-
20 quirements except as described in section 12343(e)
21 of this title, including administrative functions to
22 prepare for unit training or funeral honors functions
23 at the funeral of a veteran as described in section
24 1491 of this title; or

1 “(B) carrying out an activity or requirement
2 approved by the Secretary concerned.

3 “(2) A member described in paragraph (1) who is
4 performing funeral honors functions described in para-
5 graph (1)(A)—

6 “(A) may be paid—

7 “(i) an allowance under section 435 of title
8 37; or

9 “(ii) compensation under section 206 of
10 title 37;

11 “(B) shall be reimbursed for travel and trans-
12 portation expenses incurred in conjunction with such
13 duty as authorized under section 435 of title 37 if
14 such duty is performed at a location 50 miles or
15 more from the member’s residence; and

16 “(C) shall receive retirement points under sec-
17 tion 12732(a)(2)(B) of this title.

18 **“§ 12354. Category IV: remote assignment purposes**

19 “(a) WORK OR COURSE OF INSTRUCTION RELATED
20 TO READINESS.—A member of the Ready Reserve or
21 Standby Reserve in an active status may, with the consent
22 of the member, be assigned to perform a remote assign-
23 ment under section 12344 of this title for the purpose of
24 carrying out—

1 “(1) pre-approved work authorized for that
2 member that is directly related to the readiness of
3 the member or the readiness of the member’s unit;
4 or

5 “(2) a pre-approved course of instruction that
6 completes a career advancement requirement or im-
7 proves the military readiness of the member.

8 “(b) COMPENSATION.—(1) At a rate and under terms
9 determined by the Secretary of Defense and only upon
10 successful completion of pre-approved work or a course of
11 instruction described in subsection (a), the Secretary con-
12 cerned may, at the discretion of the Secretary concerned,
13 authorize a member described in subsection (a) to be—

14 “(A) awarded retirement points under section
15 12732(a)(2)(E) of this title; or

16 “(B)(i) paid compensation under section 206 of
17 title 37, at a rate of compensation not to exceed the
18 rate otherwise applicable to the member paid under
19 section 206(a) of title 37; and

20 “(ii) awarded retirement points under section
21 12732(a)(2)(E) of this title.

22 “(2) A member of the Individual Ready Reserve who
23 performs screening conducted through electronic means
24 may be paid a stipend in accordance with section 433a
25 of title 37, in lieu of compensation under paragraph (1).

1 “(c) EXCLUSION FROM CERTAIN BENEFITS AND
 2 PROTECTIONS.—A member described in subsection (a)
 3 who performs pre-approved work or undertakes a pre-ap-
 4 proved course of instruction pursuant to this section shall
 5 not—

6 “(1) be subject to chapter 47 of this title (Uni-
 7 form Code of Military Justice); or

8 “(2) be entitled to any of the pay, benefits,
 9 rights, privileges, or immunities provided a member
 10 on active duty or performing reserve component
 11 duty, except as provided in subsection (b).”.

12 **SEC. 4. DEFINITION OF CONTINGENCY OPERATION.**

13 Paragraph (13) of section 101(a) of title 10, United
 14 States Code, is amended by striking subparagraph (B)
 15 and inserting the following new subparagraphs:

16 “(B)(i) results in a member of a reserve
 17 component being called or ordered to active
 18 duty—

19 “(I) under section 12341 of this title;

20 or

21 “(II) under section 3713 of title 14;

22 or

23 “(ii) results in a member of the Army Na-
 24 tional Guard of the United States or the Air
 25 National Guard of the United States in the

1 member's status as a member of the National
 2 Guard of a State or territory, the Common-
 3 wealth of Puerto Rico, or the District of Colum-
 4 bia being called or ordered to full-time National
 5 Guard duty under section 541 of title 32; or

6 “(C) results in a retired member being or-
 7 dered to active duty under section 688 of this
 8 title for an operation described in subparagraph
 9 (A).”.

10 **SEC. 5. COAST GUARD RESERVE.**

11 Section 3713 of title 14, United States Code, is
 12 amended—

13 (1) in subsection (a), by striking “in any 2-year
 14 period”; and

15 (2) by striking subsection (e).

16 **SEC. 6. NATIONAL GUARD.**

17 Chapter 5 of title 32, United States Code, is amended
 18 to read as follows:

1 **“§ 511. Training generally**

2 “(a) DISCIPLINE OF THE NATIONAL GUARD.—The
3 discipline, including training, of—

4 “(1) the Army National Guard shall conform to
5 that of the Army; and

6 “(2) the Air National Guard shall conform to
7 that of the Air Force.

8 “(b) CONDUCT OF TRAINING.—The training of the
9 National Guard shall be conducted by the several States
10 of the United States, the Commonwealth of Puerto Rico,
11 the District of Columbia, Guam, and the United States
12 Virgin Islands in conformity with this title.

13 **“§ 512. Assignment and detail of members of Regular**
14 **Army or Regular Air Force for instruc-**
15 **tion of National Guard**

16 “(a) IN GENERAL.—(1) The President shall assign
17 for instruction of the National Guard such members of
18 the Regular Army or the Regular Air Force as the Presi-
19 dent considers necessary.

20 “(2) The Secretary of the Army may detail members
21 of the Regular Army to attend training, maneuvers, rifle
22 proficiency, or other exercises for field instruction of the
23 Army National Guard.

1 “(3) The Secretary of the Air Force may detail mem-
2 bers of the Regular Air Force to attend training or exer-
3 cises for field instruction of the Air National Guard.

4 “(b) INSTRUCTION.—Members so detailed shall in-
5 struct the members of the National Guard at the exercise,
6 as directed by the Secretary of the Army or Secretary of
7 the Air Force, or as requested by the Governor or com-
8 manding officer of the National Guard there assembled.

9 **“§ 513. Instruction in firing; supply of ammunition**

10 “Ammunition for instruction in firing and for target
11 practice may be furnished, in such amounts as may be
12 prescribed by the Secretary of the Army or the Secretary
13 of the Air Force, as the case may be, to units of the Na-
14 tional Guard encamped at a post, camp, or air base. The
15 instruction shall be under the direction of a commissioned
16 officer selected for that purpose by the proper military
17 commander.

18 **“§ 514. Assistance for certain youth and charitable or-**
19 **ganizations**

20 “(a) AUTHORITY TO PROVIDE SERVICES.—Members
21 and units of the National Guard may provide the services
22 described in subsection (b) to an eligible organization in
23 conjunction with training required under this chapter in
24 any case in which—

1 “(1) the provision of such services does not ad-
2 versely affect the quality of that training or other-
3 wise interfere with the ability of a member or unit
4 of the National Guard to perform the military func-
5 tions of the member or unit;

6 “(2) the services to be provided are not com-
7 mercially available, or any commercial entity that
8 would otherwise provide such services has approved,
9 in writing, the provision of such services by the Na-
10 tional Guard;

11 “(3) the provision of such services will enhance
12 the military skills of the National Guard personnel
13 providing such services; and

14 “(4) the provision of the services will not result
15 in a significant increase in the cost of the training.

16 “(b) AUTHORIZED SERVICES.—The services author-
17 ized to be provided under subsection (a) are as follows:

18 “(1) Ground transportation.

19 “(2) Air transportation in support of Special
20 Olympics.

21 “(3) Administrative support services.

22 “(4) Technical training services.

23 “(5) Emergency medical assistance and serv-
24 ices.

25 “(6) Communications services.

1 “(c) OTHER AUTHORIZED ASSISTANCE.—Facilities
2 and equipment of the National Guard, including military
3 property of the United States issued to the National
4 Guard and General Services Administration vehicles
5 leased to the National Guard or to the Department of De-
6 fense, may be used in connection with providing services
7 to any eligible organization under this section.

8 “(d) ELIGIBLE ORGANIZATIONS.—The organizations
9 eligible to receive services under this section are as follows:

10 “(1) The Boy Scouts of America.

11 “(2) The Girl Scouts of America.

12 “(3) The Boys Clubs of America.

13 “(4) The Girls Clubs of America.

14 “(5) The Young Men’s Christian Association.

15 “(6) The Young Women’s Christian Associa-
16 tion.

17 “(7) The Civil Air Patrol.

18 “(8) The United States Olympic Committee.

19 “(9) The Special Olympics.

20 “(10) The Campfire Boys.

21 “(11) The Campfire Girls.

22 “(12) The 4–H Club.

23 “(13) The Police Athletic League.

24 “(14) Any other youth or charitable organiza-
25 tion designated by the Secretary of Defense.

1 **“§ 515. National Guard Youth Challenge Program of**
2 **opportunities for civilian youth**

3 “(a) PROGRAM AUTHORITY AND PURPOSE.—The
4 Secretary of Defense may use the National Guard to con-
5 duct a civilian youth opportunities program, to be known
6 as the ‘National Guard Youth Challenge Program’, which
7 shall consist of at least a 22-week residential program and
8 a 12-month post-residential mentoring period. The Pro-
9 gram shall seek to improve life skills and employment po-
10 tential of participants by providing military-based training
11 and supervised work experience, together with the core
12 program components of assisting participants to receive
13 a high school diploma or its equivalent, leadership develop-
14 ment, promoting fellowship and community service, devel-
15 oping life coping skills and job skills, improving physical
16 fitness, and improving health and hygiene.

17 “(b) CONDUCT OF THE PROGRAM.—(1) The Sec-
18 retary of Defense shall provide for the conduct of the Pro-
19 gram in such States as the Secretary considers to be ap-
20 propriate.

21 “(2) The Secretary shall carry out the Program
22 using—

23 “(A) funds appropriated directly to the Sec-
24 retary of Defense for the Program; and

1 “(B) nondefense funds made available or trans-
2 ferred to the Secretary of Defense by other Federal
3 agencies to support the Program.

4 “(3) The Secretary of Defense shall remain the exec-
5 utive agent to carry out the Program regardless of the
6 source of funds for the Program or any transfer of juris-
7 diction over the Program within the executive branch.

8 “(c) PROGRAM AGREEMENTS.—(1) To carry out the
9 Program in a State, the Secretary of Defense shall enter
10 into an agreement with the Governor of the State or, in
11 the case of the District of Columbia, with the commanding
12 general of the District of Columbia National Guard, under
13 which the Governor or the commanding general will estab-
14 lish, organize, and administer the Program in the State.

15 “(2) The agreement may provide for the Secretary
16 to provide funds to the State for civilian personnel costs
17 attributable to the use of civilian employees of the Na-
18 tional Guard in the conduct of the Program.

19 “(d) MATCHING FUNDS REQUIRED.—(1) The
20 amount of assistance provided by the Secretary of Defense
21 to a State program of the Program for a fiscal year under
22 this section shall not exceed 75 percent of the costs of
23 operating the State program during that fiscal year.

24 “(2) The limitation in paragraph (1) shall not be con-
25 strued as a limitation on the amount of assistance that

1 may be provided to a State program of the Program for
2 a fiscal year from sources other than the Department of
3 Defense.

4 “(e) PERSONS ELIGIBLE TO PARTICIPATE IN PRO-
5 GRAM.—A school dropout from secondary school shall be
6 eligible to participate in the Program. The Secretary of
7 Defense shall prescribe the standards and procedures for
8 selecting participants from among school dropouts.

9 “(f) AUTHORIZED BENEFITS FOR PARTICIPANTS.—
10 (1) To the extent provided in an agreement entered into
11 in accordance with subsection (c), and subject to the ap-
12 proval of the Secretary of Defense, a person selected for
13 training in the Program may receive the following benefits
14 in connection with that training:

15 “(A) Allowances for travel expenses, personal
16 expenses, and other expenses.

17 “(B) Quarters.

18 “(C) Subsistence.

19 “(D) Transportation.

20 “(E) Equipment.

21 “(F) Clothing.

22 “(G) Recreational services and supplies.

23 “(H) Other services.

24 “(I) Subject to paragraph (2), a temporary sti-
25 pend upon the successful completion of the training,

1 as characterized in accordance with procedures pro-
2 vided in the agreement.

3 “(2) In the case of a person selected for training in
4 the Program who afterwards becomes a member of the
5 National Civilian Community Corps under subtitle E of
6 title I of the National and Community Service Act of 1990
7 (42 U.S.C. 12611 et seq.), the person shall not receive
8 a temporary stipend under paragraph (1)(I) while the per-
9 son is a member of that Corps. The person may receive
10 the temporary stipend after completing service in that
11 Corps unless the person elects to receive benefits provided
12 under subsection (f) or (g) of section 158 of such Act (42
13 U.S.C. 12618).

14 “(g) PROGRAM PERSONNEL.—(1) Members of the
15 National Guard of a State in which the Program is con-
16 ducted may serve on full-time National Guard duty for
17 the purpose of providing command, administrative, train-
18 ing, or supporting services for the Program. For the per-
19 formance of those services, any such personnel may be or-
20 dered to duty under section 542 of this title for not longer
21 than the period of the Program.

22 “(2) A Governor participating in the Program and
23 the commanding general of the District of Columbia Na-
24 tional Guard (if the District of Columbia National Guard
25 is participating in the Program) may procure by contract

1 the temporary full-time services of such civilian personnel
2 as may be necessary to augment National Guard personnel
3 in carrying out the Program in that State.

4 “(3) Civilian employees of the National Guard per-
5 forming services for the Program and contractor personnel
6 performing such services may be required, when appro-
7 priate to achieve the purposes of the Program, to be mem-
8 bers of the National Guard and to wear the military uni-
9 form.

10 “(h) EQUIPMENT AND FACILITIES.—(1) Equipment
11 and facilities of the National Guard, including military
12 property of the United States issued to the National
13 Guard, may be used in carrying out the Program.

14 “(2) Activities under the Program shall be considered
15 noncombat activities of the National Guard for purposes
16 of section 710 of this title.

17 “(i) STATUS OF PARTICIPANTS.—(1) A person receiv-
18 ing training under the Program shall be considered an em-
19 ployee of the United States for the purposes of the fol-
20 lowing provisions of law:

21 “(A) Subchapter I of chapter 81 of title 5 (re-
22 lating to compensation of Federal employees for
23 work injuries).

24 “(B) Section 1346(b) and chapter 171 of title
25 28 and any other provision of law relating to the li-

1 ability of the United States for tortious conduct of
2 employees of the United States.

3 “(2) In the application of the provisions of law re-
4 ferred to in paragraph (1)(A) to a person referred to in
5 paragraph (1)—

6 “(A) the person shall not be considered to be in
7 the performance of duty while the person is not at
8 the assigned location of training or other activity or
9 duty authorized in accordance with a Program
10 agreement referred to in subsection (c), except when
11 the person is traveling to or from that location or is
12 on pass from that training or other activity or duty;

13 “(B) the person’s monthly rate of pay shall be
14 deemed to be the minimum rate of pay provided for
15 grade GS–2 of the General Schedule under section
16 5332 of title 5; and

17 “(C) the entitlement of a person to receive com-
18 pensation for a disability shall begin on the day fol-
19 lowing the date on which the person’s participation
20 in the Program is terminated.

21 “(3) A person referred to in paragraph (1) shall not
22 be considered an employee of the United States for any
23 purpose other than a purpose set forth in that paragraph.

24 “(j) SUPPLEMENTAL RESOURCES.—To carry out the
25 Program in a State, the Governor of the State or, in the

1 case of the District of Columbia, the commanding general
2 of the District of Columbia National Guard may supple-
3 ment funds made available under the Program out of
4 other resources (including gifts) available to the Governor
5 or the commanding general. The Governor or the com-
6 manding general may accept, use, and dispose of gifts or
7 donations of money, other property, or services for the
8 Program.

9 “(k) REPORT.—Not later than 90 days after the end
10 of each fiscal year, the Secretary of Defense shall submit
11 to Congress a report on the design, conduct, and effective-
12 ness of the Program during the preceding fiscal year. In
13 preparing the report, the Secretary shall coordinate with
14 the Governor of each State in which the Program is car-
15 ried out and, if the Program is carried out in the District
16 of Columbia, with the commanding general of the District
17 of Columbia National Guard.

18 “(l) DEFINITIONS.—In this section:

19 “(1) The term ‘State’ includes the Common-
20 wealth of Puerto Rico, the District of Columbia, a
21 territory of the United States, and a possession of
22 the United States.

23 “(2) The term ‘school dropout’ means an indi-
24 vidual who is no longer attending any school and
25 who has not received a secondary school diploma or

1 a certificate from a program of equivalency for such
2 a diploma.

3 “(3) The term ‘Program’ means the National
4 Guard Youth Challenge Program carried out pursu-
5 ant to this section.

6 “(m) REGULATIONS.—The Secretary of Defense shall
7 prescribe regulations to carry out the Program. The regu-
8 lations shall address at a minimum the following:

9 “(1) The terms to be included in the Program
10 agreements required by subsection (c).

11 “(2) The qualifications for persons to partici-
12 pate in the Program, as required by subsection (e).

13 “(3) The benefits authorized for Program par-
14 ticipants, as required by subsection (f).

15 “(4) The status of National Guard personnel
16 assigned to duty in support of the Program under
17 subsection (g).

18 “(5) The conditions for the use of National
19 Guard equipment and facilities to carry out the Pro-
20 gram, as required by subsection (h).

21 “(6) The status of Program participants, as de-
22 scribed in subsection (i).

23 “(7) The procedures to be used by the Sec-
24 retary when communicating with States about the
25 Program.

1 **“§ 516. Regulations**

2 “(a) IN GENERAL.—The Secretary of Defense shall
3 prescribe such regulations as the Secretary considers nec-
4 essary to carry out this chapter.

5 “(b) BOUNDARY RESTRICTIONS.—(1) Except as pro-
6 vided in paragraph (2) or (3), full-time National Guard
7 duty and reserve component duty described in this chapter
8 shall not be performed—

9 “(A) on land outside the United States, the
10 Commonwealth of Puerto Rico, the District of Co-
11 lumbia, a territory of the United States, or a posses-
12 sion of the United States;

13 “(B) on water outside the territorial sea of the
14 United States, the Commonwealth of Puerto Rico, a
15 territory of the United States, or a possession of the
16 United States; or

17 “(C) in international airspace outside the
18 United States, the Commonwealth of Puerto Rico, a
19 territory of the United States, or a possession of the
20 United States.

21 “(2) While on full-time National Guard duty or per-
22 forming reserve component duty, a member may transit
23 land, water, or airspace described in paragraph (1) in
24 properly sanctioned modes of transportation between or
25 among the United States, the Commonwealth of Puerto

1 Rico, a territory of the United States, or a possession of
2 the United States.

3 “(c) CONTINUOUS PERIOD OF DUTY.—(1) When the
4 authority or purpose for a member to serve on full-time
5 National Guard duty changes with no break in service—

6 “(A) the order to full-time National Guard duty
7 shall be amended to cite the new authority or pur-
8 pose and the applicable funding; and

9 “(B) the member shall remain on the same
10 order to full-time National Guard duty.

11 “(2) If a member is released from full-time National
12 Guard duty and subsequently ordered to active duty or
13 full-time National Guard duty with a break in service of
14 24 hours or fewer, the period of service shall be treated
15 as continuous Federal service for the purposes of pay and
16 benefits, unless otherwise specified in law.

17 “(d) DOCUMENTATION OF MANPOWER AND APPRO-
18 PRIATIONS.—To account for manpower utilization and ex-
19 penditure of appropriations—

20 “(1) each order to full-time National Guard
21 duty described in this chapter shall cite the author-
22 ity and the purpose of the order to duty, and each
23 amendment to such order shall cite the new author-
24 ity or purpose of the duty if the authority or purpose
25 changes; and

1 “(2) the purpose of reserve component duty de-
2 scribed in this chapter and the associated funding
3 shall be documented.

4 “(e) DUTY WITHOUT PAY.—(1) Subject to other pro-
5 visions of this title, any member of the National Guard
6 may be ordered to full-time National Guard duty—

7 “(A) with the pay and allowances provided by
8 law; or

9 “(B) with the member’s consent, without pay.

10 “(2) An order to full-time National Guard duty de-
11 scribed in subchapter II of this title without pay shall be
12 considered for all purposes (other than pay) as if it were
13 an order to full-time National Guard duty with pay.

14 “(3) A member of the National Guard who is retained
15 on full-time National Guard duty after the member’s term
16 of service expires is entitled to pay and allowances while
17 on that duty, except that the pay and allowances may be
18 forfeited—

19 “(A) under the approved sentence of a court-
20 martial;

21 “(B) by non-judicial punishment by a com-
22 manding officer; or

23 “(C) when the member is otherwise in a non-
24 pay status.

1 “(f) FUNDING.—Amounts necessary for the pay, sub-
2 sistence, transportation, and other proper expenses of any
3 part of the National Guard of a State, the Commonwealth
4 of Puerto Rico, the District of Columbia, Guam, or the
5 United States Virgin Islands participating in an exercise
6 under section 552(b)(1) of this title may be set aside from
7 funds allocated to it from appropriations for field instruc-
8 tion.

9 “(g) PAYMENT RULE.—Members of the National
10 Guard participating in an exercise under section 552(b)(1)
11 of this title may, after being mustered, be paid for the
12 period beginning with the date of leaving home and ending
13 with the date of return, as determined in advance. If oth-
14 erwise correct, such a payment passes to the credit of the
15 disbursing officer.

16 “(h) ORDER TO DUTY.—A unit or member of the
17 Army National Guard or Air National Guard may only
18 be ordered to duty under this title by the Governor of a
19 State or territory, the Governor of the Commonwealth of
20 Puerto Rico, or the commanding general of the District
21 of Columbia National Guard, or their designated author-
22 ity, as applicable, for purposes authorized by the Secretary
23 of the Army or the Secretary of the Air Force, as appro-
24 priate.

1 **“§ 517. Definition of reserve component duty**

2 “In this chapter, the term ‘reserve component duty’
3 has the meaning given that term in section 101(d)(7) of
4 title 10.

5 **“SUBCHAPTER II—DUTY AUTHORITIES**

“541. Category I: full-time National Guard duty.

“542. Category II: full-time National Guard duty.

“543. Category III: reserve component duty.

6 **“§ 541. Category I: full-time National Guard duty**

7 “(a) IN GENERAL.—(1) Under regulations prescribed
8 by the Secretary of the Army or Secretary of the Air
9 Force, as the case may be, which shall conform to regula-
10 tions prescribed by the Secretary of Defense, a member
11 of the National Guard may be ordered to or retained on
12 full-time National Guard duty for a purpose described in
13 section 551 of this title.

14 “(2) Duty performed pursuant to an order to full-
15 time National Guard duty under this section shall be
16 known as category I full-time National Guard duty.

17 “(b) MEMBER CONSENT.—(1) A member of the Na-
18 tional Guard may, with or without the consent of the
19 member, be ordered to full-time National Guard duty
20 under this section.

21 “(2) A member of the National Guard who is, without
22 the consent of the member, ordered to full-time National
23 Guard duty under this section shall not be retained on

1 full-time National Guard duty beyond the duration limita-
2 tion described in section 551 of this title, if any, for the
3 purpose of that duty.

4 “(3) A member of the National Guard who is, with
5 the consent of the member, ordered to full-time National
6 Guard duty under this section shall not be subject to a
7 duration limitation described in section 551 of this title,
8 if any, for the purpose of that duty.

9 **“§ 542. Category II: full-time National Guard duty**

10 “(a) IN GENERAL.—(1) Under regulations prescribed
11 by the Secretary of the Army or Secretary of the Air
12 Force, as the case may be, which shall conform to regula-
13 tions prescribed by the Secretary of Defense, a member
14 of the National Guard may be ordered to or retained on
15 full-time National Guard duty for a purpose described in
16 section 552 of this title.

17 “(2) Duty performed pursuant to an order to full-
18 time National Guard duty under this section shall be
19 known as category II full-time National Guard duty.

20 “(b) MEMBER CONSENT.—Member consent is re-
21 quired for an order to full-time National Guard duty
22 under this section, except for required training described
23 in section 552(a) of this title.

24 “(c) CATEGORY I OPERATION OR MISSION EXCLU-
25 SION.—Except as provided in section 551(c) of this title,

1 a member of the National Guard shall not be ordered to
2 or retained on full-time National Guard duty under this
3 section if that duty is in support of an operation or mis-
4 sion for which members have been ordered—

5 “(1) to active duty under section 12341 of title
6 10; or

7 “(2) to full-time National Guard duty under
8 section 541 of this title.

9 **“§ 543. Category III: reserve component duty**

10 “(a) IN GENERAL.—(1) Under regulations prescribed
11 by the Secretary of the Army or the Secretary of the Air
12 Force, as the case may be, which shall conform to regula-
13 tions prescribed by the Secretary of Defense, a member
14 of the National Guard may be required, or otherwise au-
15 thorized, to perform reserve component duty for a purpose
16 described in section 553 of this title.

17 “(2) Duty performed pursuant to an order to reserve
18 component duty under this section shall be known as cat-
19 egory III reserve component duty.

20 “(b) MEMBER CONSENT.—(1) A member of the Na-
21 tional Guard may, without the consent of the member, be
22 required to perform reserve component duty under this
23 section for required training described in section 553(a)
24 of this title.

1 “(2) A member of the National Guard may, with the
2 consent of the member, be authorized to perform reserve
3 component duty under this section for—

4 “(A) additional training described in section
5 553(b) of this title; or

6 “(B) support activities or requirements de-
7 scribed in section 553(c) of this title.

8 “(c) PERIOD OF SERVICE.—(1) Each period of re-
9 serve component duty performed under this section shall
10 be for a duration of not fewer than 2 hours.

11 “(2) Not more than 2 periods of reserve component
12 duty under this section may be performed in a calendar
13 day.

14 “(d) HOSTILE FIRE OR IMMINENT DANGER
15 AREAS.—A member of the National Guard shall not be
16 permitted to perform reserve component duty under this
17 section if the location of such duty is in a designated hos-
18 tile fire or an imminent danger area.

19 “(e) CATEGORY I MISSION EXCLUSION.—A member
20 of the National Guard shall not perform reserve compo-
21 nent duty under this section if that duty is in support of
22 an operation or mission for which members are ordered—

23 “(1) to active duty under section 12341 of title
24 10 for such operation or mission; or

1 “(2) to full-time National Guard duty under
2 section 541 of this title.

3 **“§ 544. Category IV: remote assignments**

4 “(a) IN GENERAL.—(1) Under regulations prescribed
5 by the Secretary of the Army in the case of the Army
6 National Guard and the Secretary of the Air Force in the
7 case of the Air National Guard, which shall conform to
8 regulations prescribed by the Secretary of Defense, an au-
9 thority designated by the Governor, at the discretion of
10 that authority, may assign a member of the Army Na-
11 tional Guard or Air National Guard (other than a member
12 assigned to the inactive Army National Guard or inactive
13 Air National Guard)—

14 “(A) work described in section 554(a)(1) of this
15 title that has been pre-approved by the Secretary of
16 the Army in the case of the Army National Guard
17 and the Secretary of the Air Force in the case of the
18 Air National Guard; or

19 “(B) a course of instruction described in section
20 554(a)(2) of this title that has been pre-approved by
21 the Secretary of the Army in the case of the Army
22 National Guard and the Secretary of the Air Force
23 in the case of the Air National Guard.

1 “(2) Duty performed pursuant to an assignment
 2 under this section shall be known as a category IV remote
 3 assignment.

4 “(b) INDIVIDUALLY ASSIGNED.—Work or a course of
 5 instruction assigned under this section shall be specifically
 6 and individually assigned to a member described in sub-
 7 section (a).

8 “(c) DIRECT MILITARY CONTROL NOT REQUIRED.—
 9 (1) Work or a course of instruction assigned under this
 10 section shall not require direct military control of the
 11 member or the presence of a supervisor or instructor.

12 “(2) Work or a course of instruction assigned under
 13 this section may be performed at a time and location de-
 14 termined by the member, subject to any completion dead-
 15 line or other applicable requirement established by the
 16 Governor.

17 “(d) ELECTRONIC BASED METHODOLOGY.—A course
 18 of instruction assigned under subsection (a)(2) may be
 19 completed by an electronic-based distributed learning
 20 methodology or other means approved by the Governor.

1 **“§ 551. Category I: full-time National Guard duty pur-**
2 **poses**

3 “(a) PRESIDENT OR SECRETARY OF DEFENSE RE-
4 QUEST.—A member of the National Guard may be ordered
5 to full-time National Guard duty under section 541 of this
6 title for the purpose of supporting operations or missions
7 that are undertaken by the member’s unit at the request
8 of the President or Secretary of Defense.

9 “(b) HOMELAND DEFENSE ACTIVITIES.—(1) A
10 member of the National Guard may be ordered to full-
11 time National Guard duty under section 541 of this title
12 for the purpose of performing homeland defense activities,
13 as that term is defined in section 901(1) of this title and
14 described in section 904 of this title.

15 “(2)(A) A member of the National Guard may, with-
16 out the consent of the member, be ordered to or retained
17 on full-time National Guard duty for the purpose de-
18 scribed in paragraph (1) for a period of not more than
19 180 days, except that the Governor of the State may ex-
20 tend, with the concurrence of the Secretary of Defense,
21 the 180-day period one time for an additional 90 days to
22 meet extraordinary circumstances.

23 “(B) In this paragraph the term ‘State’ means each
24 of the several States, the District of Columbia, the Com-
25 monwealth of Puerto Rico, Guam, and the United States
26 Virgin Islands.

1 “(c) SPECIAL RULE REGARDING CALL-UP RELATED
2 ACTIVITIES.—(1) A member of the National Guard may
3 be ordered to or retained on full-time National Guard duty
4 under section 541 of this title for the purpose of—

5 “(A) completing training that is required to
6 prepare the member for a category I active duty
7 purpose described in this section or section 12351 of
8 title 10;

9 “(B) completing activities approved by the Sec-
10 retary concerned that are required to prepare the
11 member for a category I active duty purpose de-
12 scribed in this section or section 12351 of title 10;

13 “(C) receiving medical or dental care required
14 to meet the deployment readiness standards for a
15 category I active duty purpose described in this sec-
16 tion or section 12351 of title 10;

17 “(D) undergoing medical evaluation or receiving
18 treatment or rehabilitation for an injury, illness, or
19 disease incurred or aggravated in the line of duty
20 while serving on full-time National Guard duty
21 under section 541 of this title or active duty under
22 section 12341 of title 10;

23 “(E) undergoing medical evaluation for dis-
24 ability separation or retirement under chapter 61 of
25 this title for an injury, illness, or disease incurred or

1 aggravated in the line of duty while serving on full-
2 time National Guard duty under section 541 of this
3 title or active duty under section 12341 of title 10;

4 “(F) participating in post-deployment and re-
5 integration activities approved by the Secretary of
6 Defense following service on active duty under sec-
7 tion 12341 of title 10.

8 “(2)(A) A member on full-time National Guard duty
9 under section 542 of this title who is performing Active
10 Guard and Reserve functions described in section
11 552(d)(1) of this title may be ordered to full-time National
12 Guard duty under section 541 of this title for the purpose
13 of supporting an operation or mission described in this
14 section while retaining the member’s status as an Active
15 Guard and Reserve.

16 “(B) During a period that a member described in
17 subparagraph (A) is serving on full-time National Guard
18 duty under section 541, the member may perform duties
19 in connection with any operation or mission for a purpose
20 described in subsection (a) or (b), notwithstanding the
21 limitations described in section 552(d) of this title on the
22 duties a member described in subparagraph (A) is author-
23 ized to perform.

24 “(C) Funds available for the pay and allowances of
25 a member described in subparagraph (A) for performing

1 the duties described in section 552(d) of this title shall
2 be available for the pay and allowances of the member
3 while performing an operation or mission pursuant to sub-
4 paragraph (A).

5 **“§ 552. Category II: full-time National Guard duty**
6 **purposes**

7 “(a) REQUIRED TRAINING.—(1) Under regulations
8 to be prescribed by the Secretary of the Army or the Sec-
9 retary of the Air Force, as the case may be, each unit
10 of the National Guard, unless excused by the Secretary
11 concerned, shall assemble for the purpose of training for
12 not less than 15 days each year.

13 “(2) A member of the National Guard who has served
14 on active duty for one year or longer shall not be required
15 to participate in training required under paragraph (1) if
16 the first day of such training falls during the last 120
17 days of the member’s required membership in the National
18 Guard.

19 “(b) ADDITIONAL TRAINING AND TRAINING SUP-
20 PORT.—At any time, a member of the National Guard
21 may, with the consent of the member, be ordered to or
22 retained on full-time National Guard duty under section
23 542 of this title for the purpose of—

24 “(1) additional training, including—

1 “(A) participation in training, maneuvers,
2 rifle proficiency, or any other exercise for field
3 instruction, independently of or in conjunction
4 with the Army or the Air Force;

5 “(B) participation in a joint exercise with
6 the Army or the Air Force for instruction to
7 prepare the National Guard for response to a
8 civil emergency or disaster;

9 “(C) attendance at a school conducted by
10 the Army or the Air Force, as appropriate;

11 “(D) conducting or attending a school con-
12 ducted by the National Guard;

13 “(E) participation in a small arms com-
14 petition;

15 “(F) in the case of the Army National
16 Guard—

17 “(i) attendance at any service school,
18 except the United States Military Acad-
19 emy, to pursue a regular course of study at
20 the school; or

21 “(ii) attaching to an organization of
22 the branch of the Army corresponding to
23 the organization of the Army National
24 Guard to which the member belongs, for
25 routine practical instruction at or near an

1 Army post during training, maneuvers,
2 rifle proficiency, or any other exercise for
3 field instruction; or

4 “(G) in the case of the Air National
5 Guard—

6 “(i) attendance at any service school,
7 except the United States Air Force Acad-
8 emy, to pursue a regular course of study at
9 the school; or

10 “(ii) attaching to an organization of
11 the Air Force corresponding to the organi-
12 zation of the Air National Guard to which
13 the member belongs, for routine practical
14 instruction at an air base during field
15 training or any other outdoor exercise; or

16 “(2) supporting a training operation or training
17 mission assigned in whole or in part to the National
18 Guard by the Secretary of the Army or the Sec-
19 retary of the Air Force, as the case may be, but only
20 to the extent that such training operation or train-
21 ing mission is solely to instruct active duty military,
22 foreign military (under the same authorities and re-
23 strictions applicable to active duty troops), Depart-
24 ment of Defense contractor personnel, or Depart-
25 ment of Defense civilian employees.

1 “(c) OTHER ACTIVITIES OR REQUIREMENTS.—At
2 any time, a member of the National Guard may, with the
3 consent of the member, be ordered to or retained on full-
4 time National Guard duty under section 542 of this title
5 for the purpose of—

6 “(1) carrying out drug interdiction and counter-
7 drug activities, to the extent that those activities are
8 in accordance with the State drug interdiction and
9 counter-drug activities plan referred to in section
10 112(c) of this title;

11 “(2) providing command, administrative, train-
12 ing, or support services for the National Guard
13 Youth Challenge Program as provided in section
14 515(g) of this title;

15 “(3) preparing for or performing funeral honors
16 functions at the funeral of veterans as described in
17 section 1491 of title 10, which shall be treated as a
18 Federal function for which appropriated funds may
19 be used;

20 “(4) providing operational support, other than
21 for missions or operations described in section 551
22 of this title, authorized by the Secretary of Defense;

23 “(5) receiving authorized medical or dental care
24 authorized by the Secretary of the Army or the Sec-
25 retary of the Air Force;

1 “(6) undergoing medical evaluation for dis-
2 ability or for other similar purposes; or

3 “(7) performing an activity or requirement au-
4 thorized by the Secretary of Defense.

5 “(d) ACTIVE GUARD AND RESERVE.—(1) The Gov-
6 ernor of a State, the Commonwealth of Puerto Rico,
7 Guam, or the United States Virgin Islands, or the com-
8 manding general of the District of Columbia National
9 Guard may, with the consent of the member, order a mem-
10 ber of the National Guard to full-time National Guard
11 duty under section 542 of this title for the purpose of per-
12 forming the Active Guard and Reserve functions of orga-
13 nizing, administering, recruiting, instructing, or training
14 the reserve components. Subject to regulations prescribed
15 by the Secretary of Defense, a member performing Active
16 Guard and Reserve functions described in the preceding
17 sentence may support an operation or mission described
18 in subsection (a) or (b) of section 551 of this title.

19 “(2) Subject to regulations prescribed by the Sec-
20 retary of the Army or the Secretary of the Air Force, as
21 the case may be, a member performing Active Guard and
22 Reserve functions pursuant to paragraph (1) may carry
23 out the additional activities described in section 552(b)(2)
24 of this title to the extent that the performance of those
25 activities does not interfere with the performance of the

1 member's primary Active Guard and Reserve functions de-
2 scribed in paragraph (1).

3 “(3) A member performing Active Guard and Reserve
4 functions pursuant to paragraph (1) may perform func-
5 tions in support of emergency preparedness programs de-
6 scribed in paragraph (3) of section 12352(f) of title 10,
7 subject to the requirements, limitations, and restrictions
8 provided in such paragraph (3). A member on full-time
9 National Guard duty who is performing functions in sup-
10 port of emergency preparedness described in the preceding
11 sentence shall be counted against the annual end strength
12 authorizations described in paragraphs (1)(B) and (2) of
13 section 115(a) of title 10.

14 “(4) WAIVER AUTHORITY.—(A) Notwithstanding
15 section 101(c)(8)(A) of title 10 and subsection (b) of this
16 section, the Governor of a State or the Commonwealth of
17 Puerto Rico, Guam, or the Virgin Islands, or the com-
18 manding general of the District of Columbia National
19 Guard, as the case may be, may, at the request of the
20 Secretary concerned, order a member of the National
21 Guard to perform Active Guard and Reserve functions for
22 purposes of performing training of the regular components
23 of the Armed Forces as the primary duty.

1 “(B) Training performed under subparagraph (A)
2 must be performed in the United States or the Common-
3 wealth of Puerto Rico or possessions of the United States.

4 “(C) No more than 100 personnel may be granted
5 a waiver by a Secretary concerned under subparagraph
6 (A) at a time.

7 “(D) The authority under subparagraph (A) shall
8 terminate on October 1, 2024.

9 “(e) SEXUAL ASSAULT LINE OF DUTY DETERMINA-
10 TION.—(1) In the case of a National Guard member who
11 is the alleged victim of sexual assault committed while on
12 full-time National Guard duty and who is expected to be
13 released from full-time National Guard duty before the de-
14 termination is made regarding whether the member was
15 assaulted while in the line of duty (in this section referred
16 to as a ‘line of duty determination’), upon the request of
17 the member, the member may, with the consent of the
18 member, be ordered to or retained on full-time National
19 Guard duty under section 542 of this title for the purpose
20 of aiding in the line of duty determination until completion
21 of the determination. A member eligible for continuation
22 on full-time National Guard duty under this paragraph
23 shall be informed as soon as practicable after the alleged
24 assault of the option to request continuation on full-time
25 National Guard duty under this paragraph.

1 “(2) In the case of a National Guard member who
2 is not on full-time National Guard duty and who is the
3 alleged victim of a sexual assault that occurred while the
4 member was on full-time National Guard duty and when
5 the line of duty determination is not completed, upon the
6 request of the member, the member may be ordered to
7 full-time National Guard duty under section 542 of this
8 title for the purpose of aiding in the line of duty deter-
9 mination until completion of the determination.

10 “(3) The Secretaries of the military departments
11 shall prescribe regulations to carry out this subsection,
12 subject to guidelines prescribed by the Secretary of De-
13 fense. The guidelines of the Secretary of Defense shall
14 provide that—

15 “(A) a request submitted by a member de-
16 scribed in paragraph (1) or (2) to continue on full-
17 time National Guard duty, or to be ordered to full-
18 time National Guard duty, shall be decided within
19 30 days from the date of the request; and

20 “(B) if the request is denied, the member may
21 appeal to the first general officer in the chain of
22 command of the member, and in the case of such an
23 appeal, a decision on the appeal shall be made with-
24 in 15 days from the date of the appeal.

1 **“§ 553. Category III: reserve component duty pur-**
2 **poses**
