## A BILL

To direct the Secretary of Defense to establish a compensation fund for military firefighters exposed to PFAS.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. COMPENSATION FUND FOR MILITARY FIRE-**  
4 **FIGHTERS.**

5 (a) PROGRAM AND FUND ESTABLISHED.—Not later  
6 than two years after the date of enactment of this Act,  
7 the Secretary of Defense shall establish a program and  
8 fund to be known as the “Military Firefighters Compensa-  
9 tion Fund”.

1 (b) PURPOSE OF PROGRAM.—The purpose of the  
2 compensation program is to provide for timely, uniform,  
3 and adequate compensation to current and former military  
4 firefighters and, where applicable, survivors of such em-  
5 ployees, suffering from illnesses incurred by such employ-  
6 ees in the performance of duty for the Department of De-  
7 fense and certain of its contractors and subcontractors due  
8 to exposure to per- and polyfluoroalkyl substances, or  
9 PFAS.

10 (c) PFAS EXPOSURE.—Current and former military  
11 firefighters shall, in the absence of substantial evidence  
12 to the contrary, be determined to have been exposed to  
13 PFAS in the performance of duty for the purposes of the  
14 compensation program if such firefighter was employed at  
15 a military installation, facility of the National Guard, of  
16 formerly used defense site during a period when PFAS  
17 would have been present at such facility.

18 (d) COMPENSATION PROVIDED.—A current or former  
19 military firefighter, or the survivor of such firefighter if  
20 the firefighter is deceased, shall receive compensation for  
21 the disability or death of that employee from that employ-  
22 ee’s occupational illness.

23 (e) PAYMENTS IN THE CASE OF DECEASED PER-  
24 SONS.—

1           (1) CLAIM FILED.—In the case of a military  
2 firefighter who is deceased at the time of payment  
3 of compensation under this section, whether or not  
4 the death is the result of the firefighter’s occupa-  
5 tional illness, such payment may be made only as  
6 follows:

7           (A) If the military firefighter is survived  
8 by a spouse who is living at the time of pay-  
9 ment, such payment shall be made to such sur-  
10 viving spouse.

11           (B) If there is no surviving spouse de-  
12 scribed in subparagraph (A), such payment  
13 shall be made in equal shares to all children of  
14 the military firefighter who are living at the  
15 time of payment.

16           (C) If there is no surviving spouse de-  
17 scribed in subparagraph (A) and if there are no  
18 children described in subparagraph (B), such  
19 payment shall be made in equal shares to the  
20 parents of the military firefighter who are living  
21 at the time of payment.

22           (D) If there is no surviving spouse de-  
23 scribed in subparagraph (A), and if there are  
24 no children described in subparagraph (B) or  
25 parents described in subparagraph (C), such

1 payment shall be made in equal shares to all  
2 grandchildren of the military firefighter who are  
3 living at the time of payment.

4 (E) If there is no surviving spouse de-  
5 scribed in subparagraph (A), and if there are  
6 no children described in subparagraph (B), par-  
7 ents described in subparagraph (C), or grand-  
8 children described in subparagraph (D), then  
9 such payment shall be made in equal shares to  
10 the grandparents of the military firefighter who  
11 are living at the time of payment.

12 (F) Notwithstanding the other provisions  
13 of this paragraph, if there is—

14 (i) a surviving spouse described in  
15 subparagraph (A); and

16 (ii) at least one child of the military  
17 firefighter who is living and a minor at the  
18 time of payment and who is not a recog-  
19 nized natural child or adopted child of  
20 such surviving spouse, then half of such  
21 payment shall be made to such surviving  
22 spouse, and the other half of such payment  
23 shall be made in equal shares to each child  
24 of the military firefighter who is living and  
25 a minor at the time of payment.

1           (2) BEFORE FILING OF CLAIM.—If a current or  
2 former military firefighter eligible for payment dies  
3 before filing a claim under this section, a survivor of  
4 that firefighter who may receive payment under  
5 paragraph (1) may file a claim for such payment.

6           (3) DEFINITIONS.—In this subsection:

7           (A) The term “child” includes a recognized  
8 natural child, a stepchild who lived with an in-  
9 dividual in a regular parent-child relationship,  
10 or an adopted child.

11           (B) The term “grandchild” means the  
12 child of a child of an individual.

13           (C) The term “grandparent” means the  
14 parent of a parent of an individual.

15           (D) The term “parent” includes fathers  
16 and mothers through adoption.

17           (E) The term “spouse” means the wife or  
18 husband of a deceased individual who was mar-  
19 ried to such individual for at least one year im-  
20 mediately before such death.

21           (f) MEDICAL BENEFITS PROVIDED.—The Secretary  
22 shall furnish, to an individual receiving medical benefits  
23 under this section for an illness, the services, appliances,  
24 and supplies prescribed or recommended by a qualified  
25 physician for that illness.

1 (g) TRANSPORTATION AND EXPENSES.—The indi-  
2 vidual may be furnished necessary and reasonable trans-  
3 portation and expenses incident to the securing of such  
4 services, appliances, and supplies.

5 (h) COMMENCEMENT OF BENEFITS.—An individual  
6 receiving benefits under this section shall be furnished  
7 those benefits as of the date on which that individual sub-  
8 mitted the claim for those benefits in accordance with this  
9 section.

10 (i) DEFINITIONS.—In this section:

11 (1) The term “military firefighter” means a  
12 member of the Armed Forces or a civilian employee  
13 of the Department of Defense whose military occu-  
14 pational specialty or primary duties are fire suppres-  
15 sion and prevention.

16 (2) The term “military installation” has the  
17 meaning given such term in section 2801(c)(4) of  
18 title 10, United States Code.

19 (3) The term “PFAS” means perfluoroalkyl  
20 and polyfluoroalkyl substances.

21 (4) The term “perfluoroalkyl substance” means  
22 a man-made chemical of which all the carbon atoms  
23 are fully fluorinated carbon atoms.

24 (5) The term “polyfluoroalkyl substance”  
25 means a man-made chemical with at least one fully

1 fluorinated carbon atom and at least one  
2 nonfluorinated carbon atom.

3 (j) AUTHORIZATION FOR COMPENSATION FUND.—

4 There is hereby authorized such sums as may be necessary  
5 to carry out this section.
