## A BILL

To require the Congressional Budget Office to make publicly available the fiscal and mathematical models, data, and other details of computations used in cost analysis and scoring.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “CBO Show Your Work  
3 Act”.

4 **SEC. 2. PUBLICATION OF CONGRESSIONAL BUDGET OFFICE**  
5 **MODELS.**

6 (a) IN GENERAL.—Section 402 of the Congressional  
7 Budget Act of 1974 (2 U.S.C. 653) is amended—

8 (1) by striking “The Director” and inserting  
9 the following:

10 “(a) IN GENERAL.—The Director”; and

11 (2) by adding at the end the following:

12 “(b) PUBLICATION OF MODELS AND DATA.—The Di-  
13 rector of the Congressional Budget Office shall make  
14 available to Members of Congress and make publicly avail-  
15 able on the website of the Congressional Budget Office—

16 “(1) each fiscal model, policy model, and data  
17 preparation routine used by the Congressional Budg-  
18 et Office in estimating the costs and other fiscal, so-  
19 cial, or economic effects of legislation, including esti-  
20 mates prepared under subsection (a);

21 “(2) any update of a model or routine described  
22 in paragraph (1);

23 “(3) subject to paragraph (4), for each estimate  
24 of the costs and other fiscal effects of legislation, in-  
25 cluding estimates prepared under subsection (a), the  
26 data, programs, models, assumptions, and other de-

1 tails of the computations used by the Congressional  
2 Budget Office in preparing the estimate, in a man-  
3 ner sufficient to permit replication by individuals not  
4 employed by the Congressional Budget Office; and

5 “(4) for any data that is required not to be dis-  
6 closed by the Congressional Budget Office—

7 “(A) a complete list of all data variables  
8 for such data;

9 “(B) descriptive statistics for all data vari-  
10 ables for such data (including averages, stand-  
11 ard deviations, number of observations, and cor-  
12 relations to other variables), to the extent that  
13 the descriptive statistics do not violate the rule  
14 against disclosure;

15 “(C) a reference to the statute requiring  
16 that the data not be disclosed; and

17 “(D) information regarding how to contact  
18 the individual or entity who has unrestricted ac-  
19 cess to the data.”.

20 (b) EFFECTIVE DATE.—The amendments made by  
21 subsection (a) shall apply on and after the date that is  
22 6 months after the date of enactment of this Act.
