A BILL

To amend the Department of Energy Organization Act with respect to functions assigned to Assistant Secretaries, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Energy Emergency
5 Leadership Act”.

6 **SEC. 2. FUNCTIONS ASSIGNED TO ASSISTANT SECRE-**
7 **TARIES.**

8 (a) IN GENERAL.—Subsection (a) of section 203 of
9 the Department of Energy Organization Act (42 U.S.C.
10 7133(a)) is amended by adding at the end the following
11 new paragraph:

12 “(12) Energy emergency and energy security
13 functions, including—

14 “(A) responsibilities with respect to energy
15 infrastructure, security and resilience, emerging
16 threats, cybersecurity, supply, and emergency
17 planning and preparedness, coordination, re-
18 sponse, and restoration, as appropriate; and

19 “(B) upon request of a State, local, or
20 Tribal government or energy sector entity, and
21 in coordination with other Federal agencies as
22 appropriate, provision of technical assistance
23 and support to protect against, detect, and re-
24 spond to energy security threats, risks, and in-
25 cidents.”.

1 (b) COORDINATION.—The Secretary of Energy shall
2 ensure that the functions of the Secretary described in sec-
3 tion 203(a)(12) of the Department of Energy Organiza-
4 tion Act (as added by this Act) are performed in coordina-
5 tion with relevant Federal agencies.
