AN ACT

To amend the Public Works and Economic Development Act of 1965 to provide for certain grant eligibility relating to projects that facilitate the relocation, to the United States, of a source of employment located outside the United States, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Made in America Jobs
3 Act of 2026”.

4 **SEC. 2. GRANTS FOR PUBLIC WORKS AND ECONOMIC DE-**
5 **VELOPMENT.**

6 (a) GRANTS FOR PUBLIC WORKS AND ECONOMIC
7 DEVELOPMENT.—Section 201(c) of the Public Works and
8 Economic Development Act of 1965 (42 U.S.C. 3141(c))
9 is amended—

10 (1) in paragraph (7) by striking “or” at the
11 end;

12 (2) in paragraph (8) by striking the period at
13 the end and inserting a semicolon; and

14 (3) by adding at the end the following:

15 “(9) facilitate the relocation, to the United
16 States, of a source of employment located outside
17 the United States; and

18 “(10) facilitate the growth of the manufac-
19 turing sector.”.

20 (b) GRANTS FOR PLANNING AND GRANTS FOR AD-
21 MINISTRATIVE EXPENSES.—Section 203(a) of the Public
22 Works and Economic Development Act of 1965 (42
23 U.S.C. 3143(a)) is amended by inserting “, including
24 planning with respect to projects to facilitate the reloca-
25 tion, to the United States, of a source of employment lo-
26 cated outside the United States or to facilitate the growth

1 of the manufacturing sector,” after “economic develop-
2 ment planning”.

3 (c) GRANTS FOR TRAINING, RESEARCH, AND TECH-
4 NICAL ASSISTANCE.—Section 207(a)(2) of the Public
5 Works and Economic Development Act of 1965 (42
6 U.S.C. 3147(a)(2)) is amended—

7 (1) in subparagraph (H) by striking “and” at
8 the end;

9 (2) by redesignating subparagraph (I) as sub-
10 paragraph (K); and

11 (3) by inserting after subparagraph (H) the fol-
12 lowing:

13 “(I) activities to facilitate the relocation, to
14 the United States, of a source of employment
15 located outside the United States;

16 “(J) activities to facilitate the growth of
17 the manufacturing sector; and”.

18 (d) GRANTS FOR ECONOMIC ADJUSTMENT.—Section
19 209(a) of the Public Works and Economic Development
20 Act of 1965 (42 U.S.C. 3149(a)) is amended by inserting
21 “projects to facilitate the relocation, to the United States,
22 of a source of employment located outside the United

- 1 States, projects to facilitate the growth of the manufac-
- 2 turing sector,” after “loan fund),”.
