To amend the Help America Vote Act of 2002 to prohibit the use of Federal funds for election administration in States that permit ballot harvesting.

Mr. EDWARDS (for himself, Mr. ONDER, Mr. McDOWELL, Ms. TENNEY, Mr. HARRIGAN, Mr. GILL of Texas, Mr. CLINE, Mr. BENTZ, and Mr. STEUBE) introduced the following bill; which was referred to the Committee on House Administration

A BILL

To amend the Help America Vote Act of 2002 to prohibit the use of Federal funds for election administration in States that permit ballot harvesting.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; FINDINGS.**

4 (a) SHORT TITLE.—This section may be cited as the
5 “No Federal Funds for Ballot Harvesting Act”.

6 (b) FINDINGS.—Congress finds that—

7 (1) the right to vote is a fundamental right of
8 citizens of the United States, as described by the
9 Constitution of the United States;

1 (2) the Committee on House Administration of
2 the House of Representatives, which is charged with
3 investigating election irregularities, received reports
4 through its official Election Observer Program for
5 the 2018 general election and the 2020 general elec-
6 tion, as well as from other stakeholders, that individ-
7 uals other than voters themselves were depositing
8 large amounts of absentee ballots at polling places
9 throughout California and other States, a practice
10 colloquially known as “ballot harvesting”;

11 (3) the practice of ballot harvesting creates sig-
12 nificant vulnerabilities in the chain of custody of bal-
13 lots because individuals collecting ballots are not re-
14 quired to be registered voters and are not required
15 to identify themselves at a voter’s home, and the
16 State does not track how many ballots are harvested
17 in an election;

18 (4) ballot harvesting invites electioneering activ-
19 ity at home and weakens States’ long-standing voter
20 protection procedures which remain in place at poll-
21 ing locations, creating the possibility of undue influ-
22 ence over voters by bad actors; and

23 (5) the Supreme Court of the United States has
24 affirmed State authority to restrict ballot harvesting

1 (Brnovich v. Democratic National Committee, 594
2 U.S. 647 (2021)).

3 **SEC. 2. PROHIBITION ON USE OF FEDERAL FUNDS FOR**
4 **ELECTION ADMINISTRATION IN STATES THAT**
5 **PERMIT BALLOT HARVESTING.**

6 (a) IN GENERAL.—The Help America Vote Act of
7 2002 (52 U.S.C. 20901 et seq.) is amended by adding at
8 the end the following new section:

9 **“SEC. 907. PROHIBITION ON FEDERAL FUNDS FOR ELEC-**
10 **TION ADMINISTRATION FOR STATES ALLOW-**
11 **ING COLLECTION AND TRANSMISSION OF**
12 **BALLOTS BY CERTAIN THIRD PARTIES.**

13 “(a) IN GENERAL.—Notwithstanding any other pro-
14 vision of law, no Federal funds may be used to administer
15 any election for Federal office in a State unless the State
16 has in effect a law that prohibits an individual from the
17 knowing collection and transmission of a ballot in an elec-
18 tion for Federal office that was mailed to another person,
19 other than the following individuals:

20 “(1) An election official while engaged in offi-
21 cial duties as authorized by law.

22 “(2) An employee of the United States Postal
23 Service or other commercial common carrier engaged
24 in similar activities while engaged in duties author-
25 ized by law.

1 “(3) Any other individual who is allowed by law
2 to collect and transmit United States mail, while en-
3 gaged in official duties as authorized by law.

4 “(4) A family member, household member, or
5 caregiver of the person to whom the ballot was
6 mailed.

7 “(b) DEFINITIONS.—For purposes of this section,
8 with respect to a person to whom the ballot was mailed:

9 “(1) The term ‘caregiver’ means an individual
10 who provides medical or health care assistance to
11 such person in a residence, nursing care institution,
12 hospice facility, assisted living center, assisted living
13 facility, assisted living home, residential care institu-
14 tion, adult day health care facility, or adult foster
15 care home.

16 “(2) The term ‘family member’ means an indi-
17 vidual who is related to such person by blood, mar-
18 riage, adoption, or legal guardianship.

19 “(3) The term ‘household member’ means an
20 individual who resides at the same residence as such
21 person.”.

22 (b) CLERICAL AMENDMENT.—The table of contents
23 of such Act is amended by adding at the end the following
24 new item:

“Sec. 908. Prohibition on Federal funds for election administration for States allowing collection and transmission of ballots by certain third parties.”.
