# **A BILL**

To amend title 54, United States Code, to modify certain cost-sharing requirements for grant programs under the American Battlefield Protection Program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “American Battlefield*  
 5 *Protection Program Amendments Act of 2026”.*

6 **SEC. 2. AMERICAN BATTLEFIELD PROTECTION PROGRAM**  
 7 **GRANT PROGRAMS.**

8 *(a) REAUTHORIZATION OF BATTLEFIELD ACQUISITION*  
 9 *GRANT PROGRAM.—Section 308103(f) of title 54, United*  
 10 *States Code, is amended by striking “2028” and inserting*  
 11 *“2036”.*

12 *(b) BATTLEFIELD INTERPRETATION MODERNIZATION*  
 13 *GRANT PROGRAM.—Section 308104 of title 54, United*  
 14 *States Code, is amended by striking subsection (d).*

15 *(c) BATTLEFIELD RESTORATION GRANT PROGRAM.—*  
 16 *Section 308105 of title 54, United States Code, is amended*  
 17 *by striking subsection (e) and inserting the following:*

18 *“(e) AUTHORIZATION OF APPROPRIATIONS.—There is*  
 19 *authorized to be appropriated to the Secretary to provide*  
 20 *grants under section 308104 and this section \$2,000,000 for*  
 21 *each fiscal year through fiscal year 2036.”.*

22 **SEC. 3. FRENCH AND INDIAN WAR AND MEXICAN-AMERICAN**  
 23 **WAR SITES STUDIES.**

24 *(a) IN GENERAL.—Subject to the availability of appro-*  
 25 *priations made in advance for such purpose, the Secretary*

1 *of the Interior (acting through the Director of the National*  
 2 *Park Service) (referred to in this section as the “Sec-*  
 3 *retary”), shall prepare or certify, pursuant to subsection*  
 4 *(b), studies of sites and structures located in the United*  
 5 *States that are thematically tied with nationally significant*  
 6 *events that occurred during—*

7 *(1) the French and Indian War from 1754–1763;*

8 *and*

9 *(2) the Mexican-American War from 1846–1848.*

10 *(b) PREPARATION.—*

11 *(1) IN GENERAL.—The studies under subsection*

12 *(a) may be carried out—*

13 *(A) by the Secretary, in consultation with*  
 14 *affected States, Indian Tribes, local governments,*  
 15 *the American Battlefield Trust, historic preserva-*  
 16 *tion organizations, and any other interested in-*  
 17 *dividuals or entities, as determined by the Sec-*  
 18 *retary; or*

19 *(B) by interested individuals or entities, if*  
 20 *the Secretary certifies that the completed study*  
 21 *meets the requirements of subsection (c).*

22 *(2) CERTIFICATION.—Not later than 1 year after*  
 23 *receiving a study carried out by interested individ-*  
 24 *uals or entities under subsection (b)(1)(B), the Sec-*

1        *retary shall review and certify whether the study*  
2        *meets the requirements of subsection (c).*

3        *(c) CONTENTS.—The studies prepared under sub-*  
4        *section (a) shall—*

5                *(1) identify French and Indian War and Mexi-*  
6        *can-American War sites, respectively, located within*  
7        *the United States;*

8                *(2) determine the relative significance of the*  
9        *identified sites;*

10               *(3) assess short- and long-term threats to the in-*  
11        *tegrity of the identified sites; and*

12               *(4) provide alternatives for the preservation and*  
13        *interpretation of the identified sites by the Federal*  
14        *Government, State, local, and Tribal governments, or*  
15        *other public or private entities, including potential*  
16        *designation of the identified sites as units of the Na-*  
17        *tional Park System, as appropriate.*

18        *(d) CONSIDERATION OF PREVIOUS STUDIES AND RE-*  
19        *PORTS.—In preparing the studies under subsection (b)(1),*  
20        *the Secretary shall consider and may include information*  
21        *from previous studies and reports relating to French and*  
22        *Indian War or Mexican-American War historic sites pre-*  
23        *pared by the National Park Service, the American Battle-*  
24        *field Trust, or other historic preservation organizations, as*  
25        *appropriate.*

1       (e) *SUBMISSION TO CONGRESS.*—

2               (1) *STUDIES CARRIED OUT BY THE SEC-*  
3       *RETARY.*—*With respect to studies carried out by the*  
4       *Secretary in accordance with subsection (b)(1)(A), the*  
5       *Secretary shall submit such studies to the Committee*  
6       *on Natural Resources of the House of Representatives*  
7       *and Committee on Energy and Natural Resources of*  
8       *the Senate not later than 2 years after the date on*  
9       *which funds are made available to carry out such*  
10       *studies.*

11              (2) *STUDIES CARRIED OUT BY OTHER INTER-*  
12       *ESTED PARTIES.*—*With respect to studies carried out*  
13       *by interested individuals or entities in accordance*  
14       *with subsection (b)(1)(B), the Secretary shall submit*  
15       *such studies to the Committee on Natural Resources*  
16       *of the House of Representatives and Committee on*  
17       *Energy and Natural Resources of the Senate not later*  
18       *than 180 days after the date on which the Secretary*  
19       *certifies under subsection (b)(2) that the studies meet*  
20       *the requirements of subsection (c).*
