AN ACT

To require a report on Russian and Chinese intelligence assets in Georgia, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Countering China’s
3 Control of the Caucasus Act”.

4 **SEC. 2. REPORTS AND BRIEFINGS.**

5 (a) **REPORT ON RUSSIAN AND CHINESE INTEL-**
6 **LIGENCE ASSETS IN GEORGIA.—**

7 (1) **DEFINED TERM.—**In this section, the term
8 “relevant congressional committees” means—

9 (A) the Committee on Foreign Relations of
10 the Senate;

11 (B) the Select Committee on Intelligence
12 of the Senate;

13 (C) the Committee on Armed Services of
14 the Senate;

15 (D) the Committee on Appropriations of
16 the Senate;

17 (E) the Committee on Foreign Affairs of
18 the House of Representatives;

19 (F) the Permanent Select Committee on
20 Intelligence of the House of Representatives;

21 (G) the Committee on Armed Services of
22 the House of Representatives; and

23 (H) the Committee on Appropriations of
24 the House of Representatives.

25 (2) **IN GENERAL.—**Not later than 180 days
26 after the date of the enactment of this Act, the Sec-

1 retary of State, in coordination with the Director of
2 National Intelligence and the Secretary of Defense,
3 shall submit a classified report, as appropriate, to
4 the relevant congressional committees that meets the
5 requirements set forth in paragraph (3).

6 (3) CONTENTS.—The report required under
7 paragraph (2) shall—

8 (A) be prepared consistent with the protec-
9 tion of sources and methods;

10 (B) examine the penetration of Russian
11 and Chinese intelligence elements and their as-
12 sets in Georgia; and

13 (C) examine the potential intersection of
14 Russian and Chinese influence and cooperation
15 in Georgia.

16 (b) 5-YEAR UNITED STATES STRATEGY FOR BILAT-
17 ERAL RELATIONS WITH GEORGIA.—

18 (1) IN GENERAL.—Not later than 180 days
19 after the date of the enactment of this Act, the Sec-
20 retary of State shall submit to the relevant congres-
21 sional committees a detailed strategy that—

22 (A) outlines specific objectives for enhanc-
23 ing bilateral ties which reflect the current do-
24 mestic political environment in Georgia;

1 (B) includes a determination of the tools,
2 resources, and funding that should be available
3 to achieve the objectives outlined pursuant to
4 subparagraph (A) and an assessment of wheth-
5 er Georgia should remain a top recipient of
6 United States funding in the Europe and Eur-
7 asia region;

8 (C) includes a determination of the extent
9 to which the United States should continue to
10 invest in its partnership with Georgia; and

11 (D) includes a determination of whether
12 the Government of Georgia remains committed
13 to expanding trade ties with the United States
14 and Europe and whether the United States
15 Government should continue to invest in Geor-
16 gian projects.

17 (2) FORM.—The report required under para-
18 graph (1) shall be submitted in unclassified form,
19 with a classified annex.
