Mr. WIED (for himself and Mr. TIFFANY) introduced the following bill; which was referred to the Committee on the Judiciary

A BILL

To require the Attorney General to administer grants to discourage repeat offenders.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Securing Our Streets
5 Act of 2026” or the “SOS Act of 2026”.

6 **SEC. 2. GRANT PROGRAM.**

7 Title I of the Omnibus Crime Control and Safe
8 Streets Act of 1968 (34 U.S.C. 10101 et seq.) is amended
9 by adding at the end the following:

1 **“PART PP—REPEAT OFFENDERS**

2 **“SEC. 3061. GRANT TO DISCOURAGE REPEAT OFFENDERS.**

3 “(a) IN GENERAL.—Beginning not later than 180
4 days after the date of enactment of this part, the Attorney
5 General shall carry out a program under which the Attor-
6 ney General makes grants to States to.

7 “(b) APPLICATIONS.—A State seeking a grant under
8 this part shall submit to the Attorney General an applica-
9 tion at such time, in such manner, and containing such
10 information as the Attorney General may require.

11 “(c) ELIGIBILITY.—To be eligible to receive a grant
12 under this part, a State shall have in effect a law or policy
13 that requires—

14 “(1) repeat offenders to serve at least 85 per-
15 cent of the sentenced imposed;

16 “(2) pretrial detention of individuals charged
17 with a crime of violence who pose a clear threat to
18 public safety; and

19 “(3) life imprisonment for individuals convicted
20 of 3 distinct offenses, arising out of different con-
21 duct occurring at different times, that constitute
22 crimes of violence.

23 “(d) USES OF FUNDS.—A State that receives a grant
24 under this part shall use such grant to—

25 “(1) construct secure correctional facilities;

1 “(2) expand operational capacity to incarcerate
2 offenders who have committed crimes of violence;
3 and

4 “(3) train and support correctional staff.

5 **“SEC. 3062. AUTHORIZATION OF APPROPRIATIONS.**

6 “‘There is authorized to be appropriated to carry out
7 this part \$10,000,000,000 for fiscal years 2027 through
8 2031.’”.
