Mr. PERRY (for himself, Mr. ROY, and Mr. DAVIDSON) introduced the following bill; which was referred to the Committee on Transportation and Infrastructure

A BILL

To exempt certain vessels transporting liquefied natural gas from certain coastwise endorsement requirements, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “American LNG First
5 Act of 2026”.

1 **SEC. 2. EXEMPTION FROM COASTWISE LAWS FOR VESSELS**
2 **TRANSPORTING LIQUEFIED NATURAL GAS.**

3 (a) GENERAL ELIGIBILITY REQUIREMENTS.—Sec-
4 tion 12103 of title 46, United States Code, is amended
5 by adding at the end the following:

6 “(d) EXCEPTION FOR VESSELS TRANSPORTING LIQ-
7 UEFIED NATURAL GAS.—

8 “(1) IN GENERAL.—Notwithstanding subsection
9 (a), a certificate of documentation may be issued
10 under this chapter for any vessel transporting meth-
11 ane, refrigerated liquid, commonly known as lique-
12 fied natural gas.

13 “(2) CERTAIN VESSELS EXCLUDED.—Para-
14 graph (1) shall not apply to—

15 “(A) a vessel that is owned, in whole or in
16 part, by—

17 “(i) a Russian national; or

18 “(ii) the Government of the Russian
19 Federation;

20 “(B) a Russian-flagged vessel;

21 “(C) a vessel for which any crewmember is
22 a Russian national;

23 “(D) a vessel that is owned in whole or in
24 part, by—

25 “(i) a Chinese national; or

1 “(ii) the Government of the People’s
2 Republic of China;
3 “(E) a Chinese-flagged vessel; or
4 “(F) a vessel for which any crewmember is
5 a Chinese national.”.

6 (b) COASTWISE ENDORSEMENT.—Section
7 12112(a)(2)(B) of title 46, United States Code, is amend-
8 ed—

9 (1) in clause (ii) by striking “or” at the end;
10 (2) in clause (iii) by striking “and” at the end
11 and inserting “or”; and
12 (3) by adding at the end the following:

13 “(iv) transports methane, refrigerated liq-
14 uid, commonly known as liquefied natural gas;
15 and”.
