A BILL

To amend the FISA Amendments Act of 2008 to extend the authorities of title VII of the Foreign Intelligence Surveillance Act of 1978 through October 20, 2027, and for other purposes.

1 **SECTION 1. EXTENSION OF AUTHORITIES OF TITLE VII OF**
2 **THE FOREIGN INTELLIGENCE SURVEIL-**
3 **LANCE ACT OF 1978.**

4 (a) EXTENSION OF REPEAL DATE OF TITLE VII.—
5 Section 403(b) of the FISA Amendments Act of 2008
6 (Public Law 110–261) is amended—

7 (1) in paragraph (1) (50 U.S.C. 1881 note), by
8 striking “effective two years after” and all that fol-
9 lows through the period at the end and inserting
10 “effective October 20, 2027, title VII of the Foreign
11 Intelligence Surveillance Act of 1978 (50 U.S.C.
12 1881 et seq.) is repealed.”; and

13 (2) in paragraph (2) (18 U.S.C. 2511 note), in
14 the matter preceding subparagraph (A), by striking
15 “Effective two years after the date of enactment of
16 the Reforming Intelligence and Securing America
17 Act—” and inserting “Effective October 20, 2027—
18 ”.

19 (b) EXTENSION OF TRANSITION PROCEDURES.—Sec-
20 tion 404(b) of the FISA Amendments Act of 2008 (Public
21 Law 110–261) is amended—

22 (1) in paragraph (1)—

23 (A) in the heading, by striking “TWO
24 YEARS AFTER THE DATE OF ENACTMENT OF
25 THE REFORMING INTELLIGENCE AND SECURING

1 AMERICA ACT” and inserting “REPEAL DATE”;
2 and

3 (B) by striking “, as amended by section
4 101(a) and by the FISA Amendments Reau-
5 thorization Act of 2017 and the Reforming In-
6 telligence and Securing America Act,” and in-
7 serting “(50 U.S.C. 1881 et seq.)”; and

8 (2) in paragraph (2), by striking “, as amended
9 by section 101(a) and by the FISA Amendments Re-
10 authorization Act of 2017 and the Reforming Intel-
11 ligence and Securing America Act,” and inserting
12 “(50 U.S.C. 1881 et seq.)”.

13 (c) EFFECTIVE DATE.—The amendments made by
14 this section shall take effect on the earlier of the date of
15 the enactment of this Act or April 19, 2026.
