# **A BILL**

To authorize peace officer standards and training agencies to access criminal history records, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Criminal History Access*  
5 *Act of 2026”.*

6 **SEC. 2. FEDERAL BUREAU OF INVESTIGATION.**

7        *(a) ATTORNEY GENERAL DUTIES.—Section 534 of title*  
8 *28, United States Code, is amended—*

9                *(1) in subsection (a)(4), by amending to read as*  
10 *follows:*

11                *“(4) exchange such records and information*  
12 *with, and for the official use of, authorized officials*  
13 *of the Federal Government, including the United*  
14 *States Sentencing Commission, the States, including*  
15 *State sentencing commissions and peace officer stand-*  
16 *ards and training agencies, Indian tribes, cities, and*  
17 *penal and other institutions; and”;*

18                *(2) in subsection (e)—*

19                        *(A) by striking “section, the term” and in-*  
20 *serting the following: “section—*

21 *“(1) the term”;*

22                        *(B) by striking “(1) railroad” and inserting*  
23 *the following:*

24                        *“(A) railroad”;*

1           (C) by striking “(2) police” and inserting  
2           the following:

3           “(B) police”;

4           (D) by striking the period at the end and  
5           inserting a semicolon; and

6           (E) by adding at the end the following:

7           “(2) the term ‘peace officer standards and train-  
8           ing agency’ means an agency of a State with the stat-  
9           utory authority under State law to set standards for  
10          the hiring, training, ethical conduct, and retention of  
11          the law enforcement officers of the State through cer-  
12          tification, licensing, or other similar qualification  
13          process; and

14          “(3) the term ‘State’ means each of the several  
15          States of the United States, the District of Columbia,  
16          the Commonwealth of Puerto Rico, the United States  
17          Virgin Islands, Guam, American Samoa, the Com-  
18          monwealth of the Northern Mariana Islands, and any  
19          territory or possession of the United States.”.

20          (b) REGULATIONS.—Not later than 180 days after the  
21          date of enactment of this Act, the Attorney General shall  
22          amend part 20 of title 28, Code of Federal Regulations, as  
23          necessary to carry out the provisions of this Act.
