Mr. HURD of Colorado (for himself and Ms. PETTERSEN) introduced the following bill; which was referred to the Committee on Transportation and Infrastructure, and in addition to the Committee on Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To amend the America’s Water Infrastructure Act of 2018 to reauthorize the Indian Reservation Drinking Water Program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Western Tribal Water
5 Act of 2026”.

6 **SEC. 2. FINDINGS.**

7 Congress finds that—

1 (1) the Upper Colorado River Basin is home to
2 several Indian Tribes that face a variety of chal-
3 lenges for water supply reliability, including over
4 \$100,000,000 in water infrastructure needs;

5 (2) the Ute Mountain Ute Tribe in particular
6 has a project with an estimated cost of \$50,000,000
7 to fix aging drinking water delivery infrastructure in
8 southwestern Colorado; and

9 (3) the Indian Reservation Drinking Water
10 Program under section 2001 of the America’s Water
11 Infrastructure Act of 2018 (42 U.S.C. 300j–3c note;
12 Public Law 115–270) helps Indian Tribes in other
13 drought-stricken basins across the Western United
14 States improve their drinking water supplies and
15 other water services.

16 **SEC. 3. INDIAN RESERVATION DRINKING WATER PROGRAM.**

17 Section 2001 of the America’s Water Infrastructure
18 Act of 2018 (42 U.S.C. 300j–3c note; Public Law 115–
19 270) is amended—

20 (1) in subsection (c)(1)—

21 (A) in subparagraph (D), by striking
22 “and” at the end;

23 (B) in subparagraph (E), by striking the
24 period at the end and inserting “; and”; and

25 (C) by adding at the end the following:

1 “(F) 10 eligible projects described in sub-
2 section (b) that are within the Upper Colorado
3 River Basin.”; and
4 (2) in subsection (g)—
5 (A) in paragraph (1), by striking “and” at
6 the end;
7 (B) in paragraph (2), by striking the pe-
8 riod at the end and inserting “; and”; and
9 (C) by adding at the end the following:
10 “(3) \$60,000,000 for each of fiscal years 2027
11 and 2028.”.
