A BILL

To require the Administrator of the Small Business Administration to implement a certain recommendation relating to artificial intelligence adoption, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Small Business Admin-
5 istration Artificial Intelligence Adoption Reporting Act of
6 2026” or the “SBA AI Adoption Reporting Act of 2026”.

1 **SEC. 2. IMPLEMENTATION OF RECOMMENDATION RELAT-**
2 **ING TO ARTIFICIAL INTELLIGENCE ADOPT-**
3 **ION FOR THE SMALL BUSINESS ADMINIS-**
4 **TRATION.**

5 (a) IN GENERAL.—The Administrator of the Small
6 Business Administration, acting through the Chief Infor-
7 mation Officer of the Administration, shall take such ac-
8 tions as may be necessary to implement the recommenda-
9 tions contained in the report of the Comptroller General
10 of the United States titled “Artificial Intelligence: Uses
11 and Risks for Small Business Contracting and Innovation
12 Research” (GAO–26–107828; published May 4, 2026).

13 (b) IMPLEMENTATION PLAN.—Not later than 45
14 days after the date of the enactment of this Act, the Ad-
15 ministrator shall submit to the Committee on Small Busi-
16 ness of the House of Representatives and the Committee
17 on Small Business and Entrepreneurship of the Senate an
18 implementation plan detailing the actions the Small Busi-
19 ness Administration will undertake to establish and imple-
20 ment policies and procedures to disclose artificial intel-
21 ligence use and consideration of the Administration, in ac-
22 cordance with the requirements of section 7225 of the Ad-
23 vancing American AI Act (40 U.S.C. 11301 note) and the
24 memorandum of the Office of Management and Budget
25 titled “Accelerating Federal Use of AI Through Innova-
26 tion, Governance, and Public Trust” (M–25–21; signed

1 April 3, 2025), or any successor administrative memo-
2 randum or guidance. Such policies and procedures shall
3 include—

4 (1) definitions of roles and responsibilities for
5 collecting, summarizing, and publishing use cases of
6 artificial intelligence; and

7 (2) documentation of the implementation of
8 such policies and procedures and key decisions.

9 (c) ADDITIONAL REQUIREMENTS.—The implementa-
10 tion plan required by this section shall include the actions
11 required to carry out the requirements of subsection (b)
12 and the timelines for completion of each action.
