A BILL

To require the Comptroller General to evaluate Federal cybersecurity assistance to small business concerns, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Small Business Cyber-
5 security Assistance Evaluation Act of 2026”.

6 **SEC. 2. GAO STUDY ON SMALL BUSINESS CYBERSECURITY**
7 **ASSISTANCE.**

8 (a) STUDY.—The Comptroller General of the United
9 States shall conduct a study of current Federal cybersecu-
10 rity initiatives, programs, resources, tools, and services in-

1 tended to assist owners of small business concerns (as de-
2 fined under section 3 of the Small Business Act (15
3 U.S.C. 632)) with—

4 (1) identifying cyber risks, cyber threats, and
5 cybersecurity vulnerabilities relating to such con-
6 cerns;

7 (2) assessing the preparedness of such concerns
8 for such risks, threats, and vulnerabilities;

9 (3) planning for, mitigating, and recovering
10 from cyberattacks and incidents of social engineer-
11 ing, scams, and fraud (including developing, adopt-
12 ing, and implementing cybersecurity measures, train-
13 ing, protocols, tools, and infrastructure); and

14 (4) identifying sources of capital, or obtaining
15 capital, to carry out the activities specified in para-
16 graphs (1), (2), and (3).

17 (b) REQUIRED CONTENT.—The study required by
18 subsection (a) shall include—

19 (1) information on the most common
20 cyberattacks affecting small business concerns;

21 (2) an identification and description of the Fed-
22 eral cybersecurity initiatives, programs, resources,
23 tools, and services included in the study described in
24 subsection (a);

1 (3) an assessment of the awareness and use of
2 such Federal cybersecurity initiatives, programs, re-
3 sources, tools, and services by small business con-
4 cerns and reasons for differences in levels of such
5 awareness and use;

6 (4) an assessment of the coordination and inte-
7 gration among such Federal cybersecurity initiatives,
8 programs, resources, tools, and services;

9 (5) an assessment of the effectiveness of such
10 Federal cybersecurity initiatives, programs, re-
11 sources, tools, and services in assisting small busi-
12 ness concerns with the activities listed in paragraphs
13 (1) through (4) of subsection (a);

14 (6) an identification of any foundational cyber-
15 security concepts absent from such Federal cyberse-
16 curity initiatives, programs, resources, tools, and
17 services; and

18 (7) recommendations on how to improve the ef-
19 fectiveness, awareness, and coordination of such
20 Federal cybersecurity initiatives, programs, re-
21 sources, tools, and services for small business con-
22 cerns.

23 (c) REPORT.—The Comptroller General shall submit
24 to the Committee on Small Business of the House of Rep-
25 resentatives and the Committee on Small Business and

1 Entrepreneurship of the Senate a report containing all
2 findings and determinations made in carrying out the
3 study required under subsection (a).

4 **SEC. 3. COMPLIANCE WITH CUTGO.**

5 No additional amounts are authorized to carry out
6 this Act.
