## A BILL

To amend the Immigration and Nationality Act to provide for a limitation on approval of an immigrant petition on behalf of an alien who was previously employed by an entity on the Department of Defense’s 1260H list.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “No PLA Employees  
5 Act of 2026”.

1 **SEC. 2. INADMISSIBILITY AND DEPORTABILITY RELATED**  
2 **TO CURRENT OR PREVIOUS EMPLOYMENT BY**  
3 **A CHINESE MILITARY COMPANY OR FOREIGN**  
4 **INSTITUTION ENGAGED IN PROBLEMATIC AC-**  
5 **TIVITY.**

6 (a) INADMISSIBILITY.—Section 212(a)(2) of the Im-  
7 migration and Nationality Act (8 U.S.C. 1182(a)(2)) is  
8 amended by adding at the end the following:

9 “(J) CURRENT OR PREVIOUS EMPLOYMENT  
10 BY A CHINESE MILITARY COMPANY.—Any alien  
11 who is currently or was previously employed by  
12 an entity identified under section 1260H of the  
13 National Defense Authorization Act for Fiscal  
14 Year 2021 is inadmissible.

15 “(K) CURRENT OR PREVIOUS EMPLOY-  
16 MENT BY A FOREIGN INSTITUTION ENGAGED IN  
17 PROBLEMATIC ACTIVITY.—Any alien who is cur-  
18 rently or was previously employed by an entity  
19 identified under section 1286 of the National  
20 Defense Authorization Act for Fiscal Year 2019  
21 is inadmissible.”.

22 (b) DEPORTABILITY.—Section 237(a)(2) of the Im-  
23 migration and Nationality Act (8 U.S.C. 1227(a)(2)) is  
24 amended by adding at the end the following:

25 “(G) CURRENT OR PREVIOUS EMPLOY-  
26 MENT BY A CHINESE MILITARY COMPANY.—Any

1 alien who is currently or was previously em-  
2 ployed by an entity identified under section  
3 1260H of the National Defense Authorization  
4 Act for Fiscal Year 2021 is deportable.

5 “(H) CURRENT OR PREVIOUS EMPLOY-  
6 MENT BY A FOREIGN INSTITUTION ENGAGED IN  
7 PROBLEMATIC ACTIVITY.—Any alien who is cur-  
8 rently or was previously employed by an entity  
9 identified under section 1286 of the National  
10 Defense Authorization Act for Fiscal Year 2019  
11 is deportable.”.
