Mr. CRENSHAW introduced the following bill; which was referred to the Committee on Education and Workforce

A BILL

To amend the Higher Education Act of 1965 to prohibit institutions of higher education from requiring ideological oaths or similar statements, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PROHIBITION RELATING TO IDEOLOGICAL**
4 **OATHS AND SIMILAR STATEMENTS.**

5 Section 487(a) of the Higher Education Act of 1965
6 (20 U.S.C. 1094(a)) is amended by adding at the end the
7 following:

8 “(30)(A) The institution will not—

1 “(i) compel, require, induce, or solicit a
2 student enrolled at the institution, an employee
3 or contractor of the institution, or an applicant
4 for admission to or employment or contracting
5 at the institution to—

6 “(I) endorse an ideology that pro-
7 motes the differential treatment of an indi-
8 vidual or group of individuals based on
9 race, color, or ethnicity; or

10 “(II) provide a statement indicating
11 the person’s—

12 “(aa) race, color, ethnicity, or na-
13 tional origin, except to the minimum
14 extent needed record any necessary
15 demographic information;

16 “(bb) views on, experience with,
17 or past or planned contributions to ef-
18 forts involving diversity, equity, and
19 inclusion, marginalized groups,
20 antiracism, social justice,
21 intersectionality, or related concepts;
22 or

23 “(cc) views on or experience with
24 race, color, ethnicity, national origin,
25 or other immutable characteristics; or

1 “(ii) provide preferential consideration to a
2 student enrolled at the institution, an employee
3 or contractor of the institution, or an applicant
4 for admission to or employment or contracting
5 at the institution on the basis of the person’s
6 unsolicited statement in support of an ideology
7 described in clause (i)(I).

8 “(B) Nothing in this paragraph may be
9 construed—

10 “(i) to restrict academic research or
11 coursework;

12 “(ii) to prevent a person from providing to
13 an institution of higher education the informa-
14 tion described in subparagraph (A) on the per-
15 son’s own initiative separate from any specific
16 requirement or request from the institution; or

17 “(iii) to prevent an institution from requir-
18 ing an applicant for admission to or employ-
19 ment or contracting at the institution to—

20 “(I) disclose or discuss the content of
21 the applicant’s research or artistic cre-
22 ations;

23 “(II) certify compliance with State
24 and Federal antidiscrimination law; or

1 “(III) discuss pedagogical approaches
2 or experience with students with learning
3 disabilities.”.
