Mr. GOLDMAN of New York (for himself and Mr. NADLER) introduced the following bill; which was referred to the Committee on the Judiciary

A BILL

To amend the Justice for United States Victims of State Sponsored Terrorism Act with respect to lump sum catch up payment for certain eligible parties.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “No 9/11 Family Left
5 Behind Act of 2026”.

6 **SEC. 2. ADDITIONAL LUMP SUM CATCH UP PAYMENT FOR**
7 **CERTAIN ELIGIBLE PARTIES.**

8 Section 404(d)(4) of the Justice for United States
9 Victims of State Sponsored Terrorism Act (34 U.S.C.

1 20144(d)(4)) is amended by adding at the end the fol-
2 lowing:

3 “(E) LUMP SUM CATCH UP PAYMENT FOR
4 CERTAIN ELIGIBLE CLAIMANTS.—

5 “(i) NOTIFICATION PROCEDURES.—

6 Not later than 90 days after the date of
7 the enactment of the Justice for United
8 States Victims of State Sponsored Ter-
9 rorism Act of 2026, the Special Master
10 shall notify any eligible claimant on—

11 “(I) their eligibility for an addi-
12 tional payment under this subpara-
13 graph; and

14 “(II) the process by which they
15 may make a claim under this subpara-
16 graph.

17 “(ii) IN GENERAL.—Notwithstanding
18 subsection (c)(3) or subparagraph (C)(i),
19 the Special Master shall authorize addi-
20 tional payments to eligible claimants in the
21 amount equal to 5.8573 percent of any
22 judgement described in subsection
23 (c)(2)(A).

24 “(iii) TIME REQUIREMENT.—Addi-
25 tional payments under clause (i) shall be

1 made not later than 90 days after the date
2 on which the Special Master receives infor-
3 mation demonstrating that an individual is
4 an eligible claimant.

5 “(iv) APPROPRIATIONS.—There is ap-
6 propriated, out of any amounts in the
7 Treasury not otherwise appropriated, such
8 sums as may be necessary to make the ad-
9 ditional payment under clause (i).

10 “(v) ELIGIBLE CLAIMANT DEFINED.—
11 In this subparagraph, the term ‘eligible
12 claimant’ means an individual—

13 “(I) who has not received pay-
14 ment pursuant to subparagraph
15 (C)(i);

16 “(II) meets the criteria set forth
17 in subsection (c)(1)(A);

18 “(III) has a claim that meets the
19 criteria described in subsection
20 (c)(2)(A); and

21 “(IV) has been determined to
22 be—

23 “(aa) an eligible claimant
24 under section 405(c)(2) of the

“(bb) a spouse or dependent
for the purposes of section
104.44 of title 28, Code of Fed-
eral Regulations, or any suc-
cessor thereto.”.
