A BILL

To amend the Stephen Beck, Jr., ABLE Act of 2014 to adjust the amounts in ABLE accounts excluded from consideration with respect to the Supplemental Security Income Program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Stephen Wira ABLE
5 Act”.

1 **SEC. 2. ADJUSTMENT OF AMOUNTS IN ABLE ACCOUNTS**
2 **DISREGARDED AS A RESOURCE FOR SSI PUR-**
3 **POSES.**

4 (a) **IN GENERAL.**—Section 103(a)(2) of the Stephen
5 Beck, Jr., ABLE Act of 2014 (128 Stat. 4063) is amend-
6 ed by striking “exceeds \$100,000.” and inserting “ex-
7 ceeds—

8 “(A) with respect to calendar year 2026,
9 \$150,000; and

10 “(B) with respect to a successive calendar
11 year, the greater between—

12 “(i) the amount with respect to the
13 most immediate prior calendar year; and

14 “(ii) the amount with respect to the
15 most immediate prior calendar year, ad-
16 justed by the total percentage change that
17 occurred in the Consumer Price Index for
18 All Urban Consumers (all items; United
19 States city average) for the 12-month pe-
20 riod ending June 30 immediately preceding
21 the start of the calendar year.”.

22 (b) **DETERMINATION AND NOTICE OF ADJUST-**
23 **MENT.**—Section 103 of such Act (128 Stat. 4063) is
24 amended—

25 (1) by redesignating subsection (c) as sub-
26 section (d); and

1 (2) by inserting after subsection (b) the fol-
2 lowing:

3 “(c) DETERMINATION AND NOTICE OF ADJUST-
4 MENT.—The Commissioner of Social Security shall—

5 “(1) make the determination of the amount
6 with respect to a calendar year described in sub-
7 section (a)(2)(B); and

8 “(2) publish the determination in the Federal
9 Register on or before November 1 immediately pre-
10 ceding the start of the calendar year.”.
