RESOLUTION

Providing for consideration of the Senate amendments to the bill (H.R. 7148) making further consolidated appropriations for the fiscal year ending September 30, 2026, and for other purposes; providing for consideration of the joint resolution (H.J. Res. 142) disapproving the action of the District of Columbia Council in approving the D.C. Income and Franchise Tax Conformity and Revision Temporary Amendment Act of 2025; and pro-

viding for consideration of the bill (H.R. 4090) to codify certain provisions of certain Executive Orders relating to domestic mining and hardrock mineral resources, and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to take from the Speaker's table the bill
3 (H.R. 7148) making further consolidated appropriations
4 for the fiscal year ending September 30, 2026, and for
5 other purposes, with the Senate amendments thereto, and
6 to consider in the House, without intervention of any point
7 of order, a single motion offered by the chair of the Com-
8 mittee on Appropriations or his designee that the House
9 concur in the Senate amendments. The Senate amend-
10 ments and the motion shall be considered as read. The
11 motion shall be debatable for one hour equally divided and
12 controlled by the chair and ranking minority member of
13 the Committee on Appropriations or their respective des-
14 ignees. The previous question shall be considered as or-
15 dered on the motion to its adoption without intervening
16 motion or demand for division of the question.

17 SEC. 2. Upon adoption of this resolution it shall be
18 in order to consider in the House the joint resolution (H.J.
19 Res. 142) disapproving the action of the District of Co-
20 lumbia Council in approving the D.C. Income and Fran-
21 chise Tax Conformity and Revision Temporary Amend-
22 ment Act of 2025. All points of order against consider-

1 ation of the joint resolution are waived. The joint resolu-
2 tion shall be considered as read. All points of order against
3 provisions in the joint resolution are waived. The joint res-
4 olution shall be debatable for one hour equally divided and
5 controlled by the chair and ranking minority member of
6 the Committee on Oversight and Government Reform or
7 their respective designees. The previous question shall be
8 considered as ordered on the joint resolution to final pas-
9 sage without intervening motion except one motion to re-
10 commit (if otherwise in order).

11 SEC. 3. Upon adoption of this resolution it shall be
12 in order to consider in the House the bill (H.R. 4090)
13 to codify certain provisions of certain Executive Orders re-
14 lating to domestic mining and hardrock mineral resources,
15 and for other purposes. All points of order against consid-
16 eration of the bill are waived. The amendment in the na-
17 ture of a substitute recommended by the Committee on
18 Natural Resources now printed in the bill shall be consid-
19 ered as adopted. The bill, as amended, shall be considered
20 as read. All points of order against provisions in the bill,
21 as amended, are waived. The previous question shall be
22 considered as ordered on the bill, as amended, and on any
23 further amendment thereto, to final passage without inter-
24 vening motion except: (1) one hour of debate equally di-
25 vided and controlled by the chair and ranking minority

- 1 member of the Committee on Natural Resources or their
- 2 respective designees; and (2) one motion to recommit.
