RESOLUTION

Of inquiry requesting the President of the United States to furnish certain information to the House of Representatives relating to the Department of Government Efficiency's access to and usage of NUMIDENT and other personally identifiable information in the possession of the Social Security Administration.

- 1 *Resolved*, That the President of the United States is
- 2 requested to furnish the House of Representatives, not
- 3 later than 14 days after the date of adoption of this reso-

1 lution, copies of any document, record, audio recording,
2 memorandum, call log, correspondence (electronic or oth-
3 erwise), audit trails and audit logs, written agreements,
4 or other communication in his possession, or any portion
5 of any document, record, audio recording, memorandum,
6 call log, correspondence (electronic or otherwise), or other
7 communication, that refers or relates to the following:

8 (1) Efforts by the Department of Government
9 Efficiency (hereafter referred to as “DOGE”), Elon
10 Musk, any member of his team, or any individual co-
11 ordinating with the DOGE to communicate with a
12 nongovernmental organization seeking to analyze
13 State voter rolls or overturn election results in cer-
14 tain States, or to share information in the Social Se-
15 curity Administration’s Numerical Identification
16 System (hereafter referred to as “NUMIDENT”) or
17 other personally identifiable information in the pos-
18 session of the Administration with such an organiza-
19 tion.

20 (2) Efforts on or after January 20, 2025, to
21 share NUMIDENT information or other personally
22 identifiable information in the possession of the So-
23 cial Security Administration with the Department of
24 Homeland Security, including through an encrypted
25 and password-protected file sent on March 3, 2025,

1 from a member of the DOGE working at the Social
2 Security Administration to the Department of
3 Homeland Security and copied to Steve Davis.

4 (3) Use of Cloudflare or any other third-party
5 server by DOGE members, including those working
6 at or with the Social Security Administration, to
7 share electronic files containing information in the
8 possession of the Social Security Administration.

9 (4) Actions by the DOGE, Elon Musk, any
10 member of his team, or any individual coordinating
11 with the DOGE to access, use, or transmit
12 NUMIDENT information or other personally identi-
13 fiable information in the possession of the Social Se-
14 curity Administration in violation of any laws, out-
15 side of Social Security Administration policy, or in
16 noncompliance with the temporary restraining order
17 issued by the District Court of Maryland on March
18 20, 2025 and the preliminary injunction granted by
19 the Court on April 17, 2025.
