## RESOLUTION

Providing for consideration of the bill (H.R. 556) to prohibit the Secretary of the Interior and the Secretary of Agriculture from prohibiting the use of lead ammunition or tackle on certain Federal land or water under the jurisdiction of the Secretary of the Interior and the Secretary

of Agriculture, and for other purposes; providing for consideration of the bill (H.R. 1958) to amend the Immigration and Nationality Act to clarify that aliens who have been convicted of defrauding the United States Government or the unlawful receipt of public benefits are inadmissible and deportable; providing for consideration of the bill (H.R. 4638) to amend the Immigration and Nationality Act to provide that an alien who has been convicted of harming animals used in law enforcement is inadmissible and deportable, and for other purposes; and relating to consideration of motions to suspend the rules.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the bill (H.R.  
3 556) to prohibit the Secretary of the Interior and the Sec-  
4 retary of Agriculture from prohibiting the use of lead am-  
5 munition or tackle on certain Federal land or water under  
6 the jurisdiction of the Secretary of the Interior and the

14 shall be considered as adopted. The bill, as amended, shall  
15 be considered as read. All points of order against provi-  
16 sions in the bill, as amended, are waived. The previous  
17 question shall be considered as ordered on the bill, as  
18 amended, and on any further amendment thereto, to final  
19 passage without intervening motion except: (1) one hour  
20 of debate equally divided and controlled by the chair and  
21 ranking minority member of the Committee on the Judici-  
22 ary or their respective designees; and (2) one motion to  
23 recommit.

24       SEC. 3. Upon adoption of this resolution it shall be  
25 in order to consider in the House the bill (H.R. 4638)

1 to amend the Immigration and Nationality Act to provide  
2 that an alien who has been convicted of harming animals  
3 used in law enforcement is inadmissible and deportable,  
4 and for other purposes. All points of order against consid-  
5 eration of the bill are waived. The amendment in the na-  
6 ture of a substitute recommended by the Committee on  
7 the Judiciary now printed in the bill, modified by the  
8 amendment printed in the report of the Committee on  
9 Rules accompanying this resolution, shall be considered as  
10 adopted. The bill, as amended, shall be considered as read.  
11 All points of order against provisions in the bill, as amend-  
12 ed, are waived. The previous question shall be considered  
13 as ordered on the bill, as amended, and on any further  
14 amendment thereto, to final passage without intervening  
15 motion except: (1) one hour of debate equally divided and  
16 controlled by the chair and ranking minority member of  
17 the Committee on the Judiciary or their respective des-  
18 ignees; and (2) one motion to recommit.

19       SEC. 4. Debate on motions that the House suspend  
20 the rules, under clause 1 of rule XV, relating to the joint  
21 resolution (H.J. Res. 139) proposing an amendment to the  
22 Constitution of the United States requiring a balanced  
23 budget for the Federal Government, shall be extended to  
24 one hour.
