7 the Department's cybersecurity activities, to the extent
8 such documentation or any portion thereof is in the pos-
9 session of the Secretary, that refers or relates to the fol-
10 lowing:

11 (1) Any documentation related to any pause of
12 Department grants, loans, or other financial assist-
13 ance contemplated or ordered on or after January
14 20, 2025.

15 (2) Any documentation related to the imple-
16 mentation of Executive Order 14159, Executive
17 Order 14169, Executive Order 14162, Executive
18 Order 14154, Executive Order 14151, Executive
19 Order 14168, Executive Order 14182, and Office of
20 Management and Budget Memorandum M-25-13 at
21 the Department.

22 (3) Any documentation related to the evaluation
23 of potential risks to domestic preparedness and col-
24 lective response to terrorism or the Department's cy-
25 bersecurity activities related to directives con-

1 templated or ordered to pause Department grants,
2 loans, or other financial assistance.

3 (4) Any documentation related to the evaluation
4 of potential risks to domestic preparedness and col-
5 lective response to terrorism or the Department of
6 Homeland Security's cybersecurity activities related
7 to the Department's implementation of Executive
8 Order 14159, Executive Order 14169, Executive
9 Order 14162, Executive Order 14154, Executive
10 Order 14151, Executive Order 14168, Executive
11 Order 14182, and Office of Management and Budg-
12 et Memorandum M-25-13.

13 (5) Any documentation related to communica-
14 tions with organizations outside the Department re-
15 lated to the pause of Department grants, loans, or
16 other financial assistance.

17 (6) Any documentation related to communica-
18 tions with organizations outside the Department re-
19 lated to the implementation Executive Order 14159,
20 Executive Order 14169, Executive Order 14162, Ex-
21 ecutive Order 14154, Executive Order 14151, Exec-
