## RESOLUTION

Of inquiry requesting the President to transmit certain documents to the House of Representatives relating to the conflicts of interest of Elon Musk and related information.

- 1 *Resolved*, That the President is requested to transmit,
- 2 to the extent that such documents are in the possession

1 of the President, to the House of Representatives, not  
2 later than 14 days after the adoption of this resolution,  
3 in a complete and unredacted form, a copy of any docu-  
4 ment, record, report, memorandum, correspondence, or  
5 other communication that refers or relates to—

6 (1) Elon Musk and his role, official or nonoffi-  
7 cial, with the Federal Government;

8 (2) any realized or perceived conflict of interest  
9 Elon Musk may have related to his role with the  
10 United States DOGE Service (commonly referred to  
11 as the “Department of Government Efficiency” or  
12 “DOGE”), any DOGE agency team, or any other  
13 government or pseudo-government entity;

14 (3) any Elon Musk-owned, -managed, -licensed,  
15 or -controlled corporations, partnerships, limited li-  
16 ability companies, limited partnerships, or ventures,  
17 or entity on which Elon Musk serves on the board  
18 of directors; or

19 (4) any Federal Government contract involving  
20 any Elon Musk-owned, -managed, -licensed, or -con-  
21 trolled corporations, partnerships, limited liability  
22 companies, limited partnerships, or ventures, or enti-  
23 ty on which Elon Musk serves on the board of direc-  
24 tors.
