Mr. JACK, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 4016) making appropriations for the Department of Defense for the fiscal year ending September 30, 2026, and for other purposes; providing for consideration of the bill (H.R.

3633) to provide for a system of regulation of the offer and sale of digital commodities by the Securities and Exchange Commission and the Commodity Futures Trading Commission, and for other purposes; providing for consideration of the bill (H.R. 1919) to amend the Federal Reserve Act to prohibit the Federal reserve banks from offering certain products or services directly to an individual, to prohibit the use of central bank digital currency for monetary policy, and for other purposes; providing for consideration of the bill (S. 1582) to provide for the regulation of payment stablecoins, and for other purposes; and waiving a requirement of clause 6(a) of rule XIII with respect to consideration of certain resolutions reported from the Committee on Rules.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 4016) making appropriations for
6 the Department of Defense for the fiscal year ending Sep-
7 tember 30, 2026, and for other purposes. The first reading
8 of the bill shall be dispensed with. All points of order
9 against consideration of the bill are waived. General de-
10 bate shall be confined to the bill and shall not exceed one
11 hour equally divided and controlled by the chair and rank-
12 ing minority member of the Committee on Appropriations
13 or their respective designees. After general debate the bill
14 shall be considered for amendment under the five-minute

1 rule. The bill shall be considered as read. Points of order
2 against provisions in the bill for failure to comply with
3 clause 2 or clause 5(a) of rule XXI are waived.

4 SEC. 2. (a) No amendment to H.R. 4016 shall be in
5 order except those printed in part A of the report of the
6 Committee on Rules accompanying this resolution, amend-
7 ments en bloc described in section 3 of this resolution, and
8 pro forma amendments described in section 4 of this reso-
9 lution.

10 (b) Each amendment printed in part A of the report
11 of the Committee on Rules shall be considered only in the
12 order printed in the report, may be offered only by a Mem-
13 ber designated in the report, shall be considered as read,
14 shall be debatable for the time specified in the report
15 equally divided and controlled by the proponent and an
16 opponent, shall not be subject to amendment except as
17 provided by section 4 of this resolution, and shall not be
18 subject to a demand for division of the question in the
19 House or in the Committee of the Whole.

20 (c) All points of order against amendments printed
21 in part A of the report of the Committee on Rules or
22 against amendments en bloc described in section 3 of this
23 resolution are waived.

24 SEC. 3. It shall be in order at any time for the chair
25 of the Committee on Appropriations or his designee to

1 offer amendments en bloc consisting of amendments print-
2 ed in part A of the report of the Committee on Rules ac-
3 companying this resolution not earlier disposed of. Amend-
4 ments en bloc offered pursuant to this section shall be con-
5 sidered as read, shall be debatable for 20 minutes equally
6 divided and controlled by the chair and ranking minority
7 member of the Committee on Appropriations or their re-
8 spective designees, shall not be subject to amendment ex-
9 cept as provided by section 4 of this resolution, and shall
10 not be subject to a demand for division of the question
11 in the House or in the Committee of the Whole.

12 SEC. 4. During consideration of H.R. 4016 for
13 amendment, the chair and ranking minority member of
14 the Committee on Appropriations or their respective des-
15 ignees may offer up to 10 pro forma amendments each
16 at any point for the purpose of debate.

17 SEC. 5. At the conclusion of consideration of H.R.
18 4016 for amendment the Committee shall rise and report
19 the bill to the House with such amendments as may have
20 been adopted. The previous question shall be considered
21 as ordered on the bill and amendments thereto to final
22 passage without intervening motion except one motion to
23 recommit.

24 SEC. 6. Upon adoption of this resolution it shall be
25 in order to consider in the House the bill (H.R. 3633)

1 to provide for a system of regulation of the offer and sale
2 of digital commodities by the Securities and Exchange
3 Commission and the Commodity Futures Trading Com-
4 mission, and for other purposes. All points of order
5 against consideration of the bill are waived. In lieu of the
6 amendments in the nature of a substitute recommended
7 by the Committees on Agriculture and Financial Services
8 now printed in the bill, an amendment in the nature of
9 a substitute consisting of the text of Rules Committee
10 Print 119–6, modified by the amendment printed in part
11 B of the report of the Committee on Rules accompanying
12 this resolution, shall be considered as adopted. The bill,
13 as amended, shall be considered as read. All points of
14 order against provisions in the bill, as amended, are
15 waived. The previous question shall be considered as or-
16 dered on the bill, as amended, and on any further amend-
17 ment thereto, to final passage without intervening motion
18 except: (1) one hour of debate equally divided among and
19 controlled by the chair and ranking minority member of
20 the Committee on Agriculture or their respective designees
21 and the chair and ranking minority member of the Com-
22 mittee on Financial Services or their respective designees;
23 (2) the further amendment printed in part C of the report
24 of the Committee on Rules, if offered by the Member des-
25 ignated in the report, which shall be in order without

1 intervention of any point of order, shall be considered as
2 read, shall be separately debatable for the time specified
3 in the report equally divided and controlled by the pro-
4 ponent and an opponent, and shall not be subject to a
5 demand for division of the question; and (3) one motion
6 to recommit.

7 SEC. 7. Upon adoption of this resolution it shall be
8 in order to consider in the House the bill (H.R. 1919)
9 to amend the Federal Reserve Act to prohibit the Federal
10 reserve banks from offering certain products or services
11 directly to an individual, to prohibit the use of central
12 bank digital currency for monetary policy, and for other
13 purposes. All points of order against consideration of the
14 bill are waived. The amendment in the nature of a sub-
15 stitute recommended by the Committee on Financial Serv-
16 ices now printed in the bill shall be considered as adopted.
17 The bill, as amended, shall be considered as read. All
18 points of order against provisions in the bill, as amended,
19 are waived. The previous question shall be considered as
20 ordered on the bill, as amended, and on any further
21 amendment thereto, to final passage without intervening
22 motion except: (1) one hour of debate equally divided and
23 controlled by the chair and ranking minority member of
24 the Committee on Financial Services or their respective
25 designees; and (2) one motion to recommit.

1 SEC. 8. Upon adoption of this resolution it shall be
2 in order to consider in the House the bill (S. 1582) to
3 provide for the regulation of payment stablecoins, and for
4 other purposes. All points of order against consideration
5 of the bill are waived. The bill shall be considered as read.
6 All points of order against provisions in the bill are
7 waived. The previous question shall be considered as or-
8 dered on the bill and on any amendment thereto to final
9 passage without intervening motion except: (1) one hour
10 of debate equally divided and controlled by the chair and
11 ranking minority member of the Committee on Financial
12 Services or their respective designees; and (2) one motion
13 to commit.

14 SEC. 9. The requirement of clause 6(a) of rule XIII
15 for a two-thirds vote to consider a report from the Com-
16 mittee on Rules on the same day it is presented to the
17 House is waived with respect to any resolution reported
18 through the legislative day of July 18, 2025, relating to
19 the bill (H.R. 4) to rescind certain budget authority pro-
20 posed to be rescinded in special messages transmitted to
21 the Congress by the President on June 3, 2025, in accord-
22 ance with section 1012(a) of the Congressional Budget
23 and Impoundment Control Act of 1974.
