## RESOLUTION

Of inquiry requesting the President to transmit certain information to the House of Representatives referring to the firings, dismissal, reduction in force, or withholding of pay for the period of the lapse in appropriations of furloughed employees of the United States Government.

1       *Resolved*, That the President is requested to transmit,  
2 to the extent that such documents are in the possession  
3 of the President, to the House of Representatives, not  
4 later than 14 days after the adoption of this resolution,  
5 in complete and unredacted form, a copy of the following:

1           (1) Any and all documents and communica-  
2           tions, including notes from meetings, audio records,  
3           telephone and electronic mail records, text and other  
4           digital messages, related to any proposed reduction  
5           in force at a United States Government Agency re-  
6           lated to the Federal lapse in appropriations begin-  
7           ning on October 1, 2025.

8           (2) Any and all documents and communica-  
9           tions, including notes from meetings, audio records,  
10          telephone and electronic mail records, text and other  
11          digital messages, related to efforts to create a legal  
12          determination at the Office of Management and  
13          Budget finding or suggesting that the Government  
14          Employee Fair Treatment Act of 2019 does not cre-  
15          ate a self-executing requirement that furloughed  
16          Federal employees must receive pay for the period in  
17          which they were furloughed during a lapse in appro-  
18          priations immediately after the lapse in appropria-  
19          tions ends.

20          (3) Any and all documents and communica-  
21          tions, including notes from meetings, audio records,  
22          telephone and electronic mail records, text and other  
23          digital messages, related to efforts or plans to with-  
24          hold pay for the period of the lapse of appropriations  
25          beginning on October 1, 2025, for excepted or fur-

1 loughed employees of the United States Government  
2 or employees of the District of Columbia.

3 (4) Any and all documents or communications  
4 between the Office of the President, the Office of the  
5 Vice President, the Office of Personnel Management,  
6 the Office of Management and Budget, the Office of  
7 Special Counsel, and the Merit System Protection  
8 Board related to any of the above items.
