1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House any joint resolu-  
3 tion specified in section 2 of this resolution. All points of  
4 order against consideration of each such joint resolution  
5 are waived. Each such joint resolution shall be considered  
6 as read. All points of order against provisions in each such  
7 joint resolution are waived. The previous question shall be  
8 considered as ordered on each such joint resolution and  
9 on any amendment thereto to final passage without inter-  
10 vening motion except: (1) one hour of debate equally di-  
11 vided and controlled by the chair and ranking minority  
12 member of the Committee on Natural Resources or their  
13 respective designees; and (2) one motion to recommit (or  
14 commit, as the case may be).

15       SEC. 2. The joint resolutions referred to in the first  
16 section of this resolution are as follows:

17           (a) The joint resolution (S.J. Res. 80) pro-  
18 viding for congressional disapproval under chapter 8  
19 of title 5, United States Code, of the rule submitted  
20 by the Bureau of Land Management relating to  
21 “National Petroleum Reserve in Alaska Integrated  
22 Activity Plan Record of Decision”.

1           (b) The joint resolution (H.J. Res. 130) pro-  
2           viding for congressional disapproval under chapter 8  
3           of title 5, United States Code, of the rule submitted  
4           by the Bureau of Land Management relating to  
5           “Buffalo Field Office Record of Decision and Ap-  
6           proved Resource Management Plan Amendment”.

7           (c) The joint resolution (H.J. Res. 131) pro-  
8           viding for congressional disapproval under chapter 8  
9           of title 5, United States Code, of the rule submitted  
10          by the Bureau of Land Management relating to  
11          “Coastal Plain Oil and Gas Leasing Program  
12          Record of Decision”.

13          SEC. 3. Upon adoption of this resolution it shall be  
14          in order to consider in the House the concurrent resolution  
15          (H. Con. Res. 58) denouncing the horrors of socialism.  
16          All points of order against consideration of the concurrent  
17          resolution are waived. The concurrent resolution shall be  
18          considered as read. All points of order against provisions  
19          in the concurrent resolution are waived. The previous  
20          question shall be considered as ordered on the concurrent  
21          resolution and preamble to adoption without intervening  
22          motion except one hour of debate equally divided and con-  
23          trolled by the chair and ranking minority member of the  
24          Committee on Financial Services or their respective des-  
25          ignees.

1        SEC. 4. Upon adoption of this resolution it shall be  
2 in order to consider in the House the bill (H.R. 1949)  
3 to repeal restrictions on the export and import of natural  
4 gas. All points of order against consideration of the bill  
5 are waived. The bill shall be considered as read. All points  
6 of order against provisions in the bill are waived. The pre-  
7 vious question shall be considered as ordered on the bill  
8 and on any amendment thereto to final passage without  
9 intervening motion except: (1) one hour of debate equally  
10 divided and controlled by the chair and ranking minority  
11 member of the Committee on Energy and Commerce or  
12 their respective designees; and (2) one motion to recom-  
13 mit.

14        SEC. 5. Upon adoption of this resolution it shall be  
15 in order to consider in the House the bill (H.R. 3109)  
16 to require the Secretary of Energy to direct the National  
17 Petroleum Council to issue a report with respect to petro-  
18 chemical refineries in the United States, and for other  
19 purposes. All points of order against consideration of the  
20 bill are waived. The bill shall be considered as read. All  
21 points of order against provisions in the bill are waived.  
22 The previous question shall be considered as ordered on  
23 the bill and on any amendment thereto to final passage  
24 without intervening motion except: (1) one hour of debate  
25 equally divided and controlled by the chair and ranking

1 minority member of the Committee on Energy and Com-  
2 merce or their respective designees; and (2) one motion  
3 to recommit.

4       SEC. 6. Upon adoption of this resolution it shall be  
5 in order to consider in the House the bill (H.R. 5107)  
6 to repeal the Comprehensive Policing and Justice Reform  
7 Amendment Act of 2022 enacted by the District of Colum-  
8 bia Council. All points of order against consideration of  
9 the bill are waived. The amendment in the nature of a  
10 substitute recommended by the Committee on Oversight  
11 and Government Reform now printed in the bill shall be  
12 considered as adopted. The bill, as amended, shall be con-  
13 sidered as read. All points of order against provisions in  
14 the bill, as amended, are waived. The previous question  
15 shall be considered as ordered on the bill, as amended,  
16 and on any further amendment thereto, to final passage  
17 without intervening motion except: (1) one hour of debate  
18 equally divided and controlled by the chair and ranking  
19 minority member of the Committee on Oversight and Gov-  
20 ernment Reform or their respective designees; and (2) one  
21 motion to recommit.

22       SEC. 7. Upon adoption of this resolution it shall be  
23 in order to consider in the House the bill (H.R. 5214)  
24 to require mandatory pretrial and post conviction deten-  
25 tion for crimes of violence and dangerous crimes and re-

1 quire mandatory cash bail for certain offenses that pose  
2 a threat to public safety or order in the District of Colum-  
3 bia, and for other purposes. All points of order against  
4 consideration of the bill are waived. The amendment in  
5 the nature of a substitute recommended by the Committee  
6 on Oversight and Government Reform now printed in the  
7 bill shall be considered as adopted. The bill, as amended,  
8 shall be considered as read. All points of order against  
9 provisions in the bill, as amended, are waived. The pre-  
10 vious question shall be considered as ordered on the bill,  
11 as amended, and on any further amendment thereto, to  
12 final passage without intervening motion except: (1) one  
13 hour of debate equally divided and controlled by the chair  
14 and ranking minority member of the Committee on Over-  
15 sight and Government Reform or their respective des-  
16 ignees; and (2) one motion to recommit.

17       SEC. 8. Upon transmission to the Senate of a mes-  
18 sage that the House has passed H.R. 4405, House Resolu-  
19 tion 581 shall be laid on the table.
