RESOLUTION

Providing for consideration of the bill (H.R. 4593) to amend the Energy Policy and Conservation Act to revise the definition of showerhead; providing for consideration of the bill (H.R. 5184) to prohibit the Secretary of Energy from enforcing energy efficiency standards applicable to manufactured housing, and for other purposes; and providing for consideration of the bill (H.R. 6938) making consolidated appropriations for the fiscal year ending September 30, 2026, and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 4593) to amend the Energy Policy and Conservation Act
4 to revise the definition of showerhead. All points of order
5 against consideration of the bill are waived. The bill shall
6 be considered as read. All points of order against provi-
7 sions in the bill are waived. The previous question shall
8 be considered as ordered on the bill and on any amend-
9 ment thereto to final passage without intervening motion
10 except: (1) one hour of debate equally divided and con-
11 trolled by the chair and ranking minority member of the
12 Committee on Energy and Commerce or their respective
13 designees; and (2) one motion to recommit.

14 SEC. 2. Upon adoption of this resolution it shall be
15 in order to consider in the House the bill (H.R. 5184)
16 to prohibit the Secretary of Energy from enforcing energy
17 efficiency standards applicable to manufactured housing,
18 and for other purposes. All points of order against consid-
19 eration of the bill are waived. The amendment in the na-
20 ture of a substitute recommended by the Committee on
21 Energy and Commerce now printed in the bill shall be con-
22 sidered as adopted. The bill, as amended, shall be consid-
23 ered as read. All points of order against provisions in the
24 bill, as amended, are waived. The previous question shall
25 be considered as ordered on the bill, as amended, and on

1 any further amendment thereto, to final passage without
2 intervening motion except: (1) one hour of debate equally
3 divided and controlled by the chair and ranking minority
4 member of the Committee on Energy and Commerce or
5 their respective designees; and (2) one motion to recom-
6 mit.

7 SEC. 3. Upon adoption of this resolution it shall be
8 in order to consider in the House the bill (H.R. 6938)
9 making consolidated appropriations for the fiscal year
10 ending September 30, 2026, and for other purposes. All
11 points of order against consideration of the bill are waived.
12 The bill shall be considered as read. All points of order
13 against provisions in the bill are waived. The previous
14 question shall be considered as ordered on the bill and on
15 any amendment thereto to final passage without inter-
16 vening motion except: (1) one hour of debate equally di-
17 vided and controlled by the chair and ranking minority
18 member of the Committee on Appropriations or their re-
19 spective designees; (2) proceedings under section 4 of this
20 resolution; and (3) one motion to recommit.

21 SEC. 4. The proceedings referred to in section 3 of
22 this resolution are as follows:

23 (a) after debate pursuant to section 3 of this
24 resolution, the Chair shall, in the order specified by

1 the Chair, put the question on (1) retaining Division
2 A and (2) retaining Divisions B and C;

3 (b) the yeas and nays shall be considered as or-
4 dered on each of the questions under subsection (a);
5 and

6 (c) after disposition of the questions under sub-
7 section (a), the Chair shall put the question on en-
8 grossment and third reading of the text comprising
9 those portions of the bill retained pursuant to sub-
10 section (a).

11 SEC. 5. In the engrossment of H.R. 6938, the Clerk
12 shall conform division and section numbers and make re-
13 lated corrections to cross-references in the event a portion
14 of the bill is not retained pursuant to section 4 of this
15 resolution.

16 SEC. 6. The chair of the Committee on Appropria-
17 tions may insert in the Congressional Record not later
18 than January 9, 2026, such material as he may deem ex-
19 planatory of H.R. 6938.
