Ms. FOXX, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 7006) making further consolidated appropriations for the fiscal year ending September 30, 2026, and for other purposes.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 7006) making further consolidated
6 appropriations for the fiscal year ending September 30,
7 2026, and for other purposes. The first reading of the bill

1 shall be dispensed with. All points of order against consid-
2 eration of the bill are waived. General debate shall be con-
3 fined to the bill and shall not exceed one hour equally di-
4 vided and controlled by the chair and ranking minority
5 member of the Committee on Appropriations or their re-
6 spective designees. After general debate the bill shall be
7 considered for amendment under the five-minute rule. The
8 bill shall be considered as read. All points of order against
9 provisions in the bill are waived. Clause 2(e) of rule XXI
10 shall not apply during consideration of the bill. No amend-
11 ment to the bill shall be in order except those printed in
12 the report of the Committee on Rules accompanying this
13 resolution. Each such amendment may be offered only in
14 the order printed in the report, may be offered only by
15 a Member designated in the report, shall be considered
16 as read, shall be debatable for the time specified in the
17 report equally divided and controlled by the proponent and
18 an opponent, shall not be subject to amendment, and shall
19 not be subject to a demand for division of the question
20 in the House or in the Committee of the Whole. All points
21 of order against such amendments are waived. At the con-
22 clusion of consideration of the bill for amendment the
23 Committee shall rise and report the bill to the House with
24 such amendments as may have been adopted. The previous
25 question shall be considered as ordered on the bill and

1 amendments thereto to final passage without intervening
2 motion except one motion to recommit.

3 SEC. 2. The chair of the Committee on Appropria-
4 tions may insert in the Congressional Record not later
5 than January 16, 2026, such material as he may deem
6 explanatory of H.R. 7006.
