Mr. ROUNDS (for himself and Mr. WELCH) introduced the following bill; which was read twice and referred to the Committee on Homeland Security and Governmental Affairs

A BILL

To require the United States Postal Service to post notices of changes that will affect nationwide postal services, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Instituting Notification
5 Formalities On Reorganizing Mail Act of 2025” or the
6 “INFORM Act of 2025”.

1 **SEC. 2. REQUIRING NOTICES RELATING TO CHANGES IN**
 2 **NATURE OF POSTAL SERVICES.**

3 Section 3661 of title 39, United States Code, is
 4 amended—

5 (1) in subsection (a), by striking “The” and in-
 6 serting “IN GENERAL.—The”;

7 (2) in subsection (b)—

8 (A) by inserting “CHANGE IN NATURE OF
 9 POSTAL SERVICES.—” before “When”; and

10 (B) by striking “When” and all that fol-
 11 lows, and inserting the following:

12 “(1) IN GENERAL.—When the Postal Service
 13 determines that there should be a change in the na-
 14 ture of postal services which will generally affect
 15 service on a nationwide or substantially nationwide
 16 basis, it shall—

17 “(A) submit a proposed change, within a
 18 reasonable time prior to the effective date of
 19 the change, to the Postal Regulatory Commis-
 20 sion requesting an advisory opinion on the
 21 change; and

22 “(B) on the date such proposed change is
 23 submitted to the Postal Regulatory Commis-
 24 sion, post a notice of the change within affected
 25 storefront postal facilities, to remain posted for

1 not fewer than 30 days after the change has
 2 gone into effect, and such notice shall include—

3 “(i) relevant details of the change;

4 “(ii) associated timelines relating to
 5 the implementation of the change;

6 “(iii) anticipated impacts on nation-
 7 wide postal services;

8 “(iv) details of any public meetings
 9 and opportunities for public comment;

10 “(v) contact information for public
 11 comment; and

12 “(vi) other helpful resources as deter-
 13 mined necessary by the Postal Service.”;

14 (3) by redesignating subsection (c) as para-
 15 graph (2) of subsection (b); and

16 (4) in paragraph (2) of subsection (b), as so re-
 17 designated—

18 (A) by inserting “HEARING AND OPINION
 19 OF COMMISSION.—” before “The Commission”;
 20 and

21 (B) by striking “proposal” and inserting
 22 “proposed change”.
