A BILL

To amend the Food and Nutrition Act of 2008 to permit supplemental nutrition assistance program benefits to be used to purchase additional types of food items.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Hot Foods Act of
5 2025”.

1 **SEC. 2. HOT FOOD UNDER SUPPLEMENTAL NUTRITION AS-**
 2 **SISTANCE PROGRAM.**

3 Section 3 of the Food and Nutrition Act of 2008 (7
 4 U.S.C. 2012) is amended—

5 (1) in subsection (k)(1), by striking “consump-
 6 tion except alcoholic beverages, tobacco, hot foods or
 7 hot food products ready for immediate consumption
 8 other than those authorized pursuant to clauses (3),
 9 (4), (5), (7), (8), and (9) of this subsection” and in-
 10 serting “consumption, including hot foods or hot
 11 food products ready for immediate consumption and
 12 excluding alcoholic beverages, tobacco”;

13 (2) in subsection (o)(1)—

14 (A) in the matter preceding subparagraph
 15 (A), by striking “and consumption” and insert-
 16 ing “or home or immediate consumption”; and

17 (B) in subparagraph (A)—

18 (i) by striking the subparagraph des-
 19 ignation and all that follows through “of-
 20 fers” and inserting the following:

21 “(A)(i) offers”;

22 (ii) in clause (i) (as so designated), by
 23 striking “or” at the end and inserting
 24 “and”; and

25 (iii) by adding at the end the fol-
 26 lowing:

1 “(ii) of which not more than 50 percent of
2 the total gross sales are from hot foods or hot
3 food products ready for immediate consump-
4 tion; or”; and

5 (3) in subsection (q)(2)—

6 (A) by striking “include accessory” and in-
7 serting the following: “include—

8 “(A) accessory”;

9 (B) in subparagraph (A) (as so des-
10 ignated), by striking the period at the end and
11 inserting “; and”; and

12 (C) by adding at the end the following:

13 “(B) hot foods or hot food products ready
14 for immediate consumption.”.
