A BILL

To provide enhanced funding for family planning services.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Expanding Access to
5 Family Planning Act”.

6 **SEC. 2. TITLE X CLINIC FUND.**

7 (a) IN GENERAL.—There is established a Title X
8 Clinic Fund to be administered through the Office of the
9 Secretary of the Department of Health and Human Serv-
10 ices (referred to in this section as the “Office of the Sec-

1 retary”), to provide for expanded and sustained national
 2 investment in clinics providing family planning services
 3 supported under title X of the Public Health Service Act
 4 (42 U.S.C. 300 et seq.) (referred to in this section as “title
 5 X clinics”).

6 (b) FUNDING.—There is appropriated to the Office
 7 of the Secretary for the Title X Clinic Fund, out of any
 8 monies in the Treasury not otherwise appropriated, for
 9 each of fiscal years 2026 through 2035—

10 (1) \$512,000,000 for necessary expenses for
 11 grants and contracts under title X of the Public
 12 Health Service Act (42 U.S.C. 300 et seq.); and

13 (2) \$50,000,000 for infrastructure, including
 14 the construction and renovation (including equip-
 15 ment) of title X clinics.

16 (c) AVAILABILITY.—Amounts appropriated under
 17 subsection (b) shall remain available until expended.

18 (d) CONDITIONS ON FUNDING.—

19 (1) PROHIBITION.—No recipient of funds made
 20 available under this section that makes a subaward
 21 for the provision of title X services may prohibit an
 22 entity from participating in such subaward program
 23 for reasons other than the entity’s inability to pro-
 24 vide such title X services.

1 (2) PREGNANCY COUNSELING.—In the case of
2 services provided by a title X clinic that receives
3 funding made available under this section, all preg-
4 nancy counseling shall be nondirective, and, with re-
5 spect to all patients of the title X clinic with a posi-
6 tive pregnancy test, the following shall apply:

7 (A) All such patients shall be given the op-
8 portunity to be provided information and coun-
9 seling regarding each of the following options:

10 (i) Prenatal care and delivery.

11 (ii) Infant care, foster care, and adop-
12 tion.

13 (iii) Pregnancy termination.

14 (B) If the patient requests such informa-
15 tion and counseling, such patient shall be pro-
16 vided with neutral, factual information and
17 nondirective counseling on each option de-
18 scribed in subparagraph (A), including referral
19 upon request, except with respect to any option
20 about which the patient indicates no interest in
21 receiving such information and counseling.
