A BILL

To amend title 49, United States Code, to allow for eligibility for projects for the installation of human trafficking awareness signs at rest stops, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Combating Trafficking
5 in Transportation Act”.

1 **SEC. 2. HUMAN TRAFFICKING AWARENESS SIGNS AT REST**
2 **STOPS.**

3 (a) LOCAL AND REGIONAL PROJECT ASSISTANCE.—
4 Section 6702 of title 49, United States Code, is amend-
5 ed—

6 (1) in subsection (a)(3)—

7 (A) in subparagraph (G), by striking
8 “and” at the end;

9 (B) by redesignating subparagraph (H) as
10 subparagraph (I); and

11 (C) by adding at the end the following:

12 “(H) a project to procure and install
13 human trafficking awareness signage at rest
14 stops and welcome centers along the Interstate
15 System; and”; and

16 (2) in subsection (c), by adding at the end the
17 following:

18 “(4) CERTAIN PROJECTS.—In the case of an el-
19 igible project described in subsection (a)(3)(H), sub-
20 paragraphs (A) and (B) of paragraph (2) shall not
21 apply.”.

22 (b) SURFACE TRANSPORTATION BLOCK GRANT PRO-
23 GRAM.—Section 133(b) of title 23, United States Code is
24 amended by adding at the end the following:

25 “(25) Projects described in section
26 6702(a)(3)(H) of title 49.”.

1 **SEC. 3. DEPARTMENT OF TRANSPORTATION ADVISORY**
2 **COMMITTEE ON HUMAN TRAFFICKING.**

3 Section 5 of the Combating Human Trafficking in
4 Commercial Vehicles Act (Public Law 115–99; 131 Stat.
5 2243) is amended—

6 (1) in subsection (b)—

7 (A) in paragraph (1), by striking “15” and
8 inserting “16”; and

9 (B) in paragraph (2)—

10 (i) in subparagraph (B), by striking
11 “and” at the end;

12 (ii) in subparagraph (C), by striking
13 the period at the end and inserting “;
14 and”; and

15 (iii) by adding at the end the fol-
16 lowing:

17 “(D) State departments of transpor-
18 tation.”; and

19 (2) in subsection (c)—

20 (A) by striking “Not later than” and in-
21 serting the following:

22 “(1) IN GENERAL.—Except as provided in para-
23 graph (2), not later than”; and

24 (B) by adding at the end the following:

25 “(2) STATE DEPARTMENT OF TRANSPORTATION
26 REPRESENTATIVES.—The Secretary shall appoint

1 the member described in subsection (b)(2)(D) by not
2 later than 9 months after the date of enactment of
3 the Combating Trafficking in Transportation Act.”.
