A BILL

To amend title XVIII of the Social Security Act to improve access to mental health services under the Medicare program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Expanding Seniors Ac-
5 cess to Mental Health Services Act”.

6 **SEC. 2. IMPROVED ACCESS TO MENTAL HEALTH SERVICES**

7 **UNDER THE MEDICARE PROGRAM.**

8 (a) ACCESS TO CLINICAL SOCIAL WORKER SERVICES

9 PROVIDED TO RESIDENTS OF SKILLED NURSING FACILI-

10 TIES.—

1 (1) EXCLUSION OF CLINICAL SOCIAL WORKER
 2 SERVICES FROM THE SKILLED NURSING FACILITY
 3 PROSPECTIVE PAYMENT SYSTEM.—Section
 4 1888(e)(2)(A)(iii) of the Social Security Act (42
 5 U.S.C. 1395yy(e)(2)(A)(iii)) is amended by adding
 6 at the end the following new subclause:

7 “(VII) Clinical social worker
 8 services (as defined in section
 9 1861(hh)(2)).”.

10 (2) CONFORMING AMENDMENT.—Section
 11 1861(hh)(2) of the Social Security Act (42 U.S.C.
 12 1395x(hh)(2)) is amended by striking “and other
 13 than services furnished to an inpatient of a skilled
 14 nursing facility which the facility is required to pro-
 15 vide as a requirement for participation”.

16 (b) ACCESS TO THE COMPLETE SET OF CLINICAL
 17 SOCIAL WORKER SERVICES.—Section 1861(hh)(2) of the
 18 Social Security Act (42 U.S.C. 1395x(hh)(2)), as amended
 19 by subsection (a)(2), is amended—

20 (1) by striking “for the diagnosis and treatment
 21 of mental illnesses (other than services” and insert-
 22 ing “, including services for the diagnosis and treat-
 23 ment of mental illnesses or services for health and
 24 behavior assessment and intervention (identified as
 25 of January 1, 2023, by HCPCS codes 96156,

1 96158–96161, 96164–96168, and 96170–96171
2 (and any succeeding codes)) but not including serv-
3 ices”; and

4 (2) by striking “inpatient of a hospital)” and
5 inserting “inpatient of a hospital,”.

6 (c) EFFECTIVE DATE.—The amendments made by
7 this section shall apply to items and services furnished on
8 or after January 1, 2026.
