Mr. BOOZMAN (for himself and Ms. HASSAN) introduced the following bill;
which was read twice and referred to the Committee on Veterans' Affairs

A BILL

To direct a physician or nurse practitioner employed by the Secretary of Veterans Affairs to certify the death of a veteran not later than 48 hours after such physician or nurse practitioner learns of such death, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Veteran Burial Timeli-
5 ness and Death Certificate Accountability Act”.

6 **SEC. 2. FINDINGS.**

7 Congress finds the following:

1 (1) States and counties have reported signifi-
2 cant delays in the signing of death certificates for
3 veterans who pass away from natural causes.

4 (2) Such delays, caused by the refusal of, or
5 postponement by, physicians of the Department of
6 Veterans Affairs have, in some cases, lasted as long
7 as eight weeks.

8 (3) Such delays prevent the timely burial of de-
9 ceased veterans and access to survivor benefits.

10 **SEC. 3. TIMELY CERTIFICATION OF THE DEATH OF A VET-**
11 **ERAN.**

12 (a) IN GENERAL.—

13 (1) VA PHYSICIAN OR NURSE PRACTITIONER.—
14 Subject to paragraph (2), a physician or nurse prac-
15 titioner employed by the Secretary of Veterans Af-
16 fairs who is the primary care provider of a veteran
17 who dies of natural causes shall certify the death of
18 such veteran not later than 48 hours after such phy-
19 sician or nurse practitioner learns of such death.

20 (2) CORONER OR MEDICAL EXAMINER.—If a
21 physician or nurse practitioner described in para-
22 graph (1) cannot comply with such paragraph with
23 respect to a death described in such paragraph, a
24 coroner or medical examiner in the jurisdiction
25 where such death occurred may certify such death.

1 (b) REPORT.—

2 (1) IN GENERAL.—Not later than one year
3 after the date of the enactment of this Act, and an-
4 nually thereafter, the Secretary shall submit to the
5 Committee on Veterans' Affairs of the Senate and
6 the Committee on Veterans' Affairs of the House of
7 Representatives a report regarding compliance with
8 subsection (a).

9 (2) ELEMENTS.—Each report required under
10 paragraph (1) shall include, with respect to the year
11 preceding the date of the report, the following ele-
12 ments:

13 (A) The percentage of cases in which a
14 physician or nurse practitioner employed by the
15 Secretary complied with subsection (a)(1).

16 (B) The number of cases in which such a
17 physician or nurse practitioner could not so
18 comply.

19 (C) An identification of the most common
20 reasons why such a physician or nurse practi-
21 tioner could not so comply.

22 (c) RULE OF CONSTRUCTION.—Nothing in this Act
23 shall require any employee of the Department of Veterans
24 Affairs, including a physician or nurse practitioner, to
25 take an action not in compliance with the laws, regula-

1 tions, or requirements of the appropriate jurisdiction in
2 which the employee is licensed or practicing, or in which
3 a death may need to be certified.
