Ms. ROSEN (for herself and Mr. CORNYN) introduced the following bill; which was read twice and referred to the Committee on Finance

A BILL

To amend title XVIII of the Social Security Act to require that coinsurance for drugs under Medicare part D be based on the drug's net price and not the drug's list price.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Reducing Drug Prices
5 for Seniors Act.”.

1 **SEC. 2. REQUIRING THAT COINSURANCE FOR DRUGS**
2 **UNDER MEDICARE PART D BE BASED ON THE**
3 **DRUG'S NET PRICE AND NOT THE DRUG'S**
4 **LIST PRICE.**

5 Section 1860D-2 of the Social Security Act (42
6 U.S.C. 1395w-102) is amended—

7 (1) in subsection (b)—

8 (A) in paragraph (2)(A), in the matter
9 preceding clause (i), by striking “and (9)” and
10 inserting “, (9), and (10)”; and

11 (B) by adding at the end the following new
12 paragraph:

13 “(10) REQUIREMENT THAT COINSURANCE FOR
14 COVERED PART D DRUGS BE BASED ON THE NET
15 PRICE OF THE DRUG.—

16 “(A) IN GENERAL.—For plan years begin-
17 ning on or after January 1, 2026, for costs
18 above the annual deductible specified in para-
19 graph (1) and below the annual out-of-pocket
20 threshold specified in paragraph (4), any coin-
21 surance amount for a covered part D drug (in-
22 sofar as such covered part D drug is included
23 on the formulary and subject to coinsurance
24 rather than a copayment) shall be calculated
25 based on the net price (and not the list price)
26 of such covered part D drug if such net price

1 is lower than the list price of such covered part
2 D drug. The preceding sentence shall not apply
3 to a covered part D drug described in para-
4 graph (8) or (9).

5 “(B) NET PRICE DEFINED.—In this para-
6 graph, the term ‘net price’ means, with respect
7 to a covered part D drug, the negotiated price
8 of the covered part D drug under the prescrip-
9 tion drug plan or MA–PD plan, net of any
10 manufacturer-provided price concessions (as de-
11 fined under section 423.100 of title 42, Code of
12 Federal Regulations (or any successor regula-
13 tion)), as reported for such drug in the Detailed
14 DIR Report (or any successor report) sub-
15 mitted by the sponsor or organization offering
16 the plan for the previous plan year.”.

17 (2) in subsection (c), by adding at the end the
18 following new paragraph:

19 “(7) REQUIREMENT THAT COINSURANCE FOR
20 COVERED PART D DRUGS BE BASED ON THE NET
21 PRICE OF THE DRUG.—The coverage is provided in
22 accordance with subsection (b)(10).”.
