Mrs. MOODY introduced the following bill; which was read twice and referred to the Committee on Commerce, Science, and Transportation

A BILL

To amend title 49, United States Code, to require that commercial driver’s licenses be restricted to United States citizens, lawful permanent residents, and individuals authorized by U.S. Citizenship and Immigration Services to engage in employment in the United States that includes driving a commercial motor vehicle, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Safer Truckers Act
5 of 2025”.

1 **SEC. 2. ESTABLISHMENT OF RESIDENCY REQUIREMENTS**
2 **FOR CDLS.**

3 Section 31308(1) of title 49, United States Code, is
4 amended—

5 (1) in subparagraph (A), by striking “and” at
6 the end;

7 (2) in subparagraph (B), by adding “and” after
8 the semicolon at the end; and

9 (3) by adding at the end the following:

10 “(C) be a citizen or lawful permanent resi-
11 dent of the United States or authorized by U.S.
12 Citizenship and Immigration Services to engage
13 in employment in the United States that in-
14 cludes driving a commercial motor vehicle;”.

15 **SEC. 3. REPORTING REQUIREMENTS AND WITHHOLDING**
16 **OF AMOUNTS FOR NONCOMPLIANCE.**

17 Section 31311(a) of title 49, United States Code, is
18 amended by adding at the end the following:

19 “(26) The State may issue a commercial driv-
20 er’s license to an individual only if the individual is
21 a citizen or lawful permanent resident of the United
22 States or is authorized by U.S. Citizenship and Im-
23 migration Services to engage in employment in the
24 United States that includes driving a commercial
25 motor vehicle.

1 “(27) Not later than 180 days after the date of
2 enactment of this paragraph, and by December 31
3 of each year thereafter, the State shall submit to the
4 Secretary a report describing the policies and actions
5 of the State to uphold and enforce the English-lan-
6 guage proficiency requirements for drivers of com-
7 mercial motor vehicles, as described in section
8 391.11(b)(2) of title 49, Code of Federal Regula-
9 tions (or a successor regulation).”.
