A BILL

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Tribal Warrant Fair-
5 ness Act”.

1 **SEC. 2. AMENDMENTS.**

2 (a) U.S. MARSHALS SERVICE.—Section 566(e)(1) of
3 title 28, United States Code, is amended—

4 (1) in subparagraph (B), by inserting “includ-
5 ing Tribal fugitive matters (on the request of an In-
6 dian Tribe, as applicable),” after “matters,”; and

7 (2) in subparagraph (D), by inserting “Tribal,”
8 after “local,”.

9 (b) PRESIDENTIAL THREAT PROTECTION ACT OF
10 2000.—Section 6 of the Presidential Threat Protection
11 Act of 2000 (34 U.S.C. 41503) is amended—

12 (1) in subsection (a)—

13 (A) by inserting “and Indian Tribes” after
14 “components”; and

15 (B) by striking “and local” and inserting
16 “local, and Tribal”; and

17 (2) in subsection (c), by striking “Federal or
18 State law” and inserting “Federal, State, or Tribal
19 law”.

20 **SECTION 1. SHORT TITLE.**

21 *This Act may be cited as the “Tribal Warrant Fairness*
22 *Act”.*

23 **SEC. 2. DEFINITION.**

24 *In this Act, the term “Indian Tribe” means any In-*
25 *dian or Alaska Native tribe, band, nation, pueblo, village,*
26 *community, component band, or component reservation in-*

1 *dividually identified (including parenthetically) on the*
2 *most recent list published by the Secretary of the Interior*
3 *under section 104 of the Federally Recognized Indian Tribe*
4 *List Act of 1994 (25 U.S.C. 5131).*

5 **SEC. 3. AMENDMENTS.**

6 (a) *U.S. MARSHALS SERVICE.*—Section 566(e)(1) of
