Mr. HAWLEY introduced the following bill; which was read twice and referred to the Committee on Agriculture, Nutrition, and Forestry

A BILL

To provide appropriations to the Secretary of Agriculture to provide payments to agricultural producers, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Support Our Farmers
5 and Ranchers Act of 2025”.

6 **SEC. 2. PAYMENTS TO AGRICULTURAL PRODUCERS.**

7 (a) DEFINITIONS.—In this section:

8 (1) COVERED COMMODITY.—The term “covered
9 commodity” means a covered commodity (as defined
10 in section 1111 of the Agricultural Act of 2014 (7

1 U.S.C. 9011)) produced for harvest, haying, grazing,
2 silage, or other similar purposes.

3 (2) ELIGIBLE AGRICULTURAL PRODUCER.—The
4 term “eligible agricultural producer” means a person
5 that is a producer of, and has an invested interest
6 in input expenses for, a covered commodity, a spe-
7 cialty crop, livestock, or poultry.

8 (3) LIVESTOCK.—The term “livestock” means
9 livestock (as defined in section 780.120 of title 29,
10 Code of Federal Regulations (as in effect on the
11 date of enactment of this Act)) produced for meat
12 or milk.

13 (4) POULTRY.—The term “poultry” means
14 chickens, turkeys, ducks, geese, and other domestic
15 fowl—

16 (A) ordinarily raised or used on a farm;

17 and

18 (B) produced for meat or eggs.

19 (5) QUALIFYING TARIFF PROCEEDS.—The term
20 “qualifying tariff proceeds” means the revenues re-
21 ceived in the general fund of the Treasury that are
22 attributable to duties, including any supplemental
23 duties, imposed after January 20, 2025.

24 (6) SECRETARY.—The term “Secretary” means
25 the Secretary of Agriculture.

1 (7) SPECIALTY CROP.—The term “specialty
2 crop” means a specialty crop (as defined in section
3 3 of the Specialty Crops Competitiveness Act of
4 2004 (7 U.S.C. 1621 note; Public Law 108–465))
5 produced for food or medicinal purposes.

6 (b) PAYMENTS.—Not later than 90 days after the
7 date of enactment of this Act, the Secretary shall provide
8 1-time payments to eligible agricultural producers for nec-
9 essary expenses related to losses of revenue and quality
10 or production losses of covered commodities, specialty
11 crops, livestock, or poultry.

12 (c) ACTIVELY ENGAGED IN FARMING.—To be eligible
13 for a payment under this section, an eligible agricultural
14 producer shall be actively engaged in farming (within the
15 meaning of section 1001A of the Food Security Act of
16 1985 (7 U.S.C. 1308–1)).

17 (d) ADMINISTRATION.—The Secretary may—

18 (1) establish terms and conditions of payments
19 under this section; and

20 (2) implement this section in such manner as
21 the Secretary determines to be appropriate.

22 (e) APPROPRIATIONS.—There is authorized to be ap-
23 propriated, and there is appropriated, out of any quali-
24 fying tariff proceeds in the Treasury that are not other-
25 wise appropriated, \$20,000,000,000 for fiscal year 2026
