Ms. SLOTKIN introduced the following bill; which was read twice and referred to the Committee on Homeland Security and Governmental Affairs

A BILL

To prohibit the use of funds available to Representatives and Senators with respect to official expenses to purchase or lease a motor vehicle unless the motor vehicle is manufactured in the United States by unionized workers.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Make Congress Drive
5 Union Made Act”.

1 **SEC. 2. REPRESENTATIONAL ALLOWANCE FOR MEMBERS**
2 **OF HOUSE OF REPRESENTATIVES.**

3 (a) IN GENERAL.—Section 101 of the House of Rep-
4 resentatives Administrative Reform Technical Corrections
5 Act (2 U.S.C. 5341) is amended—

6 (1) by redesignating subsections (c), (d), and
7 (e) as subsections (d), (e), and (f), respectively; and

8 (2) by inserting after subsection (b) the fol-
9 lowing new subsection:

10 “(c) RESTRICTIONS ON MOTOR VEHICLES.—The
11 funds from the Members’ Representational Allowance may
12 not be used to purchase or lease a motor vehicle unless
13 the motor vehicle—

14 “(1) has a final assembly place (as such term
15 is defined in section 32304 of title 49, United States
16 Code) in the United States; and

17 “(2) is assembled by employees who are covered
18 by a collective bargaining agreement.”.

19 (b) EFFECTIVE DATE.—The amendments made by
20 this section shall take effect on October 1, 2026.

21 **SEC. 3. SENATORS’ OFFICIAL PERSONNEL AND OFFICE EX-**
22 **PENSE ACCOUNTS.**

23 Subsection (a) of the first section of Public Law 100–
24 137 (2 U.S.C. 6313) is amended by adding at the end
25 the following:

1 “(7) Effective on and after October 1, 2026, the
2 funds from the Senators’ Account may not be used to pur-
3 chase or lease a motor vehicle unless the motor vehicle—

4 “(A) has a final assembly place (as such term
5 is defined in section 32304 of title 49, United States
6 Code) in the United States; and

7 “(B) is assembled by employees who are cov-
8 ered by a collective bargaining agreement.”.
