Mr. HOEVEN (for himself and Mrs. GILLIBRAND) introduced the following bill;
which was read twice and referred to the Committee on Foreign Relations

A BILL

To amend the National Agricultural Research, Extension,
and Teaching Policy Act of 1977 to modify the BARD
Fund, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “United States-Israel
5 Agriculture Cooperation Improvement and Expansion
6 Act”.

7 **SEC. 2. FINDINGS.**

8 Congress finds that—

1 (1) the United States-Israel Binational Agricultural
2 Research and Development Fund (referred to
3 in this section as the “BARD Fund”)—

4 (A) was established in 1977; and

5 (B) is a competitive funding program that
6 supports collaborative agricultural research in
7 areas of mutual interest to the United States
8 and Israel;

9 (2) the primary mission of the BARD Fund is
10 to bring together United States and Israeli scientists
11 to jointly address key agricultural and food produc-
12 tion challenges that concern both countries;

13 (3) since its establishment, the BARD Fund
14 has approved more than 1,300 research projects,
15 with a total investment of \$315,000,000 that has
16 gained \$16 for every \$1 spent; and

17 (4) research funded by the BARD Fund has led
18 to new agricultural practices, commercial engage-
19 ments, patents, and breeding rights licenses, which
20 serve as a growth engine to the United States and
21 Israeli economies.

22 **SEC. 3. BARD FUND.**

23 Section 1458(e) of the National Agricultural Re-
24 search, Extension, and Teaching Policy Act of 1977 (7
25 U.S.C. 3291(e)) is amended—

1 (1) in paragraph (1), by striking “entered into”
 2 and inserting “as entered into in 1977”;

3 (2) in paragraph (2)—

4 (A) in subparagraph (A), by striking
 5 “and” at the end;

6 (B) in subparagraph (B), by striking the
 7 period at the end and inserting “; and”; and

8 (C) by adding at the end the following:

9 “(C) support mid-stage research to ad-
 10 vance cooperative agricultural research projects
 11 of mutual interest to the United States and
 12 Israel.”; and

13 (3) by adding at the end the following:

14 “(3) BARD FUND ACCELERATOR.—The BARD
 15 Fund shall establish an accelerator program that
 16 supports mid-stage research, as determined by the
 17 technology readiness level, in priority areas estab-
 18 lished by the BARD Fund, and—

19 “(A) fast-tracks cooperative research be-
 20 tween scientists participating in BARD Fund
 21 activities;

22 “(B) accelerates the successful develop-
 23 ment of agricultural research through resources
 24 and services developed or orchestrated by the
 25 BARD Fund;

1 “(C) provides management guidance, tech-
2 nical assistance, and consulting to scientists
3 participating in activities described in para-
4 graph (2); or

5 “(D) advances cooperative agricultural re-
6 search projects of mutual interest to the United
7 States and Israel.

8 “(4) AUTHORIZATION OF APPROPRIATIONS.—
9 There is authorized to be appropriated to the BARD
10 Fund to carry out activities under this subsection
11 \$8,000,000 for each of fiscal years 2027 through
12 2031.”.
