CONCURRENT RESOLUTION

1 *Resolved by the Senate (the House of Representatives*
2 *concurring),*

3 **SECTION 1. CONCURRENT RESOLUTION ON THE BUDGET**
4 **FOR FISCAL YEAR 2026.**

 13 **RAPE, MURDER, OR SEXUAL ABUSE OF A**
 14 **MINOR AFTER ILLEGALLY ENTERING THE**
 15 **UNITED STATES.**

16 The Chairman of the Committee on the Budget of
 17 the Senate may revise the allocations of a committee or
 18 committees, aggregates, and other appropriate levels in
 19 this resolution, and make adjustments to the pay-as-you-
 20 go ledger, for one or more bills or joint resolutions re-
 21 ported by the Committee on the Judiciary or the Com-
 22 mittee on Homeland Security and Governmental Affairs
 23 of the Senate, amendments or motions offered thereto, or
 24 conference reports submitted thereon relating to immigra-
 25 tion enforcement, which may include legislation funding

1 U.S. Immigration and Customs Enforcement personnel to
2 conduct apprehension, mandatory detention, and expe-
3 dited deportation of adult illegal aliens who have been con-
4 victed of rape, murder, or sexual abuse of a minor after
5 illegally entering the United States, by the amounts pro-
6 vided in such legislation for those purposes, provided that
7 such legislation would not increase the deficit over the pe-
8 riod of the total of fiscal years 2026 through 2035.

9 **TITLE IV—OTHER MATTERS**

10 **SEC. 4101. ENFORCEMENT FILING.**

11 (a) IN THE HOUSE OF REPRESENTATIVES.—In the
12 House of Representatives, if a concurrent resolution on
13 the budget for fiscal year 2026 is adopted without the ap-
14 pointment of a committee of conference on the disagreeing
15 votes of the two Houses with respect to this concurrent
16 resolution on the budget, for the purpose of enforcing the
17 Congressional Budget Act of 1974 (2 U.S.C. 621 et seq.)
18 and applicable rules and requirements set forth in the con-
19 current resolution on the budget, the allocations provided
20 for in this subsection shall apply in the House of Rep-
21 resentatives in the same manner as if such allocations
22 were in a joint explanatory statement accompanying a con-
23 ference report on the budget for fiscal year 2026. The
24 chair of the Committee on the Budget of the House of

1 Representatives shall submit a statement for publication
2 in the Congressional Record containing—

3 (1) for the Committee on Appropriations, com-
4 mittee allocations for fiscal year 2026 consistent
5 with title I for the purpose of enforcing section 302
6 of the Congressional Budget Act of 1974 (2 U.S.C.
7 633); and

8 (2) for all committees other than the Com-
9 mittee on Appropriations, committee allocations con-
10 sistent with title I for fiscal year 2026 and for the
11 period of fiscal years 2026 through 2035 for the
12 purpose of enforcing 302 of the Congressional Budg-
13 et Act of 1974 (2 U.S.C. 633).

14 (b) IN THE SENATE.—If this concurrent resolution
15 on the budget is agreed to by the Senate and House of
16 Representatives without the appointment of a committee
17 of conference on the disagreeing votes of the two Houses,
18 the Chairman of the Committee on the Budget of the Sen-
19 ate may submit a statement for publication in the Con-
20 gressional Record containing—

21 (1) for the Committee on Appropriations, com-
22 mittee allocations for fiscal year 2026 consistent
23 with the levels in title I for the purpose of enforcing
24 section 302 of the Congressional Budget Act of
25 1974 (2 U.S.C. 633); and

(2) for all committees other than the Committee on Appropriations, committee allocations for fiscal years 2026, 2026 through 2030, and 2026 through 2035 consistent with the levels in title I for the purpose of enforcing section 302 of the Congressional Budget Act of 1974 (2 U.S.C. 633).

SEC. 4102. BUDGETARY TREATMENT OF ADMINISTRATIVE EXPENSES.

(a) SENATE.—

(1) IN GENERAL.—In the Senate, notwithstanding section 302(a)(1) of the Congressional Budget Act of 1974 (2 U.S.C. 633(a)(1)), section 13301 of the Budget Enforcement Act of 1990 (2 U.S.C. 632 note), and section 2009a of title 39, United States Code, the report or the joint explanatory statement accompanying this concurrent resolution on the budget or the statement filed pursuant to section 4101(b), as applicable, shall include in an allocation under section 302(a) of the Congressional Budget Act of 1974 (2 U.S.C. 633(a)) to the Committee on Appropriations of the Senate of amounts for the discretionary administrative expenses of the Social Security Administration and the United States Postal Service.

(2) SPECIAL RULE.—In the Senate, for purposes of enforcing section 302(f) of the Congressional Budget Act of 1974 (2 U.S.C. 633(f)), estimates of the level of total new budget authority and total outlays provided by a measure shall include any discretionary amounts described in paragraph (1).

(b) HOUSE OF REPRESENTATIVES.—

(1) IN GENERAL.—In the House of Representatives, notwithstanding section 302(a)(1) of the Congressional Budget Act of 1974 (2 U.S.C. 633(a)(1)), section 13301 of the Budget Enforcement Act of 1990 (2 U.S.C. 632 note), and section 2009a of title 39, United States Code, the report or the joint explanatory statement accompanying this concurrent resolution on the budget or the statement filed pursuant to section 4101(a), as applicable, shall include in an allocation under section 302(a) of the Congressional Budget Act of 1974 (2 U.S.C. 633(a)) to the Committee on Appropriations of the House of Representatives of amounts for the discretionary administrative expenses of the Social Security Administration and the United States Postal Service.

(2) SPECIAL RULE.—In the House of Representatives, for purposes of enforcing section 302(f) of the Congressional Budget Act of 1974 (2 U.S.C.

633(f)), estimates of the level of total new budget authority and total outlays provided by a measure shall include any discretionary amounts described in paragraph (1).

SEC. 4103. APPLICATION AND EFFECT OF CHANGES IN ALLOCATIONS, AGGREGATES, AND OTHER BUDGETARY LEVELS.

(a) APPLICATION.—Any adjustments of allocations, aggregates, and other budgetary levels made pursuant to this concurrent resolution shall—

(1) apply while that measure is under consideration;

(2) take effect upon the enactment of that measure; and

(3) be published in the Congressional Record as soon as practicable.

(b) EFFECT OF CHANGED ALLOCATIONS, AGGREGATES, AND OTHER BUDGETARY LEVELS.—Revised allocations, aggregates, and other budgetary levels resulting from these adjustments shall be considered for the purposes of the Congressional Budget Act of 1974 (2 U.S.C. 621 et seq.) as the allocations, aggregates, and other budgetary levels contained in this concurrent resolution.

(c) BUDGET COMMITTEE DETERMINATIONS.—For purposes of this concurrent resolution, the levels of new

1 budget authority, outlays, direct spending, new entitle-
 2 ment authority, revenues, deficits, and surpluses for a fis-
 3 cal year or period of fiscal years shall be determined on
 4 the basis of estimates made by the chair of the Committee
 5 on the Budget of the applicable House of Congress.

6 (d) AGGREGATES, ALLOCATIONS AND APPLICA-
 7 TION.—In the House of Representatives, for purposes of
 8 this concurrent resolution and budget enforcement, the
 9 consideration of any bill or joint resolution, or amendment
 10 thereto or conference report thereon, for which the chair
 11 of the Committee on the Budget makes adjustments or
 12 revisions in the allocations, aggregates, and other budg-
 13 etary levels of this concurrent resolution shall not be sub-
 14 ject to the point of order set forth in clause 10 of rule
 15 XXI of the Rules of the House of Representatives.

16 **SEC. 4104. ADJUSTMENTS TO REFLECT CHANGES IN CON-**
 17 **CEPTS AND DEFINITIONS.**

18 (a) HOUSE OF REPRESENTATIVES.—In the House of
 19 Representatives, the chair of the Committee on the Budget
 20 may adjust the appropriate aggregates, allocations, and
 21 other budgetary levels in this concurrent resolution for any
 22 change in budgetary concepts and definitions consistent
 23 with section 251(b)(1) of the Balanced Budget and Emer-
 24 gency Deficit Control Act of 1985 (2 U.S.C. 901(b)(1)).

1 (b) SENATE.—In the Senate, upon the enactment of
2 a bill or joint resolution providing for a change in concepts
3 or definitions, the Chairman of the Committee on the
4 Budget of the Senate may make adjustments to the levels
5 and allocations in this concurrent resolution in accordance
6 with section 251(b) of the Balanced Budget and Emer-
7 gency Deficit Control Act of 1985 (2 U.S.C. 901(b)).

8 **SEC. 4105. ADJUSTMENT FOR CHANGES IN THE BASELINE.**

9 The chair of the Committee on the Budget of the
10 House of Representatives and the Chairman of the Com-
11 mittee on the Budget of the Senate may adjust the alloca-
12 tions, aggregates, and other appropriate budgetary levels
13 in this concurrent resolution to reflect changes resulting
14 from the Congressional Budget Office’s updates to its
15 baseline for fiscal years 2026 through 2035, including the
16 effects of legislation enacted before the date on which this
17 concurrent resolution is agreed to.

18 **SEC. 4106. EXERCISE OF RULEMAKING POWERS.**

19 Congress adopts the provisions of this title—

20 (1) as an exercise of the rulemaking power of
21 the Senate and the House of Representatives, re-
22 spectively, and as such they shall be considered as
23 part of the rules of each House or of that House to
24 which they specifically apply, and such rules shall

1 supersede other rules only to the extent that they
 2 are inconsistent with such other rules; and

3 (2) with full recognition of the constitutional
 4 right of either the Senate or the House of Rep-
 5 resentatives to change those rules (insofar as they
 6 relate to that House) at any time, in the same man-
 7 ner, and to the same extent as is the case of any
 8 other rule of the Senate or House of Representa-
 9 tives.

10 **SEC. 4107. EXTENSION OF ENFORCEMENT OF BUDGETARY**

11 **POINTS OF ORDER IN THE SENATE.**

12 Notwithstanding any provision of the Congressional
 13 Budget Act of 1974 (2 U.S.C. 621 et seq.), subsections
 14 (c)(2) and (d)(3) of section 904 of the Congressional
 15 Budget Act of 1974 (2 U.S.C. 621 note) shall remain per-
 16 manently in effect for purposes of Senate enforcement.

17 **SEC. 4108. EMERGENCY REQUIREMENTS IN THE HOUSE OF**

18 **REPRESENTATIVES.**

19 (a) IN GENERAL.—In the House of Representatives,
 20 if a bill, joint resolution, amendment, or conference report
 21 making appropriations for discretionary amounts contains
 22 a provision providing new budget authority and outlays,
 23 and a designation of such provision as an emergency re-
 24 quirement, the chair of the Committee on the Budget of
 25 the House of Representatives shall not count the budg-

1 etary effects of such provision for any purpose in the
 2 House of Representatives.

3 (b) APPLICATION.—

4 (1) EXCLUSION.—A proposal to strike a des-
 5 ignation under subsection (a) shall be excluded from
 6 an evaluation of budgetary effects for any purpose
 7 in the House of Representatives.

8 (2) AMENDMENT.—An amendment offered
 9 under subsection (a) that also proposes to reduce
 10 each amount appropriated or otherwise made avail-
 11 able by the pending measure that is not required to
 12 be appropriated or otherwise made available shall be
 13 in order at any point in the reading of the pending
 14 measure in the House of Representatives.

15 (c) DEFINITIONS.—For purposes of this section, the
 16 following definitions apply:

17 (1) EMERGENCY.—The term “emergency”
 18 means a situation that—

19 (A) requires new budget authority and out-
 20 lays (or new budget authority and the outlays
 21 flowing therefrom) for the prevention or mitiga-
 22 tion of, or response to, loss of life or property,
 23 or a threat to national security; and

24 (B) is unanticipated.

1 (2) UNANTICIPATED.—The term “unantici-
2 pated” means that the underlying situation is—

3 (A) sudden, which means quickly coming
4 into being or not building up over time;

5 (B) urgent, which means a pressing and
6 compelling need requiring immediate action;

7 (C) unforeseen, which means not predicted
8 or anticipated as an emerging need; and

9 (D) temporary, which means not of a per-
10 manent duration.
