CONCURRENT RESOLUTION

Setting forth the congressional budget for the United States Government for fiscal year 2026 and setting forth the appropriate budgetary levels for fiscal years 2027 through 2035.

 25 total of fiscal years 2026 through 2035.

1 **TITLE IV—OTHER MATTERS**

2 **SEC. 4101. ENFORCEMENT FILING.**

3 (a) IN THE HOUSE OF REPRESENTATIVES.—In the
 4 House of Representatives, if a concurrent resolution on
 5 the budget for fiscal year 2026 is adopted without the ap-
 6 pointment of a committee of conference on the disagreeing
 7 votes of the two Houses with respect to this concurrent
 8 resolution on the budget, for the purpose of enforcing the
 9 Congressional Budget Act of 1974 (2 U.S.C. 621 et seq.)
 10 and applicable rules and requirements set forth in the con-
 11 current resolution on the budget, the allocations provided
 12 for in this subsection shall apply in the House of Rep-
 13 resentatives in the same manner as if such allocations
 14 were in a joint explanatory statement accompanying a con-
 15 ference report on the budget for fiscal year 2026. The
 16 chair of the Committee on the Budget of the House of
 17 Representatives shall submit a statement for publication
 18 in the Congressional Record containing—

19 (1) for the Committee on Appropriations, com-
 20 mittee allocations for fiscal year 2026 consistent
 21 with title I for the purpose of enforcing section 302
 22 of the Congressional Budget Act of 1974 (2 U.S.C.
 23 633); and

24 (2) for all committees other than the Com-
 25 mittee on Appropriations, committee allocations con-

1 sistent with title I for fiscal year 2026 and for the
 2 period of fiscal years 2026 through 2035 for the
 3 purpose of enforcing 302 of the Congressional Budg-
 4 et Act of 1974 (2 U.S.C. 633).

5 (b) IN THE SENATE.—If this concurrent resolution
 6 on the budget is agreed to by the Senate and House of
 7 Representatives without the appointment of a committee
 8 of conference on the disagreeing votes of the two Houses,
 9 the Chairman of the Committee on the Budget of the Sen-
 10 ate may submit a statement for publication in the Con-
 11 gressional Record containing—

12 (1) for the Committee on Appropriations, com-
 13 mittee allocations for fiscal year 2026 consistent
 14 with the levels in title I for the purpose of enforcing
 15 section 302 of the Congressional Budget Act of
 16 1974 (2 U.S.C. 633); and

17 (2) for all committees other than the Com-
 18 mittee on Appropriations, committee allocations for
 19 fiscal years 2026, 2026 through 2030, and 2026
 20 through 2035 consistent with the levels in title I for
 21 the purpose of enforcing section 302 of the Congres-
 22 sional Budget Act of 1974 (2 U.S.C. 633).

23 **SEC. 4102. BUDGETARY TREATMENT OF ADMINISTRATIVE**
 24 **EXPENSES.**

25 (a) SENATE.—

1 (1) IN GENERAL.—In the Senate, notwith-
 2 standing section 302(a)(1) of the Congressional
 3 Budget Act of 1974 (2 U.S.C. 633(a)(1)), section
 4 13301 of the Budget Enforcement Act of 1990 (2
 5 U.S.C. 632 note), and section 2009a of title 39,
 6 United States Code, the report or the joint explana-
 7 tory statement accompanying this concurrent resolu-
 8 tion on the budget or the statement filed pursuant
 9 to section 4101(b), as applicable, shall include in an
 10 allocation under section 302(a) of the Congressional
 11 Budget Act of 1974 (2 U.S.C. 633(a)) to the Com-
 12 mittee on Appropriations of the Senate of amounts
 13 for the discretionary administrative expenses of the
 14 Social Security Administration and the United
 15 States Postal Service.

16 (2) SPECIAL RULE.—In the Senate, for pur-
 17 poses of enforcing section 302(f) of the Congres-
 18 sional Budget Act of 1974 (2 U.S.C. 633(f)), esti-
 19 mates of the level of total new budget authority and
 20 total outlays provided by a measure shall include any
 21 discretionary amounts described in paragraph (1).

22 (b) HOUSE OF REPRESENTATIVES.—

23 (1) IN GENERAL.—In the House of Representa-
 24 tives, notwithstanding section 302(a)(1) of the Con-
 25 gressional Budget Act of 1974 (2 U.S.C. 633(a)(1)),

1 section 13301 of the Budget Enforcement Act of
 2 1990 (2 U.S.C. 632 note), and section 2009a of title
 3 39, United States Code, the report or the joint ex-
 4 planatory statement accompanying this concurrent
 5 resolution on the budget or the statement filed pur-
 6 suant to section 4101(a), as applicable, shall include
 7 in an allocation under section 302(a) of the Congres-
 8 sional Budget Act of 1974 (2 U.S.C. 633(a)) to the
 9 Committee on Appropriations of the House of Rep-
 10 resentatives of amounts for the discretionary admin-
 11 istrative expenses of the Social Security Administra-
 12 tion and the United States Postal Service.

13 (2) SPECIAL RULE.—In the House of Rep-
 14 resentatives, for purposes of enforcing section 302(f)
 15 of the Congressional Budget Act of 1974 (2 U.S.C.
 16 633(f)), estimates of the level of total new budget
 17 authority and total outlays provided by a measure
 18 shall include any discretionary amounts described in
 19 paragraph (1).

20 **SEC. 4103. APPLICATION AND EFFECT OF CHANGES IN AL-**
 21 **LOCATIONS, AGGREGATES, AND OTHER**
 22 **BUDGETARY LEVELS.**

23 (a) APPLICATION.—Any adjustments of allocations,
 24 aggregates, and other budgetary levels made pursuant to
 25 this concurrent resolution shall—

1 (1) apply while that measure is under consider-
2 ation;

3 (2) take effect upon the enactment of that
4 measure; and

5 (3) be published in the Congressional Record as
6 soon as practicable.

7 (b) EFFECT OF CHANGED ALLOCATIONS, AGGRE-
8 GATES, AND OTHER BUDGETARY LEVELS.—Revised allo-
9 cations, aggregates, and other budgetary levels resulting
10 from these adjustments shall be considered for the pur-
11 poses of the Congressional Budget Act of 1974 (2 U.S.C.
12 621 et seq.) as the allocations, aggregates, and other
13 budgetary levels contained in this concurrent resolution.

14 (c) BUDGET COMMITTEE DETERMINATIONS.—For
15 purposes of this concurrent resolution, the levels of new
16 budget authority, outlays, direct spending, new entitle-
17 ment authority, revenues, deficits, and surpluses for a fis-
18 cal year or period of fiscal years shall be determined on
19 the basis of estimates made by the chair of the Committee
20 on the Budget of the applicable House of Congress.

21 (d) AGGREGATES, ALLOCATIONS AND APPLICA-
22 TION.—In the House of Representatives, for purposes of
23 this concurrent resolution and budget enforcement, the
24 consideration of any bill or joint resolution, or amendment
25 thereto or conference report thereon, for which the chair

1 of the Committee on the Budget makes adjustments or
 2 revisions in the allocations, aggregates, and other budg-
 3 etary levels of this concurrent resolution shall not be sub-
 4 ject to the point of order set forth in clause 10 of rule
 5 XXI of the Rules of the House of Representatives.

6 **SEC. 4104. ADJUSTMENTS TO REFLECT CHANGES IN CON-**
 7 **CEPTS AND DEFINITIONS.**

8 (a) HOUSE OF REPRESENTATIVES.—In the House of
 9 Representatives, the chair of the Committee on the Budget
 10 may adjust the appropriate aggregates, allocations, and
 11 other budgetary levels in this concurrent resolution for any
 12 change in budgetary concepts and definitions consistent
 13 with section 251(b)(1) of the Balanced Budget and Emer-
 14 gency Deficit Control Act of 1985 (2 U.S.C. 901(b)(1)).

15 (b) SENATE.—In the Senate, upon the enactment of
 16 a bill or joint resolution providing for a change in concepts
 17 or definitions, the Chairman of the Committee on the
 18 Budget of the Senate may make adjustments to the levels
 19 and allocations in this concurrent resolution in accordance
 20 with section 251(b) of the Balanced Budget and Emer-
 21 gency Deficit Control Act of 1985 (2 U.S.C. 901(b)).

22 **SEC. 4105. ADJUSTMENT FOR CHANGES IN THE BASELINE.**

23 The chair of the Committee on the Budget of the
 24 House of Representatives and the Chairman of the Com-
 25 mittee on the Budget of the Senate may adjust the alloca-

1 tions, aggregates, and other appropriate budgetary levels
2 in this concurrent resolution to reflect changes resulting
3 from the Congressional Budget Office's updates to its
4 baseline for fiscal years 2026 through 2035, including the
5 effects of legislation enacted before the date on which this
6 concurrent resolution is agreed to.

7 **SEC. 4106. EXERCISE OF RULEMAKING POWERS.**

8 Congress adopts the provisions of this title—

9 (1) as an exercise of the rulemaking power of
10 the Senate and the House of Representatives, re-
11 spectively, and as such they shall be considered as
12 part of the rules of each House or of that House to
13 which they specifically apply, and such rules shall
14 supersede other rules only to the extent that they
15 are inconsistent with such other rules; and

16 (2) with full recognition of the constitutional
17 right of either the Senate or the House of Rep-
18 resentatives to change those rules (insofar as they
19 relate to that House) at any time, in the same man-
20 ner, and to the same extent as is the case of any
21 other rule of the Senate or House of Representa-
22 tives.

1 **SEC. 4107. EXTENSION OF ENFORCEMENT OF BUDGETARY**
 2 **POINTS OF ORDER IN THE SENATE.**

3 Notwithstanding any provision of the Congressional
 4 Budget Act of 1974 (2 U.S.C. 621 et seq.), subsections
 5 (c)(2) and (d)(3) of section 904 of the Congressional
 6 Budget Act of 1974 (2 U.S.C. 621 note) shall remain per-
 7 manently in effect for purposes of Senate enforcement.

8 **SEC. 4108. EMERGENCY REQUIREMENTS IN THE HOUSE OF**
 9 **REPRESENTATIVES.**

10 (a) IN GENERAL.—In the House of Representatives,
 11 if a bill, joint resolution, amendment, or conference report
 12 making appropriations for discretionary amounts contains
 13 a provision providing new budget authority and outlays,
 14 and a designation of such provision as an emergency re-
 15 quirement, the chair of the Committee on the Budget of
 16 the House of Representatives shall not count the budg-
 17 etary effects of such provision for any purpose in the
 18 House of Representatives.

19 (b) APPLICATION.—

20 (1) EXCLUSION.—A proposal to strike a des-
 21 ignation under subsection (a) shall be excluded from
 22 an evaluation of budgetary effects for any purpose
 23 in the House of Representatives.

24 (2) AMENDMENT.—An amendment offered
 25 under subsection (a) that also proposes to reduce
 26 each amount appropriated or otherwise made avail-

1 able by the pending measure that is not required to
2 be appropriated or otherwise made available shall be
3 in order at any point in the reading of the pending
4 measure in the House of Representatives.

5 (c) DEFINITIONS.—For purposes of this section, the
6 following definitions apply:

7 (1) EMERGENCY.—The term “emergency”
8 means a situation that—

9 (A) requires new budget authority and out-
10 lays (or new budget authority and the outlays
11 flowing therefrom) for the prevention or mitiga-
12 tion of, or response to, loss of life or property,
13 or a threat to national security; and

14 (B) is unanticipated.

15 (2) UNANTICIPATED.—The term “unantici-
16 pated” means that the underlying situation is—

17 (A) sudden, which means quickly coming
18 into being or not building up over time;

19 (B) urgent, which means a pressing and
20 compelling need requiring immediate action;

21 (C) unforeseen, which means not predicted
22 or anticipated as an emerging need; and

23 (D) temporary, which means not of a per-
24 manent duration.
